

# Tax Increment District

The council was told that request has been made to adopt two resolutions. The first resolution requests scheduling a Public Hearing involving the proposed modifications to the Development Program for Development District # 1. The second resolution also requests a Public Hearing to be scheduled regarding adopting policies and criteria for awarding business subsidies. Tax Increment Financing was explained along with a brief history. A Tax District is established to encourage development that other-wise may not have occurred. The schedule of event for establishing a district was reviewed. The city would be required to adopt a Business Subsidies Policy if the Tax Increment District were approved. Question was asked regarding captured funds and taxes. A separate fund would be necessary to be set up for those funds. Motion was made and carried with all ayes adopting the resolution calling for a Public Hearing on the proposed modification of the Development Program for Development District Number # 1 and the proposed establishment of Tax Increment Financing Districts # 1 - 8 and the adoption of the Tax Increment Financing Plan. Motion was made and carried with all ayes adopting resolution calling for a Public Hearing on the proposed adoption of policies and criteria for awarding business subsidies

# Municipal Utility Interceptor Project

Metropolitan Council representative gave the city an update on the interceptor project. The administrator and engineer presented some background information and reviewed the wastewater treatment plant capacity remaining. Question was asked regarding the schedule for the interceptor completion. The costs associated with the interceptor being put in the county road right-of-way compared to construction in the railroad bed. County Road # 40 would not be required to be closed as long, however, the statement passed along was that it could a year or more for the acquisition of the railroad right-of-way. The city could not use condemnation until the rail road line is officially closed.

# Flooding

The council is keeping a watchful eye on the predictions, reports and data. A citizen inquired about flooding and volunteering to help. The mayor stated that plans are being drafted, gathering information is occurring and people will be welcomed to volunteer. Residents should watch the city's newsletter and their website. (Even betcha' you can monitor 'Carver Current' too for updates ) For those without computer access, you could call the city hall for information too.

# Latest Flooding Update

The city council has made the decision to raise the levee in the city a minimum of three feet prior to potential flooding this spring. The city passed a resolution declaring a State of Emergency. It was the council's opinion that the spring flooding event has impacted or expected to impact the population causing significant amounts of property damage. The City of Carver Emergency Management Director requested the declaration. The 'State of Emergency' will remain in effect until May 31st unless extended by the council. Earthen clay will be used on the levee. The additional clay would not compromise the integrity of the existing levee the city engineer told the council. This levee is the city's primary protection system but cannot ensure that it will prevent flooding.

# Minnesota River Log Jam

You have heard all the buzz about the logs in Carver Minnesota on the Minnesota River and the upcoming spring thaw. Following this saga via the internet, the rumble is that the logs have been removed. There has been all kinds of activities, talk, discussions and speculations.

#### The official word is:

"The log jam has been removed from the Minnesota River. The remaining logs will float downstream as the ice melts." Question asked repeatedly was why the logs weren't removed from the river. The answer to this questions is that the city was not allowed to remove the logs due to restrictions from the Minnesota DNR.



# Minnesota River Bridge

The city attorney relayed to the council that the Union Pacific Rail road spoke with him regarding the MN River Bridge. The railroad relayed that if the SHPO had acted in a more time effective manner in its review the bridge would have been removed in the fall of 2010 It is now the intention of the Union Pacific Railroad to remove the bridge in 2011 having already conducted some preliminary investigation into removal of the logs and flotsam prior to the spring 2011 flooding season. The city administrator reported to the council that there had been a recent flood control meeting and the log jam was still serious. He further stated that there are liability issues and possible damage to the levee. The city attorney relayed that contact has been made regarding the log jam issue. It was pointed out speculations are being made that the 1965 flood level could be exceeded. 'The ground saturation is at 90-95%.

The council discussed and reviewed the log jam at the MN River Bridge with the city engineer. The engineer responded to the request for his opinion on the impact of the log jam on flood elevations upstream of the railroad bridge. Based on the information provided in a September 2008 drafted report prepared for Scott County. This report discusses indications of a log-jam extending the entire length of the railroad bridge adjacent to Carver's levee and only results in a minimal increase in the existing flood elevation of the river. This is because the log jam floats on the water surface, only blocking a portion of the conveyance at the railroad bridge. This increased flood elevation resulting from the log jam blocking the railroad bridge is not significant enough to increase the flood risk to Carver. However, there are erosion concerns in that the existing log jam is potentially increasing flow velocities at the bridge causing erosion of the city levee. The 2008 report includeed an analysis of river scour at this bridge as a result of a log jam for the ten year, fifty year and one hundred year flood recurrence intervals. The report shows a significant increase in total depth of the scour for all three recurrence intervals when the log jam is present versus when no log jam exists. The analysis shows that the location of scour extends along the entire length of the bridge including against Carver's levee. It is the engineer's opinion that the presence of a log jam at the bridge creates an additional risk of levee failure at this location. It is the engineer's recommendation that in order to minimize this erosion risk, the log jam must be removed prior to the Mn River spring flood season.

The engineer stated that the city has been working with the Union Pacific railroad on a solution to the problem of the log jam. Question was asked if the Union Pacific would be removing the logs from the river prior to the spring thaw. The city attorney relayed discussion he has had with the Union Pacific personnel regarding the removal of logs. The Union Pacific personnel stated that they would bring in a crane to remove logs before the spring thaw. The administrator would continue communicating with the railroad. The attorney would continue updating the council. The mayor has also talked with the commissioner to assist in helping to ensure the railroad removes the logs.

# Employee Reference Manual

The administrator informed the council that the last amended Employee Personnel Policy was in 1997. Updates were necessary due to changes in the employment laws, inconsistent and omission of policy language relevant to present employee / employer issues. Motion was made and carried with all ayes adopting the resolution approving the Employee Reference Manual.

# Moratorium Ordinance

The council reviewed the issue of adopting a Moratorium Ordinance involving Pawn Shops and related businesses. The city attorney pointed out that the city does not have land use regulations regulating pawnbrokers, pawn shops, consignment sales stores, auction establishments and firearm retail outlets. Concern regarding appropriate locations within the city for the studies uses was expressed. The council adopting an Interim Zoning Ordinance most commonly referred to as a moratorium would allow reasonable time to evaluate the studies uses. If an interim zoning ordinance were adopted, the city planner would be directed to prepare the report analyzing the studied uses. These uses would involve the proximity, appropriateness, parking regulations, traffic generation, determination of whether or not the intended business could be permitted or allowed by a Conditional Use Permit, and appropriate conditions and/or performance standards. The city has budgetary line item for revisions to official controls such as zoning and subdivision ordinances. The city is required to revise its official controls after adoption of the Comprehensive Plan. The city planner presently is in the process of the preparation of the official control revisions. Motion was made and carried with all ayes adopting the interim land use controls. The council and the staff discussed consignment sales. It was a council member's opinion that the ordinance was a prudent decision.

#### Water Tower

The engineer reminded the council that the water tower on Mt Hope Road was constructed in 1987. Generally water towers require painting every fifteen to twenty years. However the water tower has not been painted since construction. This painting has been delayed for two years. Interior and exterior paint is needed. One comment made regarding the color was that it be the same as the new tower. This issue will be discussed further.

The council reviewed and discussed the issue of the water tower requiring painting inside and outside. The last inspection was in 2009. KLM Engineering recommended removal and replacement of both the interior and exterior coating in one or two years. There are also some structural repairs recommended bringing the tank into compliance with OSHA regulations and American Water Works Association Standards and also allow for safer access to the tank. This type of work overall takes approximately five weeks. There are also existing antennas on the tank. These would be required to be removed temporarily. This process requires bids. Motion was made and carried with all ayes authorizing the engineeer to prepare plans and specifications to repaint the existing water tower and go out for bids.

Main Street Bridge
The engineer pointed out to the council that a permit package had been submitted to the Army Corp of Engineers relating to replacement of the bridge on Main Street in December of 2010. Work being done in Spring Creek triggered the Corp of Engineer's involvement and federal requirements relating to historic structures. Suggestion has been submitted to put flood walls on the bridge.

Fourth Street Bridge
The engineer also updated the council on the 4th Street Bridge project. The wingwalls and slopes over the past few years has been deteriorating. The city has been tracking the changes in the conditions of the bridge.

Traditions Restaurant at Dahlgreen Golf Course is getting ready to celebrate their Grand Opening Anniversary on March 12th. There is a swinging country band scheduled from 2:30 PM to 5:30 PM. # Mills Fleet Farm Property

The council discussed the naming of the backage road at the Mills Fleet Farm property project. Two council members will be researching historical names for the property.

The city attorney relayed to the council that another aspect of the Mills project involves the negotiating agreements with owners of three properties for site improvement agreements. Councilmember inquired about bonding covering the city's share of street and utility improvements once the agreement is signed. The attorney stated that there was more to project before bonding would be considered. Motion was made and carried with all ayes adopting the resolution approving entry into and execution of site improvement agreements with the property owners.

### Mills Fleet Farm

" A Mills Fleet Farm is moving closer to becoming a reality in Carver!" The mayor has stated. The council entered into agreements to facilitate the construction of street and utility improvements providing access to the store. The mayor has also stated that construction is scheduled to begin on the road this spring. A public hearing is scheduled to create a tax increment district that would assist the ability for the store to move forward with the project.

# Freeway Commercial District

A continued Public Hearing was held regarding the Feasibility Study/Freeway Commercial District. The city council and the staff had reviewed the feasibility report at the council work session. The report reviewed construction of street and utility improvement serving the new Mills Fleet Farm store and adjacent properties on the future backage road west of County Roads #61 and 11. This project would be funded through assessments, water and sewer funds and negotiated joint powers agreement with Carver County. Streetscape issues associated with the project are being reviewed by the Feasibility Task Force Committee. Motion was made and carried with all ayes adopting the resolution ordering improvement and preparation of plans for the Freeway Commercial District Utility and Street Improvements.

The engineer reviewed with the council the process the city has utilized for updating the base maps reflecting new utilities installed in recent developments and projects. Utility maps have progressed from hard copy mylars that were updated by hand to electronic means called AutoCad and GIS basemaps. Approximately six years ago the city updated the electronic basemap system to include basic utility information such as pipe size, material, elevations, etc. and the links to record plans. There is a fee collected for this basemap updating. There are two options for updating the basemaps. Motion was made and carried with all ayes directing the city engineer to update the utility basemaps to the web base application and prepare the utility and MS 4 modules at the estimated cost.

#### District # 112

Eastern Carver4 County Schools (District #112) will begin the 2011 - 2012 budget development process with the assumption that state aid will not increase in the coming biennium. The School Board is asking for four budget scenarios be developed to estimate the impact of possible state funding action ranging from no increase in aid to a reduction of 1.5 %, 3 % and 5 %.

If legislators were to keep state aid at the current level, the District will need to reduce the budget due to projected increases in costs such as insurance, energy and personnel. If legislators were to cut aid varying amounts are necessary to reduce the budget.

The budget process begins with a committee of staff and parents from each school creating a list of possible reductions in expenditures or increases in revenue. That list will be forwarded to a budget committee comprising four district administrators and four principals. The budget committee will make the preliminary lists of cuts public when the list is completed in March.






