There was a period when we lived in town for many years.

With that said, it is only befitting that his presence be acknowledged at this time, the time of his passing with all of you who also shared in his life. There are many who did not know him either or knew of him only.

So here it goes. John William Schultz was born September 7th 1952 at St Francis Hospital to Willard and Merva Schultz. Merva was an Arlington raised young lady and became a part also of the Carver legacy. Willard on the other hand was from the area and has many, many connections with the Carver community. There were the Preiss', Riesgraf's and Lenzen's, even though some through marriage. I am not really well versed in the family tree ties, I know some connections and have forgot-ten important details. Moving forward, Willard and his brother Rudolph were local contractors and built several homes too in the city.

Dwight is John's brother and everyone knows Dwight. Paul Schultz who works for the city is John's nephew. Sorry fella's maybe some connections you didn't want public. Too late. We are all in this together. Sharon Eischens Krill is John's sister. She deserted the city and moved to Waconia and then Chanhassen. Annette, Kim and Richard were his children. Troy Galles is our Son-in-Law.

John also had alias', "Zee Zee" due to the school bus occupation, even though he drove for Shakopee schools. After forty years of driving school bus many, many youngsters knew him or of him. Then there was the alias 'Popeye' from his buddy "Milo" whom we also lost some time ago and this was, I believe, from the Mueller Gravel Pit days. So as you can see, his legacy goes way back. Recently with all the talk about the old school house in Carver, it continuously reminds me of past discussions with Jim Fletcher, Jim Pauly, Jim Hron, Joe and Marvin Plekkenpol attending that school, Now doesn't that date all of us?

Some of you may know him or remember his from his tractors in the parade representing the Scott Carver Threshers' Association in Jordan during SteamBoat Days? Definitely many of you recognize his name from the Christmas tractor decorations on former County Road # 40 that he loved taking credit for when in reality his daughters always saw to it that those were decorated for him. Sorry everyone, they are gone. Only a memory like he now is going to be. Many of you also saw him in Harvey's for breakfast on weekends.

What happened? He got sick and gave up. He had been struggling with bladder cancer. He suffers no more. Give him that peace. Forgive him for his failings as of late. He went through some very, very difficult times in the last two years. The illnesses took their toll. He went into the VA hospital in July. In August after receiving radiation he was admitted to the nursing home in Hopkins where he could no longer find the strength within to continue on. The suffering was more than his daughter's could bear. He found peace then and said goodbye to the world on August 25th, 2016.

He is survived by Ricki, Annette (Troy), Kim, and Richard (Traci) . Grandchildren are Tommy, Chelsea, Ethen and Lili and extended grandchildren Jacob and Destini. His brother, Dwight (Janet), sister, Sharon (Denny); nephews, Paul, John (Carolyn), Jim, Jeff (Wendy) ; and niece, Patty; Father and Mother In-law, Glen and Joycelyn. Last but not least, his buddy, 'our Bear'.

Staffing Plan

The administrator discussed background information with the council regarding the Staffing Plan which was intended to serve as a guide identifying future staffing requirements for the city. New positions will be required to be budgeted for and justified to the city upon implementation. Motion was made and carried with all ayes adopting the 2021 Staffing Plan presented for their review.

Field Lighting

The council reviewed prior discussions from their work session regarding the lighting on the new multiple use fields. The staff was directed to collect additional information from questions that arose. Surrounding community fields were researched for lighted versus non-lighted fields. Quotes received were reviewed.

The city engineering firm was requested to develop plans and specifications for lighted fields. An estimate of probable costs exceeds the amount which requires that the project be bid. To conduct the bid process creation of plans and specifications were required. A loan form one of the Enterprise Funds is the best candidate for funding the project, if the city chose this option. The loan could be paid with future park dedication fees as collected.

The need and the necessity were discussed. Currently there are not any fields in the community lit. The Parks Commission were interested in lighting of two fields with non-LED light. There was concern expressed by a council member concerning the costs for lighting that was not demonstrated as a necessity. Most of the fields discussed were relating to high school fields. Motion was made but failed to direct the engineer to prepare plans and specifications for field lighting.

Sixth Street Redevelopment

The council reviewed and discussed the Sixth Street Redevelopment items pertaining to the property the city purchased in 2015. The staff had been authorized along with the Planning Commission to prepare a 'Request for Proposals' to pursue redevelopment of the property. The Planning commission drafted guiding principles. Upon receipt of proposals a selection schedule is proposed to be put into place. One of the steps includes a 'development team' creation. Based on the schedule proposed, anticipation of selection of a developer could occur possibly in February of 2017, then formal development plans reviewed in spring with construction commencing in the summer. The council was considering approving requests for proposals.

The city planner reviewed with the council the prior information pertaining to the Sixth Street Property redevelopment. Based on the requests for proposals schedule of the site, statement was made that the selection of a developer could occur in early 2017 and formal plans reviewed in the spring and then construction could commence as early in the summer of the same year. Upon receipt of proposals financial impacts of the various proposals would then be prepared for consideration by both the Planning Commission and council members. Motion was made and carried with all ayes approving the Request for Proposals for redevelopment of Sixth Street Property.

General Balance Policy

The council reviewed the General Balance Policy information with the administrator. The proposed policy amendment maintains previously adopted minimum fund balance; creating a Special Capital Project Fund for any unassigned fund balances exceeding General Fund budgeted expenditures. The proposed amendment provides a buffer. The financial transfers and reasoning's were all reviewed. A presentation preceded the discussion for clarification purposes of the policy and examples visualizing management of surplus funds. Motion was made and carried with all ayes adopting the resolution amending the Fund Balance Policy, establishing a Special Capital project Fund and authorization of the designated fund amount transferred into the Special Capital Project Fund.

Then the administrator discussed budget changes proposed pertaining to the General Fund Budget Amendment. The changes proposed involved the community Space Visioning where professional service fees and related expenses for the process; the annexation appeal; the sidewalk and median extension project; and the insulation of the Church By the River. All of the costs related to these topics were reviewed. Motion was made and carried with all ayes adopting the resolution amending the 2016 General Fund Budget including the amount change for the church insulation item.

Property Donation Policy

The administrative intern provided background information regarding the new law in the state allowing local governments to donate surplus equipment to non-profit organizations. The meaning of 'surplus equipment' was discussed. Prior to donating the city will be required to identify and determine fair market value. Then the council may approve or disapprove eligibility. If approved, advertisement will be placed and then non-profit organizations will be required to submit a "Surplus Equipment Form". Approval to donate may be approved by the administrator or the council dependent upon value. All donations will be identified as "As Is" status. Shipping will be the responsibility of the organization. Then the approval depends upon the greater than / less than value of who approves the donation. Motion was made and carried with all ayes adopting the Surplus Equipment donation policy.

Law Enforcement Services

The administrative intern discussed the issue involving the agreement of law enforcement services for off duty contract. In order to have the sheriff's deputy coverage for Steamboat Days this year a current off duty contract with the Sheriff's Department is required. The fee was discussed and the expectations of the sheriff's office duties.

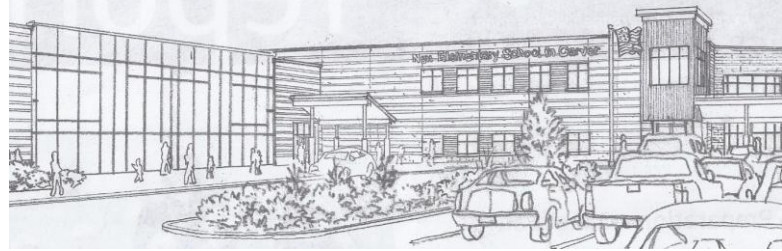
Park Name

The city planner discussed with the council the need to name the new park adjacent to the new Carver Elementary and the suggestion submitted was "ironwood Park".

Carver Elementary

The council also discussed the Carver Elementary plans regarding the Architectural Elevations with the City Planner. A condition of the approval of the site plans for the school regarding the building elevations had not been provided previously to the Planning Commission and the council for review and approval. Exterior colors also had not been selected. Material types were reviewed. Then the Planning Commission reviewed the elevations recommending approval.

Carver Elementary School



Eastern Carver County Schools School Report Newsletter discussed the building a premier school district and offered the following school facts:

" Carver Elementary School is buildt for 720 student capacity with the option of future expansion for up to 865 students; Two story building; thirty traditional classrooms designed around collaborative leasrning spaces; two full size gymnasiums, large cafeteria to accommodate future growth; shared sports field and walking paths with City of Carver; and the estimated total cost..."

Planning Assistance Grant

The city planner discussed with the council the availability of a planning assistance grant. The city is required to complete the ten year update of the city's Comprehensive Plan by December of 2018. The Metropolitan Council is providing non-competitive grant awards to qualifying local governments. The city is eligible to assist in defraing the costs of the update.

The grant is a two part program. Initial upfront payment and the second amount following completion of conditions such as completion by December of 2018; compliance with the metropolitan system and policy plans and the plan must be complete as described in the Metropolitan Council's Local Planning Handbook. This grant would pay for the cost of preparation of the Comprehensive Plan Update. A proposed scope of work and estimated buget for the update will be forthcoming to the council, Council would be request-ed to adopt the resolution authorizing the application. For the planning grant assistance funds.

Temporary Health Dwellings

The city planner discussed with the council the topic involving the temporary family health care dwellings involving the bill passed creating the new process for landowners to place mobile residential dwellings. The council reviewed the facts again. Unless the city chooses to adopt an ordinance "opting out" that is in place by the beginning of September qualifying applications required to be approved by the city. Clarifying that the city would need to be prepared with a permit in place and existing city regulations pertaining to the accessory uses under the zoning ordinance. Recreational vehicles do not apply to these applications. The type of housing permitted under the state statute can be reviewed at: www.nextdoorhousing.com. The topic pertaining to tiny houses is a separate but related issue. The new statute specifically related to tiny houses utilized for temporary health care.

The city's options are to allow these temporary dwellings which would require processing applications for temporary dwellings; or adopt an ordinance 'opting out'. There are two ways to handle the ordinance dealing with 'opting out' choice. The first situation involves no effect on the city's current regulations and the temporary dwellings would not be permitted. However if the opt out ordinance is not in effect by the deadline, then there is a gap during which the city would be required to permit the temporary dwelling if someone applied. The city could however at a later date adopt its own regulations regarding the type of dwellings. The second situation would be to opt out but also request the Planning Commission and the staff to research the topic. This option would be the choice the council would possibly be more interested in if there were to be consideration given to allowing the structures and establishing customized terms and conditions for permitting. The Planning Commission had reviewed the 'opt out' issue and held a Public Hearing recommending 'opt out' ordinance to the council.

Carver Community Service Awards

The administrative intern reviewed with the council the Carver Community Service Awards program. The purpose of the awards were to recognize the time, support, service and dedication of organizations and individuals who have given unselfishly to the City of Carver. It was the council's and staff's opinion that it is important to acknowledge the hard work of citizens who make a difference in the community. Three awards would be presented each year. They would include a youth, eighteen years and under; individual and a business or organization. Community service could include volunteering time, effort, expertise or other resources. Eligibility would include citizens, organizations and businesses within Carver. Nomination forms would be available at city hall or on the city's website. Nominations would be accepted until November 1st of each year and reviewed by the mayor and the staff. Winners would receive a plaque and be recognized in city publications for achievements.

Eastern Carver County Schools

The 2016 MEA usual school closures will not occur this year. The recommendation to the School Board was that the MEA break, "typically the Thursday and Friday of the third week in October, be eliminated." It was the committee's consensus that since the Ryder Cup break would be two and half weeks prior that the additional two days was not a good idea. So the school board made the decision that school will be in session this year. However, on the 20th of October, Thursday, a late start is scheduled.

Also this year on November 8th is voting for three seats on the Schools Board of Directors. Board members are elected for four year terms. The schools website will have information for the election.

Trinity Lutheran Church

The Trinity Lutheran Church parish invite members of the community to come and celebrate with their members their 150th Anniversary. They will be celebrating the year with special events. On September 25th the church is holding a special Anniversary Celebration Service at 1 PM. Everyone is invited to attend.

Eastern Carver County Schools will not be in session during the Ryder Cup event September 26th through the 30th. "The Ryder Cup is one of the largest international sports events.

The 2016 Ryder Cup host, Hazeltine National Golf Club, is located in the heart of Eastern Carver County Schools. Roads will be closed and there will be no school the week of Sept. 26. *Note: In the event that severe weather delays the final day of the Ryder Cup on Sunday, Oct. 2, school would need to be cancelled on Monday, Oct. 3, for make-up matches. Parents would be notified through the district's automated voice messaging system.* SouthWest Transit will also have service to the Ryder Cup. Information is on line at swtransit.org/ryder-cup.

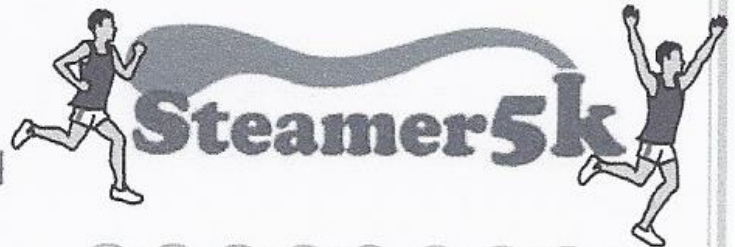

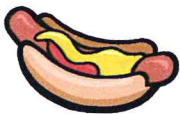
