City Council News!



Federal Disaster Relief

Frey asked the council at the August third meeting if they were interested in applying to receive Federal Disaster Relief for damages as a result of the storms in July. Sixth Street and Mt Hope Road incurred damage. Frey was to check into obtaining these funds.

Erosion had also occurred at the boat ramp site. Frey would haul in gravel and do necessary repairs.

Council was told on August 17th that relief had been applied for. An approximate \$ 18,000 work of damage had been evaluated due to storm damage. The city would receive ninety percent [90 %] of this amount in relief benefits.

Water Tower



Abbe and Svoda refused sub-contracting to put a fence around the water tower. Council discussed on August third that a new contract would have to be obtained with DEED and Bacon-Davis wage rates met if the city contracted work out with another firm. The HRA suggested that the city install the fence. Wage rates would not apply to city employees. Grant monies would pay wages for city employees, as well. Motion was made and carrired with all ayes to approve installation of the fence by Frey.

Building Permit

Lion's Club requested approval at the August third meeting for a building permit to construct a shelter at the Lion's Park. Planning Commission had approved plans and recommended approval. Motion was made and carried with all ayes approving the building permit request.

Fire Department

On August 3rd, fireman inquired about the council's action to deny payment for extra hours worked making major repairs on fire equipment Fee received on a monthly basis was considered for regular maintenance. The payment request was submittted for addition al hours for major repairs. Councilman Thuenning commented that the maintenance position was an elected position and other men also put in extra hours without compensation. The mayor stated that funds come out of the Fire Department budget, therefore should be approved by the Fire Department, then submitted to the council. Bill was to be resubmitted to the Fire Department.

Gillfilan Avenue

Frey asked the council on August 3rd to have the engineer [Maier Stewart] survey Gillfillan Avenue for suggestions to stop the washout on the road. Long term correction of the problem would be to pave, but property owners were not willing to be assessed for the costs. Engineer was to look at this area and in the meantime more fill would be hauled in.

Park Complex

Park and Recreation Board presented an up date on the new park site on August 3rd. Prints have been established to show proposed plans. The board is waiting for a topographical survey, so that they can go out for bids for excavation.

Giese told the council on August 17th that he had talked with several individuals and bids were received for the park complex.



Park and Recreation Board

The Park and Recreation Board requested on August third that more than three members be appointed to serve on their board. Council requested that a copy of the Ordinance be sent to the board and the council. The board and Councilman Wendland are to review this ordinance and return with proposed changes.

Ordinance concerning the number of members was discussed on August seventeenth. Five members on the board was the number the group reached. It was decided to have the new City Administrator check into changing this ordinance.



Request was presented on August 3rd from a businessman for 3.2 On and Off Sale and setup licenses for Sunday sales. Motion was made and carried with all ayes to grant Chip's Taverna Non-Intoxicating Malt Liquor On Sale & Off Sale license and a set-up license.

Disurance Coverage



B & D Catering spoke to the council on August 17th regarding the need for Product Liability insurance coverage for a business being operated out of the Village Hall. Regulations required were explained. The cost for the insurance was considered to be high. Lioness meeting cooking was brought up. Further contacts are to be made regarding insurance coverage costs. Attorney was also to be contacted for more answers and confirmations of questions. Another insurance company should be contacted for rates. Cooking for the Lion's Club was briefly discussed. Emotions were hot.

Several citizens were present at the August third meeting with questions for Maier Stewart regarding the municipal utilities projects.

One property owner inquired about water run off and landscaping changes that need to be made to correct the problem. Hydro would make appropriate corrections, but would have to be paid to do work on the sidewalk and the culvert.

Another resident expressed concern regarding increased water run off flooding a structure on his property. The council discussed water run off change of direction. Water that previously ran off into the creek was unable to follow past patterns. Maier Stewart, Hydro Engineering and Frey were to tour, find problem areas and return to the council with recommendations for corrections.

Hydro requested a time extension on the project. Ebeling [Maier Stewart] suggested holding off to act on this request. The mayor stated that because of implications, he would prefer not to act on an extension. The Post Office would be the only establishment affected by a delay.

There are still some problems with cells at the pond site. Shortly, it should be known if these cells will pass tests and can be utilized.

Owner of the Post Office made contracttual arrangements upon completion of the building. If sewer and water are not operational, he can not turn the structure over to the Federal Government. He will need to seek recourse, if he trouble with the investors. It was suggested that he try a temporary water hook up since the sewer can be used, and see if this would be an acceptable arrangement.

Hydro requested the use of seed versus sod in most areas. Hydro would keep the seed wet and after it is growing, they will keep it green for thirty days. If lawns are not green after thirty days, they will either reseed or sod if they feel necessary. The council agreed with this proposal.

Ebeling told the council that Abbe and Svoda would like partial payment for work done on the water tower with the city retaining \$ 5,000. Motion was made and carried with all ayes to make payment.

Water and Sewer Miscellaneous

Motions were made and carried with all ayes to make payments for requests submitted on August 3rd relating to the municipal projects.

Letter was to be drafted and forwarded by the city concerning a water connection.

Water main depths will be reviewed at the next meeting.

Motion was made and carried with all ayes to authorize the city clerk to purchase necessary supplies for implementing manual billing of water and sewer.

Clerk was directed to send letters to property owners regarding meter deposit with a request that these be paid by August twentieth.

Water and Sover Improvements



Craig Ebeling resigned from his position at Maier Stewart and Associates the council was told on August 17th. John Stewart will be handling issues for the city.

MPCA [Minnesota Pollution Control Agency] wants more data regarding pond sites before approval of the use of these ponds. A special meeting will be scheduled to approve resolution accepting the ponds.

Wayne Dauwalter inquired about the use of the water system. City needs written authorization from the PCA [Pollution Control Agency] or Maier Stewart that the city accepts the water system before it can be utilized. Motion was made and carried with all ayes allowing hook up to the water system after the State Health Department and Munitech approve the system. Frey is to call Munitech informing them to coordinate water hook ups.

Change order concerning acceptance of seed rather than sod was presented to the council for approval. the council wants to see a deduction for sod before considering approval of this change order.

Shallow water mains were discussed. Boettcher [Maier Stewart] stated that none of the water lines were a problem and were all deep enough. Frey was directed to talk with Hydro Engineering to see where their concerns were for shallow lines.

Pond site condemnation was discussed. The owner had appealed the judgement. The city cross appealed on the advise of the city attorney.

City Administrator

Mayor Meyers updated the council on August 3rd regarding the status of hiring a City Administrator. A meeting was scheduled to review applications.

On August 17th the mayor presented the final candidate for the position of the City Administrator. Councilman Hanson expressed concern regarding the process of interviewing applicants. The mayor explained the process utilized. Five candidates qualified for the requirements. The finalists were reviewed per a set of questions. The committee agreed that Ms. Norris was the best qualified for the position. Motion was made and carried with all ayes approving the resolution to enter the candidate into the joint powers employment agreement.

Length of the contract was discussed. Salary and evaluations were talked about. Ms. Norris would tentatively begin employment September sixteenth. Consensus of the council was to revise contract agreement with a quarterly review and vacation time established. Motion was made and carried with all ayes approving the revised agreement.




