Discussion was held regarding the upcoming Halloween party. There would be costume contests, games and a prize raffle for the younger 'munchkins'. Older adolescents would participate with a carnival theme.

SteamBoat Days finances were briefly discussed. The 1988 Committee has already been started.

The club was looking ahead to their December Christmas party. Scheduling dates were discussed.

The '26 Club' was talked about. Further discussions and planning would be necessary.

Past dues were talked about.

Decision was made to have the Lion's Club determine if a single or joint meetings would be held for the visit of the Deputy District Governor.

Memorial donation would be given to the family of Denton Anderson.

Lioness received a thank you letter from the City of Carver Council for the Christmas decorations donation.

Wayne Neubarth commented that he was impressed with the club. They were busy and doing well. They had out done many Lion's Club and he was happy to see their participation.


Reminder was given that the next zone meeting will be November 23rd and also, the mid-winter convention to be held in Mankato.

Next meeting is scheduled for the Lioness on November 9th with the Board Meeting at 6:15 PM and the General Meeting at 7:00 PM.



Contract for patrolling services with the Carver County Sheriff's Department was discussed at the September 23rd meeting. The council discussed whether or not to renew the contract for 1988. Mayor Meyers had attended a meeting with the Sheriff's Department and that the actual cost for patrolling in 1987 would cost the city an additional amount for 1988. Since Councilman Briggs did not favor giving a blank check to the Sheriff's Department, he asked what the advantage was of having the one hour per day patrolling service. Councilman Hanson reminded that there is not an additional cost for services provided during SteamBoat Days. Further discussion held resulted in the consensus that the city was to renew the contract for one hour per day for 1988.

Sheriff Wallin was present at the October fifth meeting to answer any questions about the '88 Police Contract. The mayor commented on his observation of dissatisfaction with the contract system. Motion was made and carried with four ayes and one nay approving the '88 Police Contract.



1988 Budget Decisions

Motion was made and then amended on September 23rd to create a special fund, using any money left for Administration's Capital Outlay. This to be set aside each year beginning in 1988. This amended motion carried with all ayes.

Motion was made and carried with all ayes to create a fund for money not spent in the Fire Department's 'Building Repair and Maintenance' beginning with the 1988 budget.

Previously two thousand dollars per year was set aside in the Fire Department's Capital Improvement Fund to defray costs for purchase of large fire equipment. Motion was made and carried with all ayes increasing that amount by one thousand dollars.

Motions were made and carried with all ayes to create funds for the balance not used in Street Major Public Works and Park Developments funds, and also to create funds for Sewer Repair and Water Repair Capital Funds.

On October 5th, the council discussed budget changes. Mayor Meyers proposed changing contingency funds from five percent to three percent and adding five hundred dollars to the Village Hall and Fire Department budgets for sewer and water utility bills.

Motion was made and carried with all ayes approving the 1988 budget per additional proposals. Motion was made and carried with all ayes approving the Resolution adopting the 1988 levy for the city.

Frey met with NSP. He told the council on October 5th that six additional street lights should be put up. Costs would be nine dollars and sixty cents per month for overhead lights and thirteen twenty per month for one underground light without any cost for installation. These lights would be placed at the end of Fourth Street by Gilfillan Avenue, Skyview Lane, Lime Street, Meadow Bluff and boat ramp. Motion was made and carried with all ayes approving placement of these lights.

Placement of lights on Mt Hope Road were asked about. NSP said installation in this area would not be free. City Administrator was directed to obtain costs and report back with the information.

Road Repairs

Frey presented to the council on October 5th quotes for work that should be done on a bridge on Main Street. He obtained costs for laying a blacktop mat on County Road # 40, instead of red rock. Motion was made, but defeated to do any bridge work, until more information about the work could be received.



Building Permit

Siegle appeared before the council on October fifth requesting permit to move a modular home onto a core city lot. Home and lot met zoning ordinance requirements Council could not approve the request without finding out if such an approval would affect the grant. A more detailed site plan would have to be presented.

Building request with site plan was presented to the council for a garage. Variations in size were discussed. New plans would be resubmitted to the Planning Commission.

Planning Commission held a meeting to consider request for construction of a garage Modifications to plans were made. Planning Commission recommended approval of the request. Motion was made and carried with all ayes approving building permit for the garage.

Vehicle Storage




City received complain of vehicle storage on private propert at the October 5th meeting. Property owner discussed status of those vehicles with the council. Requestion was made to enforce the ordinance regarding abondoned vehicles. City Administrator was directed to discuss settlement of this problem.



Disurance Coverage

On October fifth, City Administrator discussed the policy issue of insurance coverage for catering service. It was his opinion that they could either be or not be required to have insurance. Councilman Briggs felt that the city should adhere to the policy established. Administrator said that the city should have coverage for themselves. City Administrator was directed to draft a letter to catering service with copies to the city attorney.



Councilman Thuenning asked the City Administrator on October fifth about continuation of the Joint Powers Agreement after the first of the year. Adminstrator thought that the matter was settled and that he would be solely employed by the City of Young America full-time at the end of the year. Mayor Meyers was to attend the Young American council meeting to discuss the issue further.

On October 12th, the council was notified that a letter had been received from the City of Young America to discontinue the Joint Powers Agreement for city administrator services.

Motion was made and carried with all ayes directing the Administrator to advertise for a part-time City Administrator for the City of Carver. Discussion was held. The mayor commented that he was upset with the decision by the City of Young America. Ads were to be placed in the Carver County Herald, St Paul Pioneer Press, Minneapolis Star and Tribune and the Courrier Spokesman.

Water and Sewer Improvements

Citizen asked at the October fifth meeting if the sewer and water projects were complete. Response was that the municipal utility projects were not complete.

Representative from Munitech told the council that rocks in the water system are a problem for the Fire Department. Flushing all of these out of the system would be difficult and expensive. Suggestions was made that screens be put on the hydrants. Frey was to check about getting screens.

Munitech representative suggested that wiring in the main lift station be checked and a back up system possibly be installed. An inventory of parts on hand is needed. Specific start-up timetable is also needed.

council concluded that a meeting with Hydro Engineering, Maier Stewart, Munitech and the city to discuss problems that have arisen from the municipal utilities projects was necessary. Meeting was scheduled for October twelfth.

Motion was made and carried approving Resolution to accept Wastewater Pond # 1 as complying with specifications.

Quotes have been received for trees for the water tower site at sixty dollars each. Frey told the council of an auction where trees may be gotten at a reduced cost. Motion was made and carried with all ayes authorizing the City Administrator and Frey to attend auction to purchase trees.

On October 12th, Mayor told participants of the meeting that the Boy Scouts had planted trees at the water tower site.

Representatives from Maier Stewart, Hydro Engineering, Munitech, Carver Fire Department and the City of Carver were all present to discuss the utilities projects at the October twelfth meeting.

Sewer project costs were discussed. Stewart stated that a true picture of final costs could not be given at present, since quantities have not been determined. Suggestion was made that respective firms should meet to discuss this topic.

Councilman Briggs stated that Ebeling has assured the council that change orders the MPCA had rejected were grant eligible. Regarding the septic tank change order, the council approved, contingent on being grant eligible. Mayor Meyers stated that many decisions were made after advice from the engineers.

Stewart thought completion could be in two weeks. Thus, issues should be discussed then, when a more complete picture could be given on the project.

Rocks in the water lines were discussed. Fire Department asked about removal. Munitech said flushing would not cure the entire problem and that screens should be put on hydrants. Firemen expressed concern that this would affect the flow rates.

Councilman Briggs asked about the responsibility of the system meeting specifications. Stewartresponded that contractors were responsible until acceptance by they city. Hydro Engineering had given verbal permission to the Fire Department to use the system.

Munitech inquired about the use of rocks for bedding in the system. It was thought that if areas could be isolated, flushing could be done more efficiently. Agreement was reached to attempt to flush the lines once more.

Mayor stated the need for electrical drawings of the lift station and the treatment plant. These were available upon request.

Munitech wishes to go through the start-up of equipment with the engineers and would like a date set. Hydro had already done this, but the city did not have an operator. They did not think that they should have to do it again. Munitech would go through the specifications. What was not clear, they would ake the original manufacturers.

Since shutdown of the fire hydrants too fast could cause problems in the pressure reducing valves, Stewart suggested that a pressure relief valve be installed at the Fire Station. Costs were notknown, but estimated costs were briefly discussed.


Frey asked about padlocks on step stations. Hydro ordered locks which should be delivered shortly. Mayor Meyers commented that an ordinance should be passed regarding illegality of tampering with the said stations.

Developer inquired about costs to hook up to the systems. Inquiry was also made regarding who was responsible for purchasing septic tanks and lift stations necessary. He was told that one step station serves three homes.

Citizen questioned whether or not the mill rate would be increased because of the municipal utilities. Mayor said mill rate would not be increased because of the systems. Adding, that if the cost to allow a lot of hook-ups to the system were too great, a parvel may not be served by the city.


Munitech told the council that there was a significant amount of iron in the water. Suggestion was made to add polyphosphate to sequester the iron.

Motion was made and carried with all ayes to approve payment requests for Hydro Engineering.





Council considered pay requests submitted by the HRA. Motions were made and carried with all ayes to make, payment.

Set of specifications have been drafted for the park complex, the council was told on October 5th. The council was asked if they wanted to go out for bids or send specifications to firms who expressed interest in the project. Consensus of the council was to forward specs to interested firms.

City Administrator is still investigating the possibility of cable TV for Carver.


City Administrator presented a rough draft of proposed ordinance for restriction of animals in an R-2 District. Proposed ordinance will be presented to the Planning Commission.



He inquired whether or not funds, if any, remaining from the Lawcon funds could be put towards this type of development.
