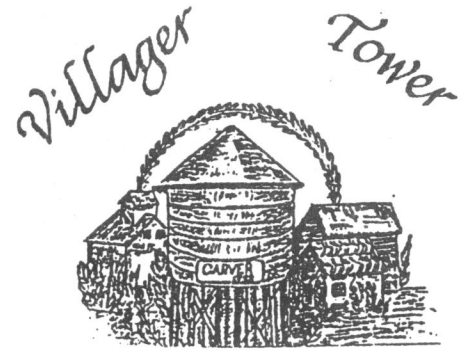

City Council News:

Building Permit

On August 7th the council reviewed plans for a house to be built on the unimproved part of Walnut Street. The Planning Commission approved the request.

Council reviewed 'Statement of Access Clarification'. This statement involved access through platted but unimproved public right of way. The use will be "as is" condition. This street has not been improved nor maintained. There are not any present plans to improve Walnut Street. Approval does not mean improvements or maintenance will occur.

Motion was made and carried with all ayes granting building permit.

Steamboat Days



Request was made on August 7th that Third Street be closed for SteamBoat Days. Events will be under one tent this year. Clean Sweep will give services basically the same as last year with half the cost being reimbursed to the city. Motion was made and carried with all ayes approving closure of Third Street.

The Lioness and Lions are handling the parade. The Lions donated three thousand dollars for SteamBoat Days.

Motion was made and carried with all ayes approving temporary 3.2 licenses for SteamBoat Days.

County Road #40



County Road #40 at Lime Street corner was discussed on August 7th. Mueller's are to give Frey an estimate.

Weeds along the county road were discussed. Carver County has been contacted.

Council Vacancy

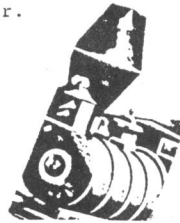
On August 7th motion was made and carried accepting resignation submitted by Councilman Hanson. Mayor thanked Mr. Hanson for his service to the city.

Council considered applications for vacancy resulting from resignation. Interviews were conducted with Stephen Antoni and Robert Low. Brad Gulden indicated interest.

Brief discussion was held on the candidates. Comment was made that citizens should attend the meetings to voice their views.

Motion was made and carried appointing Mr. Stephen Antoni to fill the vacant chair on the City of Carver council. Mr. Antoni was given the Oath of Office and took the vacant chair.

Light Rail Transit



On August 7th, Roger Gustafson, Carver County Engineer gave some background on the Eastern Carver County Transportation Technical Committee Agreement # 1 on the Light Rail Transit Planning Study. A grant has been received for this study. Carver's share of cost would be \$ 500 which has already been committed and payments made. Motion was made and carried approving Supplemental Agreement # 1. Request was made to approve Supplemental Agreement #2 which would permit the City of Waconia to join the Eastern Carver County Transportation Technical Committee. Motion was made and carried approving second agreement.

The county is in the process of obtaining information on Population and Employment Forecasts for the year 2010.

Hennepin County Regional Rail Authority has authorized an agreement to sell the railroad right-of-way in Chaska.

Gustafson presented possible Highway # 212 alignment at Carver, Dahlgren Township and Chaska Township. With population growth and employment forecasts his opinion was that a four lane highway needs to be built. The State hopes to start in 1993 and complete in 1999.

Fire Department



Fire Chief Riesgraf presented fire truck specifications on August seventh. The mayor stated that Councilman Antoni should have the opportunity to look at specifications before it is discussed. Motion was made and carried to go out for bids with the stipulation that the staff check for disclaimer. A fixed amount is necessary if the city bonds for the equipment. The city may decide to go with a financial option provided by the companies, then bond for the purchase.

Report was received on the burning of a house on Fourth Street. Loose brick was to be removed and the owner has been notified to clean up the area.

Administrator reported that two firemen were injured at a volunteer function. The insurance company has refused payment of claims.

Councilman Thuening attended a meeting in Cologne regarding formula to charge townships for fire protection. It was the general impression that the townships were not pleased with the formula.

Fire Relief Association members were present to request an increase in benefits for firemen. Fifty dollars per year, per man was requested. This would increase the budget by eight hundred dollars for 1990. It was stated that this increase should be looked at as part of the budgetary process.

Fourth Street Improvements



Property owner was present at the August 7th meeting to discuss Fourth Street drainage and ditch improvement work done by the city. Soil and Water Conservation Department will return to check drainage. A lengthy discussion was held on ditch work and watershed and drainage on the street.

Municipal Utilities



Administrator reported on August 7th regarding the sewer Construction Close-Out Update. The Engineer with the Corps of Engineers stated that the fuel gauge had not been placed as specified. There is also concern that the city does not have all of the construction records on the system. Maier Stewart has these and will keep them for seven years at which time they will be passed to the city. The EPA wants the city to have these and will check with Maier Stewart about obtaining them.

Municipal Utilities continued -

The Main Lift Station at Main and Oak Streets does not have adequate sealing around the electrical conduit and could cause damage to the panel. A sealer has been used. Engineer will be talking with Maier Stewart and try to get a handle on what records of Carver's they are still holding.

Sidewalk complaints were discussed.

Administrator spoke with Tom Hoffman of Hydro Engineering about work done on Seventh Street and SkyView Lane. Hydro claims no responsibility in either area. Hydro wishes the entire retained amount plus interest from July 1, 1989 returned. Motion was made and carried with all ayes to pay Hydro retained monies.

Annexation

The State of Minnesota Municipal Board has ordered approximately twenty acres annexed from Dahlgren Township to the City of Carver.

Harry and Lester Hartung's approximately 3.85 acres was also annexed. Mr. Hartung was present at the meeting on August 7th and stated that his land should be surveyed so he knows how much of his land is annexed. Purchase of the property for \$800 an acre was proposed. Motion was made and carried to purchase the land.

Question was asked about building on a vacant lot when the cost was \$16,000 to put in water and sewer because of lift stations necessary.

Sewer/Water Operator reported that a leak has been found in a water connection. Repairs will be made. Effluent samples are testing lower again and are almost back to normal.

Administrator reported that all residents who are required to connect to the municipal utilities have completed it.

Motion was made and carried to hook Meadow Bluff Addition residents to the water system with individual connections to the water main where possible.

Proposed Subdivision

Council discussed proposed subdivision request on August 7th. Administrator was directed to look at the tie sheet to determine whether or not the easement ran over municipal utilities lines. If it did, it would not be a responsibility the city would want.

Lengthy discussion was held on the proposed subdivision. Administrator recommended approval contingent on a more satisfactory access to the second lot.

Motion was made and denied concerning request for Minor Subdivision. It was concluded that the request did not comply with the intent of the Minor Subdivision Ordinance regarding improvements.

Riverside Park

Well house replacement at Riverside Park is complete except for the wiring. The Department of Health tested the well. The water is not contaminated but it was strongly suggested that the well be capped since it is in the flood way. Motion was made and carried to not operate the drinking fountain and post a sign that water is for sanitation purposes only.

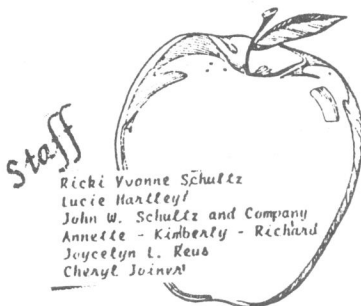
Carver Lioness

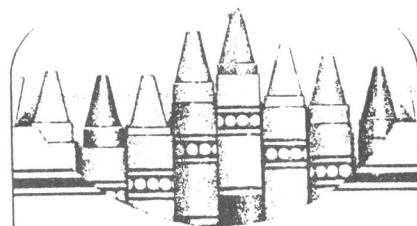
Instead of a party for the young adolescents, the Lioness will be hosting a Scavenger Hunt. There will be treats and prizes. Details to follow. Watch for them.....

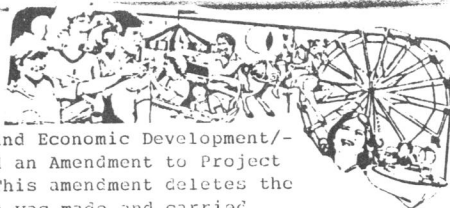

City Clerk informed the council of a liquor license violation of non-payment and notice forwarded.



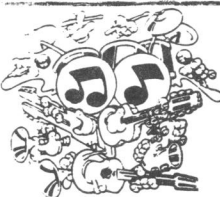

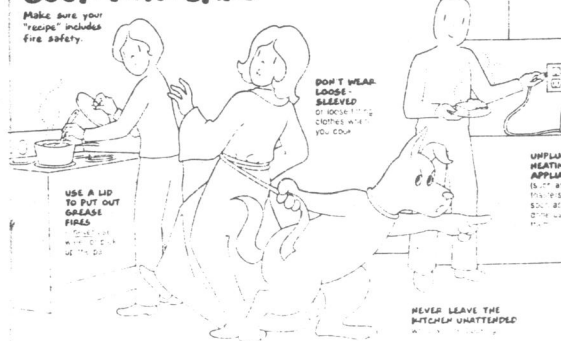

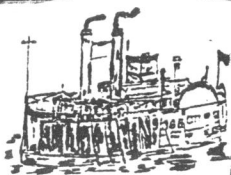
