

# Gary's Place



The owner of Gary's Place informed the council on August 3rd that he would be remodeling the bar slightly. He also requested putting Sunday Liquor on the November ballot. Motion was made and carried to approve year 3.2 license for Gary's Place on Sundays providing proper forms are presented and proof of insurance.

# Public Works Maintenance Garage



Frey received three quotes for the maintenance garage building. These quotes did not include plumbing or electrical, etc. These plans are for a 40' x 60' x 16' high building. Mayor Meyers appointed a committee to investigate the type of building and best placement. This committee is to report back to the council in Octo-

# Apartment



Administrator informed the council that the municipal utilities' fees for the apartment building are in excess of \$ 80,000. Lunak would pay ten percent (10 %) down on that amount and ninety percent (90 %) would be placed on property tax rolls for the next nine years.
Motion was made and carried to put ninety percent of municipal utilities' hook-up fees for apartments on tax rolls for the next nine years.

# County Road #147

Administrator attended the Carver County Board meeting about County Road # 147. County Board's interpretation of letter sent by the city was that the city was not cooperating. The board's decision was to go ahead with County Road # 147, upon completion, the city will be expected to accept the present county road.

# Dahlgren Township Board

letters to the Dahlgren Board to inform them of a new state law allowing a city to annex sixty (60) acres of land if the property owner(s) have petitioned for annexation without township approval. Motion was made and carried to table the issue until board arrived. The issue was discussed when members of the board arrived to discuss annexing one hundred (100) acres of Kelly's land. Administrator explained that the annexation process has been modified in recent years in favor of cities and can be done by ordinance.

Dahlgren board member commented that the city's Comprehensive Plan did not designate area for development. He further requested a time table for coming development with municipal utilities, since presently the board can serve property as well as the city. The mayor stated that options are being researched for updating the Compre-hensive Plan. He stated further that the city is unable to give a time table for municipal utilities extension.

Board member expressed concern of the city annexing said one hundred acres and then int he future taking land sixty acres at a time until reaching East Union. The mayor responded that property owners must petition for annexation.

The mayor also explained the city's desire to work with the township board on this issue. The board would like to see a development plan prior to agreeing to anything. The board would discuss the issue at their board meeting and get back to the council.

# 1993 Police Contract

Administrator told the council that patrol service rates for 1993 were at the same rate as 1992. Discussion pursued about contract services and whether or not time should be increased. Councilman stated that they would still like to see the Community Services Officer position implemented by the county. Council man also stated that they were dissatisfied with services rendered.

Motion was made and carried to retain patrol services with Sheriff's Department, but also to forward a letter requesting implementation of the Community Services Officer program.

## Miscellancous

Motion was made and carried approving consent agenda providing that organizations requesting temporary 3.2 licenses provide proof of proper in-

Frey informed the council that the Department of Fish and Wildlife contacted him regarding placing a holding structure at the edge of River-side Park to help keep water off the fields and in the swamp. The department will be submitting an agreement for the city's consideration. Presently, beaver dams are causing the problem of holding back water on fields.

Council was told that upgrade of gravel portio on Fourth Street is progressing slowly. Reminder was made that labor is being donated to keep costs down. More work has also been done on Community Park by volunteers. Citizen thanked the council for work done on street, but was concerned about the erosion occurring. The installation of a culvert is still necessary.

After brief discussion, decision was made to put excess funds in Streets Major Fund. Motion was made and carried placing excess funds in the Streets Major Capitol Fund.

Administrator informed the council that two households have defaulted on Rehabilitation Loans. Arrangements were made to repay loans in monthly installments.

Council requested explanation of Excess Liability Quotation. Motion was made and carried tabling action on this

Administrator told council of decision to not renew service warranty on computer since replacement would be more cost effective than paying cost of warranty.

St Nicholas Church requested charitable gambling license for SteamBoat Days. The council did not have any objections.

Administrator updated council on the installation of the weather siren. A timer and another radio and a pole are needed. this cost would be approx-imately \$ 3,000. Council had budgeted \$ 2,000. Motion was made and carried approving costs over budget for placement of weather siren.

Administrator was directed to draft an animal ordinance for the next council meeting. A Public Hearing was scheduled for September 8th meeting on proposed ordinance.

Mayor suggested issuing a challenge to neighboring councils for a water fight during SteamBoat Days. Letters are to be forwarded.
