Comprehensive Plan

At the February 7th meeting, representatives from McCombs Frank Roos Associates were present to discuss work on the Comprehensive Plan. The work has not begun at this time and explanation was given of what will need to be done, as well as information that the plan is used as a guide for the city into the future. The council was also informed that quoted numbers are "not to exceed" amounts. Motion was made and carried approving McCombs Frank Roos Associates to do the first phase of the Comprehensive Plan and return to the city with draft.

Motion was made and carried approving the engineering agreement with McCombs Frank Roos Associates with all ayes.

Sixth Street Limprovements

City Engineer presented an update of the Feasibility Report for Sixth Street Im., provements. Several options were reviewed for routing water and sewer to HillTop Estates. Council was informed that a grant has been obtained from the Soil and Water Conservation Service to be used for Sixth Street in the amount of \$ 248,000. The city will need to come up with the remaining funds for the project.

Tentative schedule for the project calls for a Public Hearing. Property owners along part of Fourth Street, Sixth Street and all of Sunny Side Addition should receive notices for the hearing.

Citizen inquired about run off into Spring Creek. The mayor responded that this issue will be researched.

Park and Recreation Board Chair reported to the council that the board recommended a six foot walkway to the Community Park plus dedicated land to square off the park and a tot lot on the east end of the proposed subdivision at Lenzen Second Addition.

It was also stated that a trail along Sixth Street should be built by the city, preferably along the south side of the street.

Motion was made and carried with all ayes adopting resolution approving the preliminary engineering report and scheduling a Public Hearing on 1994 improvements.

Municipal Utilities

Motion was made and carried with all ayes to adopt resolution approving transfer of water treatment plant costs from water operating to the General Fund. Qauwalter spoke to the council about the watermain break. Consensus was to bill the city for his expenses and the city would bill the contractor who allegedly caused the watermain break.

Carver Bridges

Public Works Director reported that the wording for the signs to be placed on the dike has been approved by the City Attorney. Discussion was held on the Ash Street bridge. Question was asked if Ash Street could be vacated without land-locking any property owners. Frey contacted Carver County who did the original evaluation of the bridge and requested letter submission to the city regarding safety of the bridge.

City Flag

Council discussed the design of the flag and proposed letter to Brian Kemkes who had agreed to add color to the drawing. Suggestion was submitted that the river should be part of the flag design and a name was suggested that could help with design and color. Council authorized forwarding the letter.

Public Square

The city received a letter from the Attorney General's office stating that a fee of \$ 25. per hour would be charged to write a legal opinion on the Public Square. It was the council's decision to set a limit of \$ 500 on the project. City Engineer told the council that a ponding area was designated for the Public Square since the water, if already running, would just be slowed down.

Employee Review

The council discussed Employee Reviews. Councilmember stated that it was the City Administrator's job to review the employees work per his job description. Administrator was directed to do the evaluations by the March meeting.

Hilltop Estates Addition

City Engineer reviewed proposed subdivision plans. Report was given that the street grades are okay and reviewed the storm drain system. Some lots on the cul-de-sacs do not meet lot width requirements. These can either be redrawn or a variance requested. With proposed street widths, parking on the street will not be allowed. The Fire Department reviewed the plans and the council reviewed recommendations made by the department. The council heard the Planning Commission's recommendations for conditional approval of the subdivision.

The Park and Recreation Board recommended tot lots in the proposed addition on Sky-View Lane. It was their opinion that anyone purchasing lots in Hilltop Estates Addition should be informed that there will be lights on the fields in the future. Another boardmember had pointed out that if cash were taken in lieu of land, then there would not be enough room for adequate parks in the future.

Council discussed Resolution to adopt the Preliminary Plat and rezoning for HillTop Estates Addition. Developer expressed that tot lots are more of a nuisance. Maintaining small pieces of park throughout the city and trails are becoming unfavorably regarded in residential areas because residents oppose people walking so close to their property. Councilmember agreed that tot lots are hard to maintain.

Developer agreed that a piece of land adjacent to the Community Park under the high wires could be donated as park land. A discussion was held on using a proposed dedicated street as a park near Sunny Side Addition. The street leads to an estate that is not proposed for development in the near future. If the land is ever developed the land would revert back to a street. The mayor suggested that the Park and Recreation Board meet with the Planning Commission in February to discuss the proposed subdivision.

Municipal Utilities operator requested that the water line to the park be of adequate size for irrigation.

Motion was made and carried with all ayes adopting resolution approving the proposed rezoning and preliminary plat of HillTop Estates Addition as amended.

Council was informed that Hilltop Estates Addition is on the Lower Minnesota River WaterShed District agenda. Councilmember would be attending this meeting.

Mayor Griep will try to get funds for an escrow account for Hiltop Estates.

Motion was made and carried reappointing Rosamond Dols and Tom Griep to the Planning Commission for a two year term.

Council directed the staff to make several changes in the wording of the Personal/Professional Service Agreement.

Administrator reported that FEMA is processing all costs pertaining to the flood at once and will pay when all is finished.

Council was informed that the county has set the City's Board of Review meeting for May 3rd. The mayor requested that council members bring their goals and strategies to be reviewed.

Motion was made and carried to adopt resolution increasing the pay for the Fire Department Equipment Engineer.

Council was told that the Fire Hall has been painted.

The Chaska Legion agreed to donate \$ 2,500 for dug outs for the Community Park.

Council was informed that a grant for the rail road water tower had not been submitted. A preliminary grant application had been submitted, but the Minnesota State Historic Society had informed the City that this application would not be given a very high priority because the property was not owned by the applicant.

Council was shown pictures from the flood. The mayor stated that these could be offered to the public for sale. This topic will be discussed more in the "Carver Quarterly" newsletter.

The mayor informed the council that there is a potential developer talking about the Industrial Park. The Dale Green Company now uses part of the land for a dirt business. It was the mayor's opinion that the business could be given a sunset date for the business in the

Administrator was directed to send apartment owner a letter stating that the Apartment Building is a nice addition to the community.

Council was informed that the Fire Department received a \$ 500 50/50 matching grant from the DNR for equipment.

Frey informed the council that windows in the Village Hall need to be replaced.

Did you know or are you aware that a local resident, Don Forner is an organizer for Volunteer In Overseas Cooperative Association (VOCA)?

Mr Forner has visited Indonesia. Has been invited to go to Romania to study the Dairy Industry. He has been invited back to Romania where he had organized the start up of pilot programs for 4-H. In his course of travel, he's seen the need for 4-H programs to help teach leadership to youths.

Mr Forner worked in the villages of Risnov and Zarnesti in the mountain area. He's worked through the schools. He's organized several clubs and left much material with them. Youths have learned election of officers, parlimentary procedures and he has taught these youths how to study and learn how to be successfull leaders. Mr Forner will be returning to Romania with videos for 4-H projects on poultry, rabbits, sheep and dairy animals.

There are other organizations also working with the Romanians to improve their living conditions and improve productivity of their livliehoods and make their lives betMr Forner will be returning to Romania in March for follow-up and to ensure that the pilot programs are going according to schedule, as well as bring them more material to study.


