Industrial Park Complex

Citizen expressed idea of promoting an industrial tax base to reduce taxes at the March 7th meeting. Response was that the Planning Commision has prioritized the planning and development of an industrial park. The city's goal is to boost the economic/tax base and implement industrial development.

Filtration Plant

The council discussed the filtration plant. This project is incomplete due to complications. There has been considerable volunteer work involved with this project, as well.

At the April 4th meeting the water filtration plant was discussed. City engineer explained that Carver water has a high iron level. The cost of replacing the old tank at the plant would cost about \$95 thousand, plus piping, valves and controls. Engineer estimated about \$185 thousand to revamp the water filtration plant. Council consensus was that it may be best to go with a new system. Administrator inquired if cost could be coordinated with assesments. City engineer stated that the entire community should be assessed for the plant.

Sixth Street Limprovements

The Feasibility Report for Sixth Street Improvements was discussed. Financing methods were discussed at length. In conclusion it was determined that this project would be financed by grants, assessments and the city budget. The tentative project schedule was discussed.

Townline Road

The city engineer reported that the Carver County Highway Department is preparing the final plans and specifications for the development of the TownLine Road which will be submitted to the State Aid Office.

Hilltop Estates Addition

The council was told that the preliminary residential plat was forwarded for review and will be reviewed by the council at the April meeting. This project will be coinciding with the Sixth Street project.

At the April 4th meeting the city engineer discussed HillTop Estates final plat. There were some problems with the walk way and hydrants, as well as some manholes

Some preliminary research had been conduced at the MPCA regarding the waste water treatment plant expansion. Added capacity will be necessary with three new additions. Authorization was requested to conduct further research for best alternative to expand waste water treatment system. Motion was made and carried with all ayes authorizing the city engineer to proceed with a maximum of sixty hours to research type of waste water treatment plant.

Eagle Ridge Addition

Engineer told the council that the Eagle Ridge Addition developers about extending water and sewer to SkyView Lane and that they require a feasibility report. Engineer commented that the street could be replaced, but this would be considered a repair project not a replacement project. Motion was made and carried to conduct a Feasibility Study for SkyView Lane with al ayes.

Town Square

Discussion was held regarding the Town Square lot. Neighbors expressed concern and desire that this lot remain a public park. Residents were told that property is landlocked.

Business District

Council discussed options available for real estate sale on Broadway. Motion was made and carried approving preparation of resolution regarding the sale of the property subject to restructuring formula including a ten year amortization period prepared by the city attorney.

Curfew Ordinance

The council discussed the proposed Curfew Ordinance. This ordinance is being promoted by the county on a county wide basis. Motion was made and carried with three ayes and one nay to include the Curfew Ordinance in the current revision of the city ordinances.

Flood Damage

Citizen was at the April 4th meeting to inquire about repairs to yard damaged during the 1993 flood. Public Works Director responded that as soon as it dries repairs will be completed.

Comprehensive Plan

The council was updated on the Comprehensive Plan. A special joint meeting was requested. Suggestion was submitted to reevaluate the direction to be taken next. Another meeting was scheduled for the eighteenth to discuss revisions.

Railroad Property

Council reviewed letter from the Rail road offering to sell the land at the water tower site for \$5,000. Research was conducted and it was discovered that County Road # 40 is built on part of the land which greatly reduces the usable amount of land. Motion was made and carried authorizing the city attorney to offer the Rail Road \$2,500 for purchase of the land.

Carver Fire Relief

Representative from the Carver Fire Relief Association informed the council that the audits for 1991, 1992 and 1993 have been completed. The Fire Relief Meeting was held on April 21st. The mayor and clerk had been invited to the meeting.

Fire Department

Fire Marshall Calvin Wilson accompanied Chief Dauwalter. A Comprehensive Plan for the Fire Department was handed out. City was asked if they had adopted the Uniform Fire Code. Chief inquired about making the policy into an ordinance. Decision was that existing ordinances should be reviewed first.

Chief discussed donating old equipment not in use. The Chaska Fire Department donated a new air compressor to the Carver Fire Department. Therefore request was made to do nate their old air compressor to another department. Motion was made and carried allowing donation to the Cologne Fire Department.

Council was informed that the Fire Department is four members short of number allowed by the City. Volunteers are being sought from within the city limits as most of the newest members are from the townships.

Ash Street Bridge

The attorney advised that it was council decision to do what they what desired with the bridge across Ash Street. A culvert installation was discussed. Suggestion was made to hold a meeting with property owners. Councilmember inquired about watershed input on issue for a solution. Suggestion was also submitted to slope and rock the area for access across the river. Staff was directed to contact property owners to attend council meeting.

Metro Waste Control

Frey explained that the Metro Waste Control Commission has a shed located on city property near Carver Creek where they sample water from the creek. Question was asked how modification of ponds would affect this sampling. It was thought that this would not make any difference. Motion was made and carried approving the agreement.

Meetings

Council discussed necessity of holding two meetings per month. A work session would be held in April.

Miscellaneous

Council was informed that one of the lawn mower decks is worn out and needs to be replaced. Research on costs is being done.

Administrator told the council that submission of an application for a Recreation Grant has been done.

Council discussed proposal of a full-time administrator but this had not been budgeted for at this time.

Building Inspector recommended additional fees be charged for plumbing and mechanical inspections.

Frey informed the council that funds in the community park fund for completion of the parking lot at the park were low.
