Administrator Resignation

Administrator, Glenda Spiotta submitted her resignation to the council. A search process has already begun. Two suggestions were made for this process, 1) a committee be formed to screen candidates or 2) to hire a company. Motion was made and carried to hire a company to do preliminary screenings.

Council reviewed events involving applications for administrator position. Interviews of applicants are not open to the public, explained the attorney, however discussions regarding hiring are open to the public.

Carver Youth Baseball/Softball Association

Youth groups extend there thanks to everyone who helped during SteamBoat Days.

City Administrator Candidate

Council was told that an offer had been made to an individual for the position of City Administrator. Candidate terms /negotiations were reviewed by the council. Personnel Policy concerns were reviewed and discussed. Further discussions were to be reviewed when new administrator accepts positions.

Suggestion was also submitted for a "work at home" schedule that be reviewed after six months. Motion was made and carried accepting terms and conditions of administrator candidate with a six month reviewal of "home schedule" condition.

Name of candidate nor acceptance status of presented offer for position of administrator has not been established at time of print.

Miscellaneous

Voice mail for the city council members was asked about. However the present phone system is not compatible for voice mail.

Engineer presented update regarding the levee and wastewater treatment plant. Erosion control in Carver Bluffs was also discussed.

Motion was made and carried by roll call vote adopting resolution approving final plat for Eagle Ridge Subdivision.

Council member requested consideration of taking on a full time individual for public safety and animal control. Council was told of one resident possibly interested in animal control issue.

Council briefly talked about amphitheater proposal across the river.

East Union Church

On October 2nd, Saturday (9am) at the East Union Church there will be the Church Bazaar / Lunch. Everyone is welcome.

Disclaimer

Preliminary minutes of City Council meetings were referenced to compose the "Villager Tower".

Municipal Utilities

The council discussed chlorine limits. The State has guidelines, but there are not requirements concerning chlorine. Chlorine levels at ten are not harmful, but are unpleasant.

The city experienced a water main break. Council member suggested that it would be helpful that when this type of an emergency occurs the council is informed. Stocking material was discussed. It would be expensive to stock items also interior storage would be necessary for many parts. Interior storage is not available. City engineer had determined that the water main break was a direct result of grading for sewer project. Therefore the bills should be forwarded to the developer.

Utilities operator informed the council that the "Well # One Alarm" does not alert externally of a problem and the pump will not automatically fill the tower. Two quotes were obtained for dialer for the well. Motion was made and carried to purchase a dialer for the well.

Motion was made and carried by roll call vote to adopt resolution-authorizing application for a loan from the Water Pollution Control revolving fund for wastewater treatment facilities improvements.

Ehlers and Associates voiced concern regarding city's' not increasing utilities fees. It is necessary to increase utility

fees annually. In order to be in the position to pay off current debt as well as complete capital projects. Financial advisor recommended increasing water rates. Council is contemplating considering an increase in connection fees and water rates. The council reviewed the compliance report concerning the new wastewater treatment plant from the MPCA. The report stated that more riprap is necessary at the ponds.

Two property owners were approached concerning selling land for Well #2. One property owner did not want to sell land. Discussions are still taking place with a second owner.

The council talked about the recommendation to increase municipal utility fees and connection charges. Motion was made and carried by roll call vote approving resolution to increase both utility fees and charges. Residents are to be notified of possible increase and that some of these funds would be used toward water quality. Public Hearing would be scheduled in January.

Administrator discussed drafting capital improvement budget. Utilities operator was present to discuss storage building and lift station elimination. Some lift stations are very old requiring much repair and not necessary. The council was doubtful about justification of cost for such suggestion. More explanations were necessary.

Storage building at treatment plant site was also discussed. If a new fire station were to be built. Storage in the old station will be considered. Both old fire station and storage at plant could be used.

Report submitted to the council contained strong recommendation of a need for ad additional well. Report was also given of repairs being done to the chlorine injector. The city is also experiencing water pressure problems.

Public Works Report

Mr. Frey reported that STS individuals had been assigned to work in the city. He reported on tasks completed by group.

Mowing of County Road #40 ditch and Water Tower area were discussed. Repairs of ditch area close to Lime Street and County Road #40 were discussed. A resolution for the problem area was not completed at this time.

Third Street Bridge

Motion was made and carried by roll call vote adopting resolution authorizing preparation of plans and specifications for the Third Street Bridge replacement.

Two businesses requested temporary closure of Third Street Bridge West for a Nascar race sponsored by these two businesses. Motion was made and carried by roll call vote adopting resolution authorizing temporary street closure of Third Street West.

Third Street Bridge soil borings were discussed. Deadlines and completion schedules were in conflict. Motion was made and carried to contract with American Engineering for Geotechnical work on Third Street Bridge.

Council talked about the Third Street
Joint Powers Agreement with Carver
County Motion was made and
carried to enter into the Joint Powers
Agreement with Carver County for
replacement of Third Street Bridge.

Carver Café

A Public Hearing was held regarding Conditional Use permits request. Council was told of necessary requirements for a variance to construct a basement on the flood-fringe area, as well as flood proofing for the Carver Café. Present use of area would be for storage to see how dry it would remain. Motion was made and carried approving Conditional Use permit to construct a basement below the main floor of the former Café.

The council also discussed parking requirements in central business district. Consensus was that parking would not cause any problems. Notification of nearby individuals was also discussed.

Administrator informed the council that the demolishing proposal for the café has been withdrawn. The building is going to be restored instead

Carver Creek Addition

Council reviewed second plat in Carver Creek Addition. Sidewalk location was questioned. Discussion was also held regarding siren changes per lot. Motion was made and carried by roll call vote adopting resolution approving final plat in Carver Creek Second Addition.

Council held Public Hearing for utility vacation easement in Carver Creek First Addition. No action was taken at that time.

Council was told that there was no necessity for a temporary road for emergency purposes. The fire Chief will review the issue.

Council was informed that the Fire Chief had reviewed the request for a temporary road to access Carver Creek Subdivision. He stated that Sixth Street access to the subdivision was adequate. Therefore, a temporary emergency road was not necessary.



Council was told that the Fire Department now has a full roster.

Donation was received from Fire Fighters Auxiliary, the council was told.

Construction of a Fire Station was discussed. Plans have been drafted. Engineer reveiwal was requested for construction costs. Discussions are to be scheduled after the hiring of an administrator. At that same time, Capital Improvement plans should be reviewed. Referendum process was inquired about. Process was explained. Options for financing construction of a new fire station were discussed. If a referendum was to be held it should be scheduled at the same time as a general election the attorney told the council.

Carver Bluffs

Council was informed that utilities had been installed for Carver Bluffs Third Addition. One lot does not meet front footage requirements. A discussion pursued whether or not a variance was necessary. Attorney stated that the land could be replatted and a variance be granted. Also final plat could be approved with the stipulation that lot lines be adjusted to meet code. Approving resolution was reviewed and a condition on the set amount of money per lot for sirens to be added. Motion was made and carried adopting resolution approving final plat in Carver Bluffs Third Addition subject to boundary adjustments and siren fees.

Carver Bluffs 2nd Credit Reduction request was presented to the council. Motion was made and carried to accept recommendations submitted to reduce Letter of Credit. Developer also submitted request to amend the Developers Agreement giving default.

Council member inquired about the island constructed on Carver Bluffs Parkway in Phase II, as well as being under the impression that it was not authorized. Another council member was of the opinion that it was authorized and appears to be on plans.

Conditional Use Permit

Council discussed the "Conditional Use Permit" status of bus garage on Sixth Street. There are concerns regarding outside storage, noise, hours of operation and odors. There are no longer any buses on the grounds. Question was posed that permit amendment was possibly necessary. Drafting these conditions was suggested. Staff was directed by motion to draft amendments for permits to be reviewed by the council.

Computer Upgrade Proposal

Administrator requested authorization of computer upgrade. Quotes are necessary. Suggestion was made to research used equipment. Administrator stated that ideally equipment should be purchased installed and functioning by year-end. Funding for this project was suggested to be obtained from "General Reserve Fund", as well as other departmental funds since usage benefits all related departments. Bids should let in order to determine feasibility of upgrade probabilities.

Church-By-The-River

The council discussed historical Grant pre-application for the Church-by-the-River. Administrator explained necessity to authorize submitting the pre-application. The Historical Grant would be a 50/50-share grant. The city's share would involve time and money. Motion was made and carried authorizing the staff to submit pre-application for grant for the church.

The ability to meet grant due date for application is doubtful. Council considered issue and came to the discussion that it may be best to submit application in next grant cycle.

DNR Trails

Council reviewed the DNR Cooperativ Trails Grant status. At the request of th DNR the grant had been revised. Motic was made and carried to begin negotiation with property owners for additional land necessary for the trail.

DNR Cooperative Trails Grant for Carver Creek Trails has been received by the city. Administrator has been talking to residents regarding obtaining easements for these trails. Public Safety

Officers have not been attending meetings. Sheriff's Department stated they would start sending representatives. Reminder should be sent.

Council discussed obvious disregard for stop signs of 4th Street and Lime Street. Sheriff's Department to be alerted of these violation areas.

The position of Community Service Officer would have to be created by an ordinance. Decision was made to pursue this issue with new administrator later. Also funds were not available for this year.

Public Service

Council discussed contracting police services for a half-hour or one-hour contract and conduct extra patrols as well as researching other options.

Motion was made and carried adopting resolution to contract Police Service for 2000.

Carver Lions

Hey did you know that the Carver Lions celebrated their 25th Anniversary? This celebration included a dinner and boat ride on Lake Minnetonka.



The county has offered the City "City lot #7", Block # 27 for public purposes. Due to the location it was the council's consensus that this lot could be utilized for levee maintenance. Staff was directed to draft a resolution accepting the proposal from the county.

Motion was made and carried by roll call vote adopting resolution accepting the counties offer of tax forfeited land (Lot #7, Block #27) proposal.

Several lots had been purchased during the levee improvement project. Property owner has since contacted the city regarding donating the remaining lots to the city. However this would involve legal fees. These fees were questioned. Further discussions are to be held.

Motion was made and carried by roll call vote adopting resolution accepting land donation of property owner for land in floodway.


