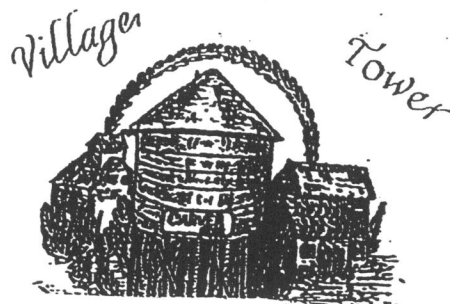

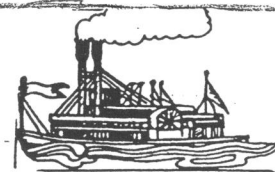

Community Parks

Vandalism at the community parks has increased. Prior to school closing for the summer the vandalism at the Community Park has not been as noticeable, but a lot of damage is occurring at Bluff Park. The Lions Park is not exempt from vandalism either. The Sheriff's Department is attempting to do all they can to catch the vandals. Possible Park Ranger or 'Adopt a Park' programs were suggested to help deter vandals.

Suggestion was submitted to post park hours at the parks in order to reduce the vandalism. Cables to close access should also be considered at the parks.

The Park and Recreation Board recommended acquiring signs stating "No Golfing On Ball-fields". The board also recommended purchasing two picnic tables with a small shelter at the Carver Depot Park area. It was also recommended approving the purchase of one set of bleachers for Bluff Park. The council by motion accepted recommendation approving purchases.

Soccer Field

The council discussed bids received regarding the approval of the Soccer Field. The bidding process was set up in three parts and any part could be bid on by contractors. Prior to acceptance of a motion the issue was discussed. Park and Recreation Board member opposed the high cost of the bid, suggesting removal of several items to decrease the cost. Statement was made that it was never the Board's intent to spend more than \$60,000 on a soccer field. The engineer stated that the Board had not intended to put in a parking lot and storm drainage. Field elevation was also discussed. A change order could be done if the bid was accepted. The council asked the Board if this was the work desired to be done. The Park and Recreation Board members present responded that they wanted the field, but due to add-on, the cost had increased and this was not the amount they wanted to spend. Council member inquired if the engineering costs would decrease if the bid was reduced accordingly. The engineer was of the opinion that acceptable percentage adjustments could be done. Motion was made and carried with all ayes awarding the project to Braun.

At another meeting a decision was made to not accept the bid for the soccer field at the Community Park. Decision was made to put the soccer field at the Bluff Park at a lesser cost.

Park and Recreation Board

The Park and Recreation Board has requested relocation and purchase of additional trees for the Community Park. Motion was made and carried approving expenditure for planting trees in the Community Park.

Municipal Utilities

Public Works Superintendent informed that council that usage was up with the water and the well had a hard time keeping up. The emergency pump had not been turned on. The second well is not completed yet. Since it rained, it was possible to get the tower filled.

The council was told that progress is being made regarding the Pump House and Well No #2. The Public Works Director should know soon how many gallons-per-minute will be pumped at the well site. Over weekends, 200 to 300,000 gallons of water are being pumped. This is due to people home over weekends, more water usage, more yard work and increased numbers of homes.

The council was informed that the generator at the waste water plant had exploded and a temporary one was being used while repairs were made.

The water tower was again very low. The new well should be operational real soon.

Variance Request

The council reviewed the variance request concerning Oak Street with the City Planner. The Planning Commission recommended approval of the request. The homeowner proposed expansion to his home but needs a variance for setbacks. The house is on a non-conforming lot of record. Recommendation of approval was given for the unusually small lot with conditions that the building plans be submitted for approval by the city showing addition matches architectural style of existing home and the downtown area. The moving of the shed was discussed at great length. The alley in the area is used for parking. Vacating the alley was discussed. The issue will be researched and followed up on in the future.

City of Carver/Carver County - Joint Powers Agreement

The Joint Powers Agreement between the county and the city was reviewed by the council for County Road #40 design and construction of street improvements. The attorney recommended change concerning auditing. Motion was made and carried with all ayes approving the agreement with the ability to audit county books.

County Rd #40 - Lime Street

Administrator had talked with the county officials regarding improvements at the Lime Street intersection with County Road #40. Recommendation was submitted for a study on this intersection. The engineer suggested a Feasibility Study. Administrator was directed to schedule a meeting with the county concerning the intersection and improvements potential.

Township Fire Contracts

The attorney had not expected to discuss the contracts with township representatives who were present at the meeting. Suggestion was made that the administrator meet with the townships and review the contents of the contract. The contract was standard formula used with other townships and cities throughout the state and this formula has been used for quite some time. Decision was made that the administrator get input from the townships and discuss issues with them and then review with the council. Also, the San Francisco Township clerk expressed that the valuation of DNR property should not be included in that township's fire rates.

Amphitheater

The council was given an update on the amphitheater issue ongoing in Scott County. The amphitheater is designed to point northwest, directly at the City of Carver. The area proposed for this amphitheater is near Bryan Rock area on Highway #169 in Scott County. Carver was encouraged to submit feedback during the public comment period. To find out more information about this issue contact Scott County.

Miscellaneous

The council reviewed renewal of city insurance. The city's agent updated the policy.

The council discussed pursuing purchase of a home on Oak Street. The mayor reported information received concerning allowing a second lift station close to current lift station. Administrator recommended purchasing property regardless, demolish the structure and reserve the property for public use. The issue will be pursued at a later date.

Administrator informed the council that changes had been made to the Emergency Management Plan and the council should be reviewing the final version of the plan for their approval. The Emergency Management Plan was accepted by motion with all ayes.

Administrator attended a meeting with the sheriff regarding Community Service Officers' Program. A task force to research this issue is being set up.

Carver South

The developer researched the issue of the cost for upgrading Seventh Street determining that it would be more cost effective and in order to improve the street to current city standards then the development must have ten housing units. The Comprehensive Plan guides concerning density would require an amendment. A Public Hearing had been held with the Planning Commission. The recommendation submitted to the council was approval of Comprehensive Plan Amendment and Conditional Use Permit with the following conditions: a final landscape plan be submitted with the final plat; an easement for turnaround be provided to the city; the cul-de-sac turnaround be determined adequate; and that all of the requirements are met by the city engineer and the city attorney. The preliminary plat approval contained the following conditions: Seventh Street be reconstructed to city standards by the developer; park dedication in cash-in-lieu of land; a Homeowner's Association be created to own and maintain the private street and Outlot 'A'; and that city engineer and attorney requirements are met. Statement was made that Klingelhutz Development would be bearing the entire cost of the Seventh Street upgrade. It was the developer's contention that the overall unit is more efficient in the new design. The height did not change. However, the new design puts the per units over the number allowed in the Comprehensive Plan. The developer is requesting an amendment to the Comprehensive Plan. It was estimated that the unfinished costs of the units would be approximately \$160,000. The finished cost was estimated to be approximately \$170 to \$180,000. Concern was voiced regarding affordable housing. It was one council member's opinion that these costs were not affordable housing costs. Question was asked if increasing the units were better for the community. The city is provided with alternate housing. Different types of living lifestyles are the trend at present.

The project had been recommended for approval of eight units and now approved for ten unit with other issues remaining the same. The city engineer interjected that the issue of some water runoff still needs to be resolved. Stormwater standard meets city standards for the project. However, there are still some water quality issues requiring approval.

The attorney pointed out that if the council approves the changes in units by approving the Comprehensive Plan amendment then a resolution would be submitted to the council. The city planner recommended approval. The Planning Commission recommended denial to the amendment so as to keep the area low density.

A citizen inquired about Conditional Use Permit requirement still being effective even though units increased. The Conditional Use Permit was still a requirement. Another citizen reiterated the Planning Commission denial recommendation. Council consensus was indicative of approval. The attorney would draft the resolution to be submitted to the council. Motion was made and carried adopting resolution amending the Comprehensive Plan for Klingelhutz Construction developing Carver South. Motion was made and carried adopting resolution approving Preliminary Plat of ten units of town homes and one outlot of Carver South. The attorney recommended resolving front and rear yard set backs and the need for a variance since this issue has not been met. Resident inquired about contact person if issues arise with the developer/development. The Administrator should be contacted.

Financial Reconciliation

The administrator reminded the council concerning hiring Abdo, Eick and Meyer to prepare investment reconciliation for 2001. Administrator also recommended hiring an individual to update the Developer's Escrow accounts up to date and continue an ongoing investment schedule, bank reconciliation and financial report at a per month fee. If overtime could be controlled then that cost would cancel out the cost for this service. Motion was made and carried approving additional expenditure.

A representative from Abdo, Eick & Meyers was present to discuss the 2001 Audit. Some information was still needed from the previous auditor, and the City Clerk had done most of the entries. This issue needs to be evaluated monthly. These processes are all necessary to bring the city's accounting up to date.

Comprehensive Trail Proposals

The council made a motion, which carried with all ayes approving funding for surveying the Carver Creek Trail Corridor and the Carver Bluffs Park. Survey work is to involve Bluff Park area and existing ball field. Also included is the property/easement acquisition along the north side of Bluff Park and an area encompassing the Carver Creek Environmental Corridor Trail (Bluff Park to Ash Street). The Park and Recreation Board discussed the area north of the Bluff Park.

The city planner distributed copies of a revised chapter of Comprehensive Plan regarding planned future trails. The Park and Recreation Board along with the city planner reviewed the map showing the trail locations. The board members recommended a walking path from Sixth Street to Lions Park. Categorizing the parks was suggested. These parks were Depot Park, Downtown Square and Overlook Park, which are being referenced as "pocket parks" or "picnic parks". Priorities and Projected Time-Lines for Park and Trail Improvement revisions were also presented to the board for their review and adjustments.

The DNR has been contacted regarding purchase of land off of County Road #45. Requested parcel was not available, but a piece further down west of #45 was offered. The DNR was to be approached about interest in RiverSide park.

Carver Ridge

The council held a Public Hearing concerning infrastructure improvements in the Carver Ridge area lift station. The proposed assessed improvement area is adjacent to County Road #40 which is preliminary as Carver Ridge and Carver Bluffs. The estimated costs were discussed. The engineer told the council that assessment consideration for all or a portion of the costs, plus costs of financing the improvements for these properties would need to be considered. Assessment options were discussed. To handle growth the facilities would be oversized. Carver Bluffs developer had not responded at this point regarding the public hearing or his input. Motion was made and carried authorizing the plans and specifications. The issue will be discussed at a council meeting in the future.

Carver Ridge property consists of 56.03 acres. A Public Hearing had been held at the Planning Commission meeting. The staff was directed to prepare an ordinance rezoning the property to residential.

The engineer reported that issues to be resolved are: the preliminary plat does not show the drainage and utility easements; easements along property lines; by pass lane on County #40; an additional right-of-way issue; grading, drainage and bluffs. The bluff has been placed in a conservation easement for the First Addition.

The representative for the developer was of the opinion that it was not the developer's responsibility to obtain right-of-way and/or easements for a turn lane. The developer has adjusted grading to accommodate drainage and bluff issues. Attempts are being made to save as many trees as possible.

Man made bluffs and bluff set backs are a major concern for the council. Consensus of the council was to have the staff draft an ordinance pertaining to this issue. Carver Partners is closing on the entire project. The city will be able to draw down on this money if Carver Partners fails to reimburse the city for costs. Motion was made and carried with all ayes authorizing payment for grading by Carver Partners.

Fire Chief inquired about uniform Fire Code streets and hydrants in new development area.

Fire Department

The Chief gave the council a report for calls for the Fire Department. It was Fire Department members' opinion that there is an increase in calls.

The council was also told about promotional radios being recommended for the Fire Department. The Fire Department will be required to be equipped with these new radios by February. The cost for one radio is approximately \$600. The county has set aside money in matching funds to aid in the purchase of these radios. This item is to be discussed further.

The Fire Chief has done more talking, and checking and he reported that the costs have been lowered. The council was also told that the Sheriff's Department has allocated monies per Fire Department towards the radios. The Fire Department could also utilize their Capitol Fund to help pay for these radios. Motion was made and carried approving purchase agreement upon attorney approval.

Village Hall Electronic Sign

The Carver Lions and the council discussed a proposed electronic sign for the front of the Village Hall. Information was given to the council regarding an electronic sign. The Heritage Preservation Commission had been contacted. The Heritage Preservation Commission did not feel that an electronic sign was representative of historical aspects that the city's guidelines were attempting to achieve in their long range plans. The Carver Lions opposed the use of plywood signs on the Village Hall if the new façade was being put on the Village Hall. Advertisements, announcements, bulletins and such would be displayed preferably on an electronic message board to enhance the appearance of the exterior. [It sure is difficult to mix the past with technology and progress sometimes.] Plywood just would not cut the mustard this time around. Motion was made and carried accepting the notion of an electronic sign on the Village Hall. The council reviewed the schedule and cost breakdown of the project. The council thanked the Lions for their support, work and contribution to the city. The goal of the Lions is to have the project completed for the 150th Celebration at SteamBoat Days. [September 6th, 7th and 8th]

DownTown Improvement Project

The Public Hearing was held regarding the Down Town Improvement Project Assessments. The engineer distributed streetscapes and explained that the project has been progressing with discussions with various groups. Some scope of the project has changed from the start and a street variance which the state has approved as necessary. Cost changes were reviewed. Funding would be done by assessments, tax increment financing, county and state grant funds. Parking issues were talked about. The engineer stated that it was their hope that most of the work would be completed by SteamBoat Days. Parking, turning, trucks, fire trucks and bumpouts were all discussed. Parking would be at a 45° angle. Question was raised regarding removal of this type of design of bumpouts on corners in Hopkins and why would another city put them in. Council member stated that in Hopkins the issue was parking for businesses and they were removed.

Business owner inquired about work being done since his business had promotions scheduled to coincide with the PGA Tournament taking place in August. This would affect parking for this promotion. The work is scheduled tentatively to begin the end of July or the first part of August. Streets being torn up would affect his business and scheduled events. The engineer assured that two lane traffic should be maintained during the project.

The issue of storm water and catch basins was briefly discussed. This project would probably not solve the water run off issue. An assessment hearing should tentatively occur in October some time.

Bids were received for the DownTown Project. One council member's opinion was to discuss the project with the business owners before proceeding. If work was to be completed by SteamBoat Days, then the work needed to be started now. Motion was made and carried with three ayes and one nay to postpone starting the project. Concerns voiced involved the light posts, possibility of work not being done for SteamBoat Days, projected increase of traffic due to the PGA Tournament and receipt of only one bid.

Thank God for small towns ... And the people who live in them.

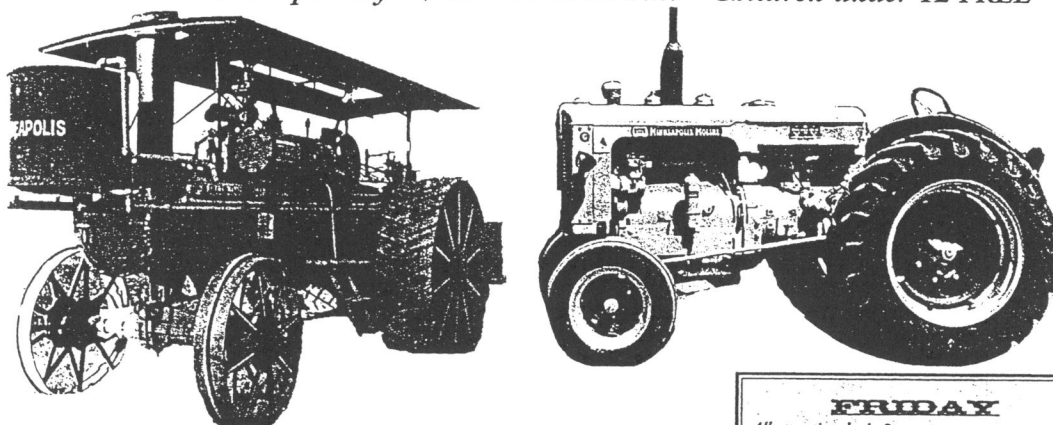
