

# City Administrator

At the December council meeting, the city's new administrator was introduced to the council and the staff. The city hired James Elmquist. Stop in and say hello.

#### 2003 Council

At the January 2003 council meeting the City of Carver swore in the mayor for another two years, James Weygand will represent the city again as mayor. Council members for four year terms were sworn in as well. Welcome to Cindy Monroe and Paul Andrescik. Wayne Voelker and Mark Chalupsky has been thanked for their service at a previous meeting.

#### 2003 Fire Contracts

The township's representatives talked with the council and the city's attorney concerning the Fire Contracts. The townships questions were addressed by the attorney. The attorney stated that the townships had valid questions since they had not received all the financial and other information. The attorney stated that the fire protection lines are set by response time and probably would not be changed. He further stated that the townships requests were reasonable. A partial agreement had been accepted. One township member commented that there was one problem with the contract. Mr Harris responded that he would discuss the issue with the other attorney.

Another township representative stated that many figures do not calculate. They would like to understand the figures and calculations and formulas. Suggestion was submitted to meet with the administrator. Each township would be represented to address issues and questions.

# Public Safety

The city was quiet the deputy reported. Information for the pilot program was being evaluated. The department would like several nonths of data prior to issuing a report to the city. Suggestions from the city on what type of eport and what information was wanted in this eport were being requested.

The Sheriff's Department presented the council vith a special copy of the department's recorded hours of work in the city.

## Public Works Report

The council was told that as a result of closing the Ash Street Bridge a land owner has been denied access to his property. The issue needs to be addressed.

The Fire Station/Public Works Committee held their first meeting and discussions had gone

The council was updated on information concerning the residence on Oak Street. Agencies have been contacted to check for substances within the house. This information is necessary before demolition in order so that adjustments can be made in bids for contingencies.

An asbestos study had been completed on the property on Oak Street. The samples were reviewed by an accredited laboratory; Nova's NVLAP. Special handling will be required during demolition. Recommendation was submitted that people should not be entering into the house. Letters were to be forwarded informing residents of this recommendation.

The Ash Street Bridge was briefly discussed This bridge needs replacement but options need to be researched. This bridge is part of the planned trail system, however, not all of the property has been dedicated at this time for this purpose.

The council reviewed the snowfall conditions with an employee's resignation. A back up person would be necessary. Decision was made by council consensus to put in place a back up individual.

An increase in vandalism occurred in the park over the Christmas season. The Community Park was graffitied badly.

## Truth in Taxation

The council continued the Truth In Taxation Public Hearing. Questions were requested. A resolution change reflecting total budget and total levy were discussed. The format had been changed because the League of MN Cities recommended that the resolution reflect total levy. A decision would be necessary on how the city would finance the fire station/public works building. This was necessary to determining the amount necessary for the levy. The financing options were discussed. Motion was made and carried to use the growth factor basis for the new bond issue. Motion was made and carried adopting the resolution approving the 2003 budget and the levy for the City of Carver.

# Down Town Improvement

## Project

The city engineer was asked how long businesses would be inconvenienced during the Down Town Improvement Project. The response given that that inconveniences could be for approximately up to a month and a half. The contractor would do one side of the street and then the

The city planner requested authorization for work to amend the Zoning Ordinance for the residential district. Motion was made and carried with all ayes directing the city planner to present proposed amendments to the Zoning Ordinance to the Planning Commission for the residential districts.

#### Municipal Utilities

The Municipal Utilities Superintendent reported that a lot of water has been pumped in 2002 and thereby, a lot of water had also been treated at the wastewater treatment plant. It was also stated that the new well should be operational by the heavier watering season.

The engineer reported that several meetings were held with the adjacent property owner to the water tower where the city has tentative plans to construct the water treatment plant. . Various issues discussed were time schedule, scope of the project, assessments, land surveys, purchase of land and appraisals, as well as the right of entry agreement. The schedule and funding were the big issues, but the placement of sewer and road paving were two issues to be resolved yet. One option was the authorization of the design of the water treatment plant for 2003 construction including sewer & water extensions. A second option was to design the water treatment plant in the summer of 2003 and construct in 2004 and the fund the project with either the Drinking Water Revolving Loan Fund or conventional bonding. The engineer recommended proceeding with this project with either option. The attorney interjected that in order to construct a water treatment plant, sanitary sewer is necessary at the site. The attorney's opinion was that the engineer should be directed to update the Mt Hope Road Feasibility

The cost of updating the Feasibility Study was discussed. The engineer estimated the cost to complete the study. The Public Works Director inquired if the study would be inclusive of Lime Street and Hidden Bluff. The engineer stated that the 1996 study did not include these areas. The council continued discussions regarding the scope of the project. Motion was made and carried with all ayes instructing the engineer to update the 1996 Mt Hope Road Feasibility Study with the amount not to exceed \$1500.

The council then discussed the type of water treatment plant that would best serve the City of Carver. The Municipal Utilities Superintendent strongly preferred the gravity system over the pressure filter. Operation and maintenance costs of either system were equal. Motion was made and carried with all ayes to build a gravity filtration water treatment plant with construction to occur in 2003. Motion was made and carried directing an appraisal be completed on the property on Mt Hope Road.

The council reviewed the update on the Water Treatment Plant. The council discussed design costs. Inquiries were made regarding the operation and maintenance costs. The O & M costs on the gravity type plant would be approximately one thousand dollars annually more than a pressure filter plant. Each system's life expectancy was approximately fifty years. The filter plant would require disassembly and sandblasting requirements several times during that time frame. Security was discussed. The design and costs of the plant were discussed. Touring of a similar plant could be arranged. One council member expressed concern regarding the exterior appearance of the building as not to be offensive to the neighborhood. Concerns of adversely affecting the new development were discussed. Aerator hook ups for future use were questioned. The engineer would research the pros and cons of the aerator issue.

## Proposed Fire Station/Public Works Building

A two and a half acre parcel may be for sale adjacent to the proposed Fire Station/Public Works Building. It was the mayor's opinion that it may be a good idea to pursue purchasing the property. Comment was made that the City Hall may be outgrown at some point in the future. Or this might be a good site for a business.

An invitation was extended to the council to join in the tour of the New Scandia building. The proposed construction in Carver would be similar to the New Scandia structures. The engineer would arrange for the members interested.

The council was told tha the meetings for the project were going well. Several issues will required council approval. Two of these items included the security system and the name of the build-ing. The council then briefly discussed signage for city buildings. It was the opinion of the Mun-icipal Utilities Superintendent that signage for all city buildings should be uniform. Council member commented that the signage issue should be passed to the Planning Commission for consideration.

The council was brought up to speed on the New Scandia tour update. The council was told that Carver's building would look slightly different than the New Scandia site, especially the location area. Another council member stated that it was beneficial to tour the site. However it was the council members opinion that Carver should bid several different ways. The cost differences should be examined between floor and ceiling heat.

The committee is tentatively scheduling Design and Development Approval for February 14<sup>th</sup>.

Question was asked if the old fire station would be available for rent after the new building was built. Another individual inquired about the sale of the Fourth Street East garage possibilities. The council would need to have discussions regarding long term plans for the fire hall building, public works building and the city hall.

## Bluff Ordinance

The Planning Commission had reviewed the Bluff Ordinance and submitted their recommendation to not adopt the bluff ordinance changes The DNR's recommended set back was 30', however the city's set back is 50'. The City Planner explained that the reason for this depth was because the city is more susceptible to erosion. It was one council member's opinion that the Planning Commission should review the bluff issue as a whole. Motion was made and carried by roll call vote with all ayes to deny the proposed ordinance amendment. One suggestion submitted was to ask the Planning Commission to review the ordinance. Another suggestion was to ask the Carver County Soil and Water District review the issue, but this was debated.

## General Obligation Bond Sale

Ehlers and Associates representative reported on the bond sale process. Motion was made and carried with all ayes adopting resolution providing for the sale of General Obligation Fire and Public Works Facility Bonds, Series 2003A.

## Building Inspector Recognition

The City Administrator reviewed services done by the Building Inspector, Tracy Salzl. The new building inspector complimented her work, especially recognizing her excellent record keeping practices. Council representative submitted personal compliments recognizing her work. Motion was made and carried with all ayes issuing a Certificate recognizing Tracy Salzl's work for the City of Carver.

### Church-By-The-River

Progress on the work being done at the Church-By-The-River was reviewed about. Report was given that the Lions are working hard and doing a good job on the project. The work is coming along nicely. Question was asked if plans still were to move the meetings to the Church-By-The-River site when work was completed. Those plans were the same to date. The Lions were to be asked when anticipated completion would be and when it would be ready to use.

#### RiverSide Park

The Park and Recreation Board held discussions with the representative from the Fish and Wildlife Service regarding the possibility of purchasing RiverSide Park and obtaining land located west of Carver County #45. The refuge manager explained to the Park and Recreation Board in order to begin the process of the sale of the park site would require an appraisal of the park. After the appraisal, the service would offer the city a fair market value of the land. With the possible sale of the land the city would then use the purchase to obtain other land.

Question was asked what the plans were for the park? Plans were the same for the park, except no motorized vehicles, biking on the trails and possibly moving of the boat ramp. The monitoring of the gate was discussed by the board. Regulations regarding the Weapons/Hunting in the city limits were briefly discussed. The board's opinion was that no firearms shooting be allowed in city limits. The refuge manager was asked about regulating activities in the park. The concept of 'good neighbor policy' working with the city would be concept materialized for the issue. The board recommended that the city council approve the US Fish and Wildlife Service to conduct appraisals for River Side Park.

#### Soccer Field

Jen Jaeger who is the Club Administrator for the Chan-Chaska Soccer Club was present at the Park and Recreation Board Meeting to discuss field usage for the Multi-field (Soccer Field). The Board reviewed presented information about the organization. Ms Jaeger explained their interest in the Bluff Park field and inquired about the possibility of allowed usage of this park. Allowing the use of this park would in return bring the game to the Carver Community, intergrating local kids with the surrounding communities. They would also plan on provisions of new uniforms and equipment, Surrounding community's field's usage was discussed. Minnetonka has the majority use of surrounding field's. One board member was of the opinion that it would not be a prob-lem with the club using Bluff Park field. Sug-gestion was made to a one year agreement with the club. The board submitted recommend-ation to the city council allowing the Chan-Chaska Soccer Club use of the Bluff Park field.

The Board discussed information for pricing and specifications for Combination Soccer Goals. Suggestion was made to purchase one se of Combination Movable Soccer Goad and two sets of 12' Soccer Goals. Motion was made by the board to recommend to the council to purchase one set of combination movable soccer goals and two sets of 12' soccer goals.

#### Park and Recreation Board

The City of Carver web site was discussed by the board. The board would like to create a link to the web site. The site is still being worked on by city staff.

The board discussed the conversion of the old Fire Station into a youth activity center. Suggestion was also made to utilize the upstairs of the Village Hall as part of city hall. Suggestion was also submitted to utilize the Church-By-The-River as a library.

The Board discussed the possible use of Surveillance Cameras in the parks to control the problems of vandalism. Results were discussed by using this type of method to monitor park activities. Maintenance and types of cameras to be used were all reviewed by the board members. This issue was to be researched further.

The Village Hall gym would be used on Saturday mornings for area youths. Volunteers were needed. The gym would be open from 8 AM to Noon. Interested in volunteering? Watch on the Village Hall bulletin board for contact name to volunteer.

#### InowMobile Ordinance

The proposed snowmobile ordinance was briefly reviewed by the Park and Recreation Board. Suggestion was made that the ordinance should be forwarded to the Snowmobile Association for their input.

The council reviewed and discussed the proposed revised SnowMobile Ordinance amendments. Motion was made and carried with all ayes adopting the ordinance amending the section relating to the city code on snowmobiles.

#### River View Estates

Motion was made and carried three ayes, one absent and one abstention to recognize River View Estates final plat to be initially null and void and re-approved post September 1st therefore falling under the jurisdiction of the Carver County Soil and Water District. The council discussed the motion. One council member inquired how this motion would benefit the city. Response was given that there are bluff issues with this development and the stated motion would clarify the city's opinion. City liability was questioned. It was the attorney's opinion that this was no guarantee that the county level would take on this project. The attorney advised not passing the development against city ordinance, but did not see this particular motion causing any civil liability. One council member wanted to research the issue further before asserting his opinions by motion. therefore abstaining from voting.

## Annual Clean-Up Day

The administrator informed the council that the Annual Clean up Day for the city was scheduled for May 17<sup>th</sup>. The service is funded by a grant from Carver County. The council was asked to approve this use for the funds. Motion was made and carried with all ayes approving the funding the city annual clean up event with funds from the Carver County Grant.

#### Carver Tax Service

## Highway #312/#212 and Counly Road #147

Ms Lisa Freese from MN DOT was introduced to the city council. Ms Freese is a member of the Highway #312/#212 Technical Committee. Carver County's Assistant Engineer, Bill Weckman was also at the meeting. The council was told that the #312 alignment has been in the planning stages for approximately thirty years. She further explained that the work north of the area was mostly completed. Preparations were now being done for the highway through the remainder of Eden Prairie, Chanhassen and Chaska for the next phase. The project is in a preliminary design phase and will go out for bids to complete the final design. This plan is a 20 year plan. Even though there are no funds presently, the committee wants to have plans in place when funds are available.

The council pointed out that the City of Carver has some concerns regarding the plans since it appears that the County Road #147 connection will be difficult to #312 exchange. The city is attempting to promote more businesses into the community, the appearance of the forecasted #312 exchange is going away from the community. The response by the MN DOT representative was that the Highway #41 crossing is also a concern for the project.

Councilman stated that in reviewing the City's Comprehensive Plan his question was where the connection to the #312 exchange would be since this was the first time they heard of it moving north and west of the County Road #147. Ms Freese stated that there would be no direct access to the road except at designated distances. Council member questioned the difficult access from the county road to either #312 or #212. Another council member expressed his hopes of MN DOT working with the City in the alignment with the county road. The administrator and the city engineer would be working with Ms Freese addressing the city's concerns and questions.

#### Trinity Lutheran Church

Starting this month, the Trinity Lutheran Church will be holding a 6 PM "Casual Praise Service" every third Sunday of the month (except April) for residents of the community and surrounding areas. Easter Sunday in April is the one exception in 2003. The service is available to offer people the opportunity to worship who can't make it to the morning service or prefer a more relaxed, casual environment or atmosphere. We were always playing outside. We shared one grape soda with four friends, form one bottle and no one died from this. We did not have PlayStations, Nintendo 64, X-boxes, video games at all, 99 channels on cable, videotape movies, surround sound, personal cell phones, personal computers, internet chat rooms....we had Friends!
