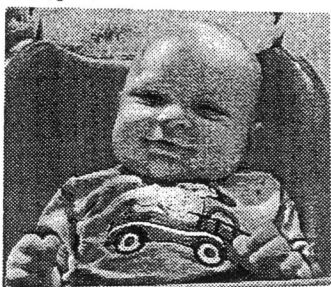

### Municipal Utilities

The council reviewed the sanitary sewer maintenance policy. The mayor inquired whether or not a policy should include the removal of said number of septic tanks per year regarding the municipal utilities for the city. The Public Utilities Supervisor did not however feel that this was necessary. The mayor was of the opinion that the gray water system was a problem. The number of septic tanks was discussed. Motion was made and carried to add the removal of a minimum of ten septic tanks per year and approve the sanitary sewer maintenance policy as amended. Motion was made and carried adopting the resolution establishing limited sewer back up clean up and property damage protection for the municipal utility customers.

### Overlook Park

The Park and Recreation Board conducted an on-site visit to Overlook Park prior to their meeting. They continued discussion regarding the layout of the trail; where it would begin and end. The types of signage that would be the best was talked about. The Park and Recreation Board will wait to see what the developers address in their final plan proposal.

### Park and Recreation

#### Board Goals

The Park and Recreation Board talked about the need for creating an Organizational Plan to accommodate the growth of parks and ball fields with anticipated additional developments within the city. Suggestion was submitted to form a committee to study these issues. This study should include, but not limited to summer ball programs, and plans for affordable maintenance programs. The thoughts of this study would be designed to oversee programs, and to meet the needs of the youth in the city. Suggestion was made to invite representatives from the Carver Youth Baseball/Softball Youth Association to the meeting.

#### Historical Plaques

The Heritage Preservation Commission approved a list of ten locations in the city to include placing historical plaques. These locations include the Hebeisen Hardware and Implement Store, the Old Fire Hall, St Nicholas Church and Rectory, Carousel Rose (Poppitz-Buetow Home), Christian Bristle House, Trinity Lutheran Church, Swedish Lutheran Church, Old Carver School and the Water Tower. Congratulations. Don't know where they are? Contact your Heritage Preservation Commission members and ask them. They would be happy to share the history with you.

### Open Construction Site

The council again reviewed the open construction site first addressed in the fall of 2003. Progress has been very slow and completion is still not in sight. The neighbors requested the council to condemn the site or draft an agreement that completion would be done by the end of 2004. Many are of the opinion that one person cannot comply with such an agreement. Question was approached to set up an escrow account to cover completion costs in the event the agreement could not be met. The homeowner's goal was to complete it himself. The homeowner was of the opinion that the exterior could be done in six months. One problem encountered was the lack of understanding codes. The homeowner insisted that they could complete the exterior, backfill and landscaping within six months. This project has been ongoing for two years. The property owner was asked if he understood his neighbors exasperation. The Homeowner's Association does not have many options and have forwarded a letter requesting completion by year end. Motion was made and carried to have the attorney draft an agreement for council review of condemnation process or completion of the exterior of the home by year's end. The Homeowner's Association requested clarification that the structure would be completed per the original plans. The building inspector will follow through with this project and oversee it closely.

## Open Space

The City Planner reviewed the issue of open space, which can be created in a community. The draft she presented addressed some guidelines for Open Space required in Preliminary Residential Development [PRD] districts. This draft was to sidestep the cumbersome process or necessity for the Comprehensive Plan Amendment prior to adoption. An amendment is the first step for finer definitions in city codes. The Park and Recreation Board requested the opportunity to include their input into new development planning. The city planner explained that this is not always feasible due to time frames. Suggestion was submitted to have joint meetings with the Planning Commission and the Park and Recreation Boards.

The Planning Commission and the Park and Recreation Board conducted a joint meeting. The 'Open Space' issue was one item discussed. Question was asked how the open space issue would effect the park dedication requirements. An explanation was given that the "open space" was over and above park dedication requirements.

Suggestion was submitted that in the future, a joint meeting of the two groups be held for a preliminary plat public hearing. This would allow recommendations from both organizations to be heard by the council.

The council reviewed the amended drafted Open Space Ordinance. The city planner recommended adoption of the ordinance. Motion was made and carried adopting the ordinance amending the section of the ordinance referring to Open Space in the Planned Residential Districts.

## Fencing

The Heritage Preservation Commission requested a six foot high fence instead of the proposed eight foot high fence at Lisa's Place for the outdoor patio area. The commission also preferred an open fence, which was more historically appropriate. Question was asked about drinks being passed through an open fence. There was discussion of outside drinking and police department presence. The proposed fence was not historically aesthetic. The council viewed a vinyl fence that was also available in black and also talked about the costs of a lattice wood fence. The council made a motion approving the resolution reflecting that the fence would be a six foot gothic black vinyl, wrought iron in appearance in the front and back.

## Bluff Ordinance

The city planner reported to the council that the staff has been researching options pertaining to the bluff ordinance. Shortly recommendations should be completed for the council. Two volunteers were needed to help with this process. Motion was made and carried assigning council members Monroe and Webb to assist with the final recommendation development of the bluff ordinance.

## Forner Lane Utility Improvements

The council was reminded by the engineer that MN DOT would be eliminating the access of Bade Lane and constructing a new access at Forner Lane sometime between 2005 and 2007. Presently there are not any municipal utilities in this area. A Feasibility Study for utilities had been authorized by the council. The property owner in this location reviewed this issue and presently prefers not to proceed with the project until MN DOT is scheduled to do the road work.

## Old Public Works Building

The council discussed the old Public Works building. The staff was directed to post the building 'For Sale'. Then the council discussed the zoning of the property. The city planner recommended initiating rezoning to allow expansion for permitted uses of the structure. Property owner adjacent is interested in bidding on the structure. Possible uses were talked about if rezoning were to occur. Motion was made and carried initiating zoning ordinance amendment proposing to rezone the old Public Works facility building and to schedule a Public Hearing with the Planning Commission.

## Tollefson Development

A Tollefson Development representative reviewed with the council their progress with the Dahlgren Township proposal and other developments they have done, as well as their plans for the future in Carver. Question was asked about acreage involved at the present time pertaining to the proposal. The present proposal includes 830 acres. Reminder was made that the city's Comprehensive Plan requires updating prior to any considerations by the city. This proposal exceeds the capacity of the waste water treatment facility and the water system. Tollefson Development is researching this need. The City Planner stated that the city is planning for upgrades that will be necessary for the project to become a reality. The representative listed several builders associated with their developing team. Tollefson's goal is to create a unique and positive image in Carver with development to begin in 2006.

## Moratorium Ordinance

The city planner recommended to the council to adopt an extension to the Interim Ordinance labeled the Moratorium Ordinance. This ordinance was adopted in August of 2003 unless an extension is approved. The moratorium could be extended for eighteen months but the recommendation submitted was to extend it for twelve months. The city attorney encouraged adoption of the ordinance. Motion was made and carried adopting the Moratorium Ordinance extension.

## Pianist

## Comprehensive Plan

Dahlgren Township Board representatives attended the council meeting to discuss the Comprehensive Plan study area. The city planner told the council that the Comprehensive Plan Work Group had met and had discussed the initial area of study for the Comprehensive Plan. This did not necessarily mean that it would be the same area as what would ultimately be adopted into the city's Comprehensive Plan. The allowance of a large study area gave the city flexibility throughout the planning process.

The city planner also explained to the council that several San Francisco Township property owners had approached her regarding property in this township. Request was presented to include the property in the Comprehensive Plan and the Alternative Urban Area Review. Two maps were presented to the city to give direction on the area for the plan. The first map included the greatest extent of land discussed by the work group and the second map included the property requested to be inclusive in the study area, along with surrounding lands which would square off the planning area. The planner recommended acceptance of the second plan because the final plan could always be scaled back from the study area. Also, if the second plan were to be accepted, the suggestion was also submitted to invite the San Francisco Township to appoint a representative to the Comprehensive Plan Work Group.

Council member questioned the number of acres involved in the first plan. The city planner was no longer certain of exactly how many acres were now involved. The council member further stated the understanding of studying the area for the Comprehensive Plan, but not why so much at this time when the city was responsible for the cost of the study. Asking why not a smaller area? The city planner explained that it was being done to help determine municipal utility needs. The council member commented at the amazement of now studying an area six or seven times larger than the existing city. Motion was made and carried selecting the second area presented inclusive of San Francisco Township's input. Council member stated that the city should see a lot of urban reserve land in the Comprehensive Plan for this area. The city planner was directed to contact the San Francisco Township to schedule a meeting to talk about this issue.

## Alternative Urban Area Review

The city planner reported to the council prior to starting the Alternative Urban Area Review for the Tollefson Development proposal, a decision would be necessary regarding the possible expansion of the Alternative Urban Area Review area. There has been additional land in Dahlgren Township and San Francisco Township. Motion was made and carried updating the Alternative Urban Area Review with the proposed parcels and to contact both Dahlgren and San Francisco Township residents so that if interest in being included is available by contacting in writing the two respective boards.

## Amphitheater

The Conditional Use Permit request for the operation of a amphitheater in Scott County has been denied. The final decision was the result of the issue of traffic. The proposal of the amphitheater would seat approximately nineteen thousand people and had been proposed to be built on the one hundred twelve acres adjacent to Highway #169 near County Road #14 in Scott County. The main area impacted by this proposal was Louisville and Sand Creek townships, Jordan and Carver, then reverberating further away involving surrounding communities within the proximity. The entertainment company has been attempting to gain success to construct their vision for more than five years. Seeking an appeal to the denial has not been confirmed.

## Did You Know. . .

...that Carver resident Olof Hanson built the Church-By-The-River (1913), the Neunsinger Hotel (1897, on the site of present day Carver City Hall), repaired storm damage to the Carver County Court House (1895), and probably was responsible for many of the 1890's Eastlake and Victorian embellishments installed on Carver's 19<sup>th</sup> Century homes. In 1900 the Chaska Weekly Valley Herald called him the foremost building contractor in Carver County. Hanson's 1882 house yet stands on Carver's Main Street West.

...that in the 1890's the Carver Gun Club held regular shoots on Monday's at Nimrod Park (probably the site of today's RiverSide Park). The gun club held an annual Thanksgiving Dinner complete with entertainment events.

...that many of Carver's early town settler also owned land and farms outside of Carver.

The Red Hat Society began in the USA, as a result of a few women deciding to.... The Red Hat Society is changing the way we view getting older and women over the age of 50 want to be a part of it. The Red Hatters go to tea, sail the high seas, join parades and go on motorcycle rides. It's been six years since the first group of women met for tea in red hats and purple outfits. Women have said that adding the Red Hat Society membership to their lives has been like finding an oasis in the desert of life and that the quality of sisterhood developed is amazing. In addition to the US chapters, the Red Hat Society has stretched and is now becoming popular in Canada, Europe and Australia strengthening the international contingency.

### The Red Hat Society Statement of Purpose:

"The Red Hat Society began as a result of a few women deciding to greet middle age with verve, humor and elan. We believe silliness is the comedy relief of life and since we are all in it together, we might as well join red-gloved hands and go for the gusto together. Underneath the frivolity, we share a bond of affection, forged by common life experiences and a genuine enthusiasm for wherever life takes us next."

"How the Red Hat Society all got started was while visiting a friend in Tucson several years ago, Sue Ellen impulsively bought a bright red fedora at a thrift shop, for no other reason than that it was cheap and, she thought, quite dashing. A year or two later she read the poem "Warning" by Jenny Joseph, which depicts an older woman in purple clothing with a red hat. Sue Ellen felt an immediate kinship with Ms Joseph. She decided that her birthday gift to her dear friend, Linda Murphy, would be a vintage red hat and a copy of the poem. She has always enjoyed whimsical decorating ideas, so she thought the hat would look nice hanging on a hook next to the framed poem. Linda got so much enjoyment out of the hat and the poem that Sue Ellen gave the same gift to another friend, then another and then another.

"One day it occurred to these friends that they were becoming a sort of "Red Hat Society" and that perhaps they should go out to tea... in full regalia. They decided they would find purple dresses, which didn't go with their red hats to complete the poem's image. The tea was a smashing success.

"Soon each of them thought of another woman or two she wanted to include, and they bought more red hats. Their group swelled to eighteen, and they began to encourage other interested people to start their own chapters. (18 women don't fit well around a tea table). One of their members passed along the idea to a friend of hers in Florida, and their first "sibling" group was born.

"Sue Ellen's fondest hope is that these societies will proliferate far and wide. We have now held two successful Red Hat Society conventions - entire hotels filled with women of a certain age wearing red hats and purple outfits!"

## Did you Know. ...

... that Captain Herman Muelberg (born 1833) of Carver was appointed Adjutant General of the State of Minnesota in 1893. He was also editor of the "Carver Free Press", a local newspaper. One of the rental properties he owned yet stands on Carver's Third Street East.

...that in the 1890's the Basler House Hotel in Carver advertised a "good hotel and stable accommodation" as well as a "choice stock of wines, liquors and cigars". The hotel was founded by Carver resident, Charles Basler, who dies in 1872, and was a long narrow building located on the northwest corner of Main and Broadway, next door on the south side of present day Lisa's Place.

# Scott Carver Threshers 41<sup>st</sup> Annual Old-Time Harvest Steam and Gas Engine Festival

Oh how lil' Joey was looking forward to going to Grandpa's house next weekend. He was just busting at the seams to get to Jordan that each day at bed time he would pull out his small blackboard and chalk and cross off still another day. One more day closer to being able to climb up aboard that great big steam engine that was fifty thousand times bigger than the four foot ten year old. Grandma would smile broadly as she would watch her grandson bolt down the long driveway in his bib jeans with his lunch and extra clothes stuffed in his makeshift luggage busting out of the seams of the worn blanket tied to the end of the short stick. She'd never seen a child work so hard to keep up with his grandfather who owned the only steam engine around to run the threshing machine on their Threshing Ring. Joey was in charge of watching for the wagon team to return. He would pitch bundles sometimes but it was an awfully big job for such a little feller. Each year Joey would push harder and harder and each year he would last longer and pitch more bundles than the year before. Grandpa would smile ever so proudly at him that he just knew he could pitch more bundles until Grandpa would say, "Joey, come here, I need you to watch for that team, it's time".

Then they'd have the most scrumptious supper Joey could ever have imagined. It never occurred to him that it was so good to him because he had worked so hard that he was hungry. Then they'd sit and relax and listen to the music. Joey would always fall asleep on Grandma's lap and Grandma would tuck him in for the night in the log cabin where he could still hear the faint playing of the guitars, banjos and fiddlers to dream again about going out in the field with Grandpa.

Did you know that you can still get a glimpse into that lifestyle somewhat at the threshing show in Jordan? You can watch them thresh, plow, saw logs, run the shingle mill, operate the lath and so much more. It really is a little like stepping back in history. Why don't you stop out and check it out? The show dates are Friday the 5<sup>th</sup>, Saturday the 6<sup>th</sup> and Sunday, August 7<sup>th</sup>. The gates are open 7AM. The events and demonstrations run all day, each day. 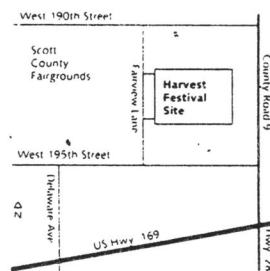
