US Fish & Wildlife Contract

The Park and Recreation Board reviewed a copy of the "Cooperative and License Agreement between the United States Fish and Wildlife Service Department of the Interior and the City of Carver". This contract expires in December of 2004. The board was encouraged to present recommendations in consideration of future projects.

Liquor License

The council meet with bar owners to talk about an increase in the liquor license. The licenses have not been reviewed since 1998. The council was told that the council must discuss this issue with owners prior to action to increase the fee. The criteria for justifying fee increase was questioned. The administrator summarized background information. For the first time in six years an increase was recommended.

..... that as early as August, 1858 there was already a Swedish settlement established in Carver.

Fire Department

The Fire Chief reported to the council that he had received notification from the Fish and Wildlife Service that the Fire Department had received a matching grant in the amount of \$1000.

The Fire also requested of the council that the department be authorized to get quotes to replace the pumper tanker. Suggestion was made that the city do a lease-purchase on the truck. The council asked questions regarding the specifications. Motion was made and carried with all ayes authorizing the Fire Department to obtain bids for a new pumper tanker per specifications presented.

The council and the Fire Chief also discussed increasing the members of the department. Presently the department is allowed a maximum of thirty members set by the city council. The Fire Chief requested the number be increased to thirty-four firemen. One council member was of the opinion that there should be a formula to determine the number of firemen needed based on the population and the size of the area serviced. The mayor agreed that a formula would be worthwhile. Therefore the council and the chief made the decision to pursue this further and discuss this issue again in the near future.

Emergency Management

The council inquired to the status of the county's decision as to what to do about the Emergency Management. The Fire Chief reported that to his knowledge the decision had been made to probably not discontinue the functionality of this department at this time. Council member asked if the residents had notified the county that their desire was to have this department remain at the county level. The council was told that the county is cutting some departments and the Sheriff's Department would be responsible for undertaking some of the duties cut, however the Emergency Services Program in Carver County is used as a model in other counties.

Police Contract

The council discussed the contract for Policing Services. Motion was made and carried with all ayes approving the contract for Police Services for 2005 with Carver County. Question was asked what the costs would be to start their own police department in the city and if anyone had done any research on this topic. Council member was interested in exactly what start up costs would be for informational purposes. The mayor pointed out some areas of problems with having your own department. Motion was made and carried with all ayes adopting the resolution to contract for police services for 2004 agreement with the Carver County Sheriff's office.

Did You Know....

...that the Minnesota River Valley, a portion upon which Carver is situated, presently varies between one and five miles in width and from 75 to 200 feet in depth, testifying to the enormous volume of glacial melt water that once flowed through it.

Park and Recreation Board

The council was told that the Park and Recreation Board had purchased a caboose and it would be arriving in Carver soon. The caboose will be placed in Depot Park and now the board is looking for an engine also. The Park and Recreation Board members were thanked for their time and efforts on this project. The council was also told that this particular caboose when in operation had traveled through Carver. [Pardon the cliché, "Welcome Home"] Good Job Guys!!!

Be sure to read the article in the City of Carver's newsletter about the acquisition of the caboose.

Comprehensive Plan Committee

The council was informed that the Tollefson Development representatives would be in attendance of the Comprehensive Plan Committee Meeting.

Tollefson Development gave a presentation to the Comprehensive Plan Committee pertaining to plans utilized in other projects they have completed. The group was also told that work for the plans for the development are to be started in the near future, as well as the Alternate Urban Area Review. There were some items that were brought to the developer's attention at this meeting to be addressed and they included attaching open spaces to the larger areas that are not build able, the need to create senior and low income housing, low income homes to coincide with employment in commercial/industrial areas and public safety needed to be incorporated into the plan.

Did You Know....

...that on 15 May 1863 Liberty Township was created from parts of Carver and Chaska. A week later Liberty Township was renamed Dahlgren Township in honor of S Rear Admiral John Dahlgren (1809-1870), a Civil War Hero of Swedish descent like many of Dahlgren's early citizens.

Chaska/Carver Cooperative Recreational Agreement

The Park and Recreation Board met discussing the determination of annual fee renewal procedures for the Chaska/Carver Cooperative Agreement. Suggestion was submitted that each year the agreement be reevaluated and renegotiated as necessary. Suggestion was also made to include the City Administrator for financial assistance relating to the agreement for families enduring financial hardships. The board was also insistent that these issues be addressed prior to any formal motions being made, as well as scheduling a meeting with the administrator to talk about feasibility and procedures.

The Board was also told that a board member prepared an "Athletics and Activity Survey" would be introduced on the city's web site, along with being included with the city's newsletters for December for the purpose of obtaining opinions and suggestions from residents.

The administrator informed the council that the Park and Recreation Board recommended approval of the recreational agreement contingent upon language clarifications. Some of Park and Recreation Board members met with the City of Chaska's representative, Tom Redman regarding the agreement. Motion was made and carried with all ayes approving the joint agreement between the two cities.

So that it's perfectly clear to Carver residents what this recreational agreement means. A partnership has been created between the Cities of Chaska and Carver concerning the Chaska Community Center. With this agreement, Carver residents pay the same low rates as Chaska residents at the community center and recreational programs sponsored by the Chaska Park and Recreation Department. Additionally, the Chaska Par 30 golf course for the 2005 golf season will pay the same resident rates as Chaska residents.

Municipal Utilities

The council was reminded that the generator for the wastewater plant was in disrepair. Problems keep occurring despite repairs. The Utilities Superintendent has received quotes for a new unit. The low quote received was from the same company as the present generator is from. The other quote was only slightly more and preferred going with this model. Due to problems with the generator no one was willing to invest in the same type of generator. Motion was made and carried approving the purchase of the Ziegler Cat generator.

The council discussed changes to the fees resolution concerning the municipal utilities. One council member opposed any fee increases. Another council member requested that the percentage increase in the utilities be that as per the financial consultants recommendations. The city attorney requested an extension of time for the fees resolution in order that he and the city planner could present the information since there had been changes in how the determinations are made.

Candidate Committee

There was a large number of citizens attending the council meeting to express their concerns regarding a flyer distributed throughout the community that many residents found disturbing. One citizen was concerned finding it in his mailbox. Question was asked about the authenticity of a "Know Your Candidate Committee of Carver". Due to the contents of the flyer there were also legal concerns and the county attorney would have to be contacted. Another citizen stated witnessing an alleged city official. The legality of this action was also questioned. The mayor pointed out that these questions would have to be directed to the County Attorney or the Secretary of State. Question was asked if witness saw an employee or an elected official. Response was an elected official. One council member was asked about his awareness of the flyer. His response was that he was unaware of it. Another council member was asked about supplying the information. The response was "No, but the information is public information." Concern about how the information was obtained was expressed. More information would be necessary to determine whether or not a protest could be filed with the Office of Administrative Policy. Another resident stated that the county attorney had been contacted and a complaint would be filed regarding violating postal laws and furthermore was embarrassed by the conduct of the city council in the past. Another resident voiced inquiry regarding impeachment processes for removal of a city official. Another resident voiced their embarrassment over the incident stating further that the voters entrusted the care of the city into the council requesting that personal agendas be put aside to perform the duties elected to do so. The mayor thanked the residents for their input stating that it was his hope that a similar type of incident would not be repeated in the future.

Ordinances

The City Planner reported to the council that recently the issue of accessory structures on properties had been brought to the attention of the building official and the city planner that the Zoning Ordinance does not have any provisions restricting either the size or number of accessory structures allowed to be built on properties. The council was presented with a proposed ordinance amendment including a maximum of two accessory structures for a total of 800 square feet. The Planning Commission held a Public Hearing on this issue and presented their recommendation of approval to the changes in the Zoning Ordinance. Motion was made and carried with four ayes and one nay adopting the ordinance amending sections relating to the accessory structures.

The City Planner also told the council about changes necessary to an Ordinance regarding utilities that would allow the city to compel the underground placement of utilities when deemed necessary. Again the Planning Commission held a Public Hearing and recommended approval subject to the city attorney's reviewal. There was discussion regarding timing of burial of overhead lines during development. Motion was made and carried with four ayes and one nay adopting the Ordinance amending the section relating to underground utilities.

Bonds

The council listened to presentation regarding necessary criteria to determine amounts of bond issue from the financial consultant's representative from Ehlers and Associates. Motions were made and carried with all ayes adopting the resolutions providing for the sale of General Obligation Water Revenue Bonds and Improvement Bonds. Motion was made and carried with all ayes scheduling a special meeting for the purpose of considering sealed proposals for and awarding the sale of bonds.

The council reviewed the issue of General Obligation Improvement Bonds with the financial consultants. Three bids were received and the council reviewed them. Motion was made and carried with all ayes adopting the resolution providing for the issuance and sale of General Obligation Improvement Bonds pledging special assessments for the security and levying a tax for payment of bonds. Then the council reviewed the General Obligation Water Revenue Bonds. Four bids were received for this issue. Motion was made and carried with all ayes adopting the resolution providing for the issuance of General Obligation Water Revenue Bonds and pledging for the security net revenues.

Alternate Urban Area Review

The council reviewed the Alternate Urban Area Review Cost Reimbursement and Security Agreement with Tollefson Development. The city attorney reported to the council that the staff had been negotiating and agreement with Tollefson whereupon the developer would be obligated to pay the third party consulting fees and expenses that the city were to incur in preparation of the Alternate Urban Area Review for property determined in the Dahlgren Township area. Also the terms and conditions that Tollefson Development would make payments to the city to reimburse for a pro rata portion of the third party consultant fees and expenses incurred by the city regarding the Comprehensive Plan. The developer, it was stated had been reasonable in the process. There was further discussion concerning the defined area of the agreement. The Tollefson representative stated that it was their opinion that the agreement was fair. Motion was made and carried with all ayes to enter into the Cost Reimbursement and Security Agreement with Tollefson Development.

Building Permit

The attorney talked with the council regarding the agreement with property owner for construction of a single family resident to complete the dwelling in an orderly and efficient manner. Report was given that trusses ordered had failed to be delivered in time to meet with the third timeline for deadline of the agreement. Progress had been made in construction and the first two deadlines had been met. The attorney recommended adjustment of deadlines. Motion was made and carried with all ayes extending the contract for completion of construction. Request was made to notify neighbors in the schedule changes.

Did You Know...

...that prior to 1850 no serious attempt was made to navigate up the Minnesota River by steamboat beyond Mendota & Fort Snelling as it was then believed not navigable.

Dahlgren Township

The Dahlgren Township Board reviewed the issue regarding consent for the Heritage Development. The board signed the contract for the Heritage Development allowing the developers to have the City of Carver act as the Responsible Governmental Unit to conduct an environmental review for the property located in the township. The agreement also stated that the township shall not have any financial responsibility or obligation regarding preparation for the Alternate Urban Area Review.

The consent form involving another development request was denied since a parcel been included where the township was unclear of the owner's intent to be included in the study. The township requests written notification to be included in the Alternate Urban Area Review study prior to signing contracts. The same application applied to another request for more parcels where residents requests to be included had not been forwarded at that point.

Carver's Caboose

By now, almost everyone has seen the caboose upon entrance into the city. A lot of research, time, effort and love of trains has gone into this project and all of the people involved should be congratulated, as well as thanked. And just think when the restoration is completed, how much more time, effort, blood, sweat and tears will have been poured in to the project. And every waking moment well worth the end result. I found the markings neat and hope that they keep the writing on the sides when they refurbish it....CNW for Chicago North Western. The 'pulling together' seems appropriate as a logo for the city. The residents do always pull together. When I saw the date on the caboose, I had to come home to see if that date correlated with the founding of Carver only to find no correlating important dates tying this date of '1844' on the caboose. Only that possibly it was passing through the region before the Carver Village was incorporated on February 17, in 1877 per Lucie's "The Carver Story". Upon further research of Lucie's book shows the tracks in place as early as 1855 with a photo of the mill and notation of bonds issued at a special meeting to aid the railroad in 1870. So when exactly did the railroad lay track in the steamboat river community. This also would tie in with the RiverBoat Captain research to be done. None the less, thanks to the work and efforts of the Park and Recreation Board members; there is a piece of history now smack dab in the city. Thanks guys!

Disclaimer

The 'unapproved' minutes of the council and the township meetings have been referenced for the purposes of reporting news in the "Villager Tower" and creating the contents of this newsletter for the purpose of informing residents in the City of Carver and the townships surrounding the city.

Did You Know....

.....that near the railroad track and the Carver Water Tower in the 1890's there was a large beer facility that included a warehouse, ice house, stable, shed and office.

.....that Carver resident Olof Hanson built the Church-By-River (1913), the Neunsinger Hotel (on the site of the present day Carver City Hall), repaired storm damage to the Carver County Court House (1895), and probably was responsible for many of the 1890's East Lake Victorian embellishments installed on Carver's 19th century homes. Hanson's house yet stand on Carver's Main Street West.

...that many of Carver's early town settler's also owned land and farms outside of Carver.
