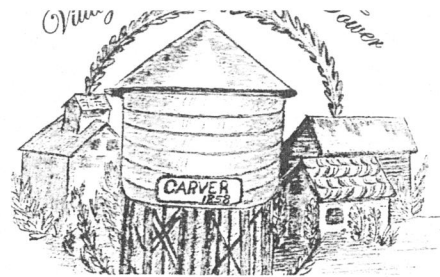


In Loving Memory of Ellie Thiemert and Becky Bade



Death, grieving, the healing process and then moving forward. What does this really mean? We tell someone that they have our sympathies. That we are there if they need us. How many of us really understand or even identify with the pain these loved ones are enduring? Do we really identify with their internal agony? Do we really, truly understand their daily struggle each day to keep putting one foot in front of the other, and to keep going on without their loved one? Every day people die. Some we know, some are total strangers, some we identify with, some family, and some are friends. But what about the sons, daughters, grandchildren,

brothers, sisters, fathers, mothers and spouses. etc. Their pain, their loss, their own personal pain is theirs to bear, some feel truly all alone. No matter what day it is; it is a deep loss of such magnitude to that individual that it is almost un-imaginable to anyone who has not experienced the same emotions. Each day is so precious and we tend to take that for granted. When you really analyze the initial thought processes, you will be able to decipher that yes, December is Christmastime. January is New Year's. February holds Valentine's Day. March and April claim Easter & spring. May is Mother's Day and Memorial Day. June is the beginning of summer and Father's Day. July possesses Independence Day. August is the end of summer. September hails Labor Day. October claims Halloween and November is Thanksgiving. There we are full circle. So no matter when we lose someone in this lifetime, it affects the person closest to him or her and makes a huge hole in their life with the reminder of that time of year, no matter when it happened or around what holiday. Each and every day is precious with someone's special memory attached to that particular day. An anniversary, a birthday, a first date, a first kiss, a birth, another death, religious day or just the sun was bright and the smell of lilacs rushes over your senses triggering memories of a special person. Deep inside the anger of their loss thunders in their ears like the thunder in a violent thunderstorm. A familiar aroma will trigger another wave of overwhelming guilt and tears flow even heavier. The touch of some familiar object will activate the sense of helplessness like lightning blazing through the sky only all these emotions are occurring deep within their subconscious. These are the days that are their worst. Some succumb, some gain control, some re-press and some become numb over time. These are only a few of the emotions on this rollercoaster ride called life in the reality of mortals. The only finality of truth being, "Better to have loved and lost than to have never loved at all." Amen.

New County Attorney

The council was introduced to the new appointed Carver County Attorney, Jim Keeler. This was a personal goal to visit the cities throughout the County. Mr. Keeler had been Assistant Carver County Attorney previously prior to transferring to Hennepin County. The council was told that he felt that being appointed as the Carver County Attorney was like coming home.

Christy's Bluff

The city planner reminded the council of the MN Statutes deadline requiring action. The staff met with the developer discussing plan changes, trails and sidewalk options. The developer would be submitting an open space and trail option exhibit to the council. The plans had been updated to reflect changes with ponding, bluff protection and trails/sidewalk issues. Motion was made and carried with all ayes adopting the resolution approving rezoning for the Christy's Bluff Development. Motion was made and carried with all ayes adopting the resolution approving the preliminary plat for single family lots and right-of-way for Christy's Bluff development.

Everist LG Inc

Representatives from Everist LG Inc attended the Dahlgren Township Board meeting regarding a request for a storage facility in the township to stock pile aggregate. They explained their proposal, the hours of operation and transportation route. A variance and a Conditional Use Permit will be required. The business operation would be considered a wholesale operation for commercial use. There is opposition to the proposal. Mn DOT has not been contacted as of yet regarding access onto the highway. The township did not take any action.

The Dahlgren Township Board was presented with a proposal for a Fall Festival on township property similar to the festivities held at Canterbury Park in the fall. A Conditional Use Permit would be required from the county to conduct this proposal. Plans are to have a straw maze, corn maze, haunted house, tent for exotic animals and other tents for other exhibits. The county will be the decision make whether or not it can be held in the township or not.

Miscellaneous

A resident attended the township meeting to request that the board keep the town rural township of Dahlgren. Requested that allowing the city to continue annexing township land be stopped.

Citizens attended the township meeting requesting information regarding proposal for the construction of a new town hall. Preliminary plans are in place, but not set in stone. A site plan is not in place yet, but a building plan has been drawn up to look at. Resident voiced opposition to construction due to proposed development in the township.

The council was given a letter concerning the county road jurisdiction of #40. When the city reaches a population of five thousand that the city intends to apply for Municipal State Aid status. Upon achievement of Municipal State Aid status, then the city would take on jurisdiction of County Road #40, Highway #212 and County Road #11 within the city limits.

Incomplete Construction

Homeowners sought city aid with property in the Carver Bluffs development that is incomplete. The building permit had been revoked because there has not been any work being done. Council was asked if the property could be condemned or how completion could be encouraged to be done. The building official pointed out that since the exterior is not completed; a certificate of occupancy could not be issued. Question was asked if the Homeowner's Association rules could not be utilized to ensure completion. The city attorney was asked for resolutions. The attorney's options cited the hazardous building code, however, this may not work since the structure is closed and secure. Condemnation would be very costly and the laws have changed significantly. Resident pointed out that this construction has been in the works for twenty nine years. Most of the exterior looks good, but there also is the concern of mold and moisture in the basement. The question at hand was whether or not the city had the right to condemn the property. Repair of another home from fire damage has been ongoing for four years, so relating to this concern was not isolated. The situation is frustrating for all concerned. The attorney explained that the city would have to proceed to identify all buildings requiring work and prioritizing and then proceed in an orderly fashion ensuring completion, which would be far fetched in the long run if you examined it completely. Suggestion was submitted to forward a letter to the homeowner expressing concern. Motion was made and carried to draft a certified letter encouraging the owner to continue efforts to complete construction on said property. The residents were encouraged to contact the Homeowners Association regarding the issue. The city attorney further stated that the estimated cost for condemnation would cost approximately hundred of thousands of dollars and then the public purpose for use of the land would be required to be identified.

Streetscape Committee

The council was updated on the Streetscape Committee reviews. The proposal for cost of burying the power lines in the downtown area had been received from Xcel Energy and the committee reviewed the \$215,023 cost. The engineer pointed out some proposal items relating to this project. Each residential customer with overhead service would be required to rewire to underground for an average cost of fifteen hundred per service and an electrician would be required to be contracted. Commercial properties with overhead power lines would not be buried.

Bridge Options

The Heritage Preservation Commission recommendations were reviewed by the council for the two bridges, Main Street and Spring Creek crossings. The culvert type would have a textured headwall stained to resemble the historic appearance of the existing bridge. Verbal indications for design had been given by the county. An agreement would still be necessary. The engineer pointed out that the state bridge bonds would cover a percentage of the costs and the county would be responsible for the balance. However, the aesthetic treatments on the side of the bridge or the decorative railing are not included in that payment for certain. Discussions with the Army Corp, the engineer stated that removable floodwalls may need to be incorporated into a later certified levee projects due to costs.

Did You Know...

....that the Carver and Waconia Road was first surveyed for a county road the day after Christmas, 1865 by Carver County Surveyor Capt. Herman Muehlberg (born 1833), who had just returned from service in Company E of the Minnesota Fifth Regiment in the Civil War. Muehlberg lived in Carver and went on to own and publish the *Carver Free Press* newspaper from 1884-1897 and to serve as Adjutant General of the State of Minnesota from 1893-99.

Planning Commission

The Planning Commission members reviewed concept plan for the Woodland Hills development proposal. The City Planner informed the m that the engineer was to update the council on the placement of collector roads in the area. Did You Know...

....that December 26, 1865 saw the completion of a county-commissioned survey of the crude old road and trail northbound out of downtown Carver along Spring Creek to Waconia. A petition of Charles Gebhard and others calling for an improved Carver and Waconia Road had just been approved by the Carver County Board.

2007 Carver Heritage Preservation Award

The Joseph and Debra Kelzer Family are recipients of the 2007 Carver Heritage Preservation Award for their restoration of the 19th Century Andrew G. Anderson House on Main Street in Carver. The award is given annually for the year's best preservation work in the Carver Historic District, which is listed on the National Register of Historic Places.

During October and November nominations were solicited from Carver citizens. At the November meeting of the Carver Heritage Preservation Commission the 2007 nominations were reviewed, and from them the commission selected the year's best preservation work or contribution to the Carver Historic District. The restoration took place during 2006 and 2007, with work done as a family project involving Joe and Deb Kelzer, their daughter and son-in-law, Kim and Bill Breen, and their son and daughter-in-law Jason and Becky Kelzer.


The Andrew G. Anderson House at 208 Main Street was built about 1870 and was owned by Civil War veteran A.G. Anderson, a Swedish immigrant, who in 1855 came to the fledgling Minnesota River town of Carver by oxcart. When the Civil War broke out Anderson enlisted in Company H of the Ninth Minnesota Infantry Regiment and was present at many battles. On June 11, 1864 he was captured by the Confederates at Guntown, Mississippi and taken to the infamous Andersonville Prison of the Confederacy in Georgia, which

saw 13,000 of 45,000 Union prisoners die of disease, malnutrition, exposure, and overcrowding. In a prisoner exchange Anderson was released and continued his Union military service until August 1865. On a military furlough he married Emma Demers, and after the war he returned to Carver and became a successful general store owner and businessman. Anderson served on the Carver town council and was elected to serve in the Minnesota State Senate in the 1880s and 1890s.

When the Kelzers acquired the house it was vacant, in foreclosure, and in bad need of repairs. The Kelzer family re-roofed the house, straightened the porch, matched missing porch railings, reproduced and replaced some of the missing gable decorations, renovated the entire inside, built a connecting garage to match the house, updated mechanicals, completely repainted house and garage, cleared debris and trees threatening the house, and touched virtually every surface of the house.

The Kelzer family was presented a plaque at 6:30 p.m. January 7, 2008 at the Carver City Council meeting. The Kelzers will also be given a traveling recognition sign that can be placed on their restored property for one year.

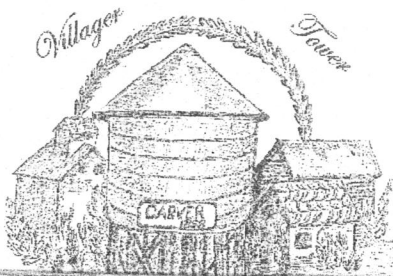

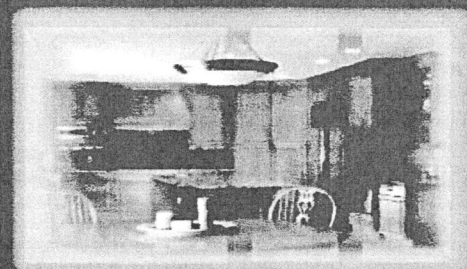
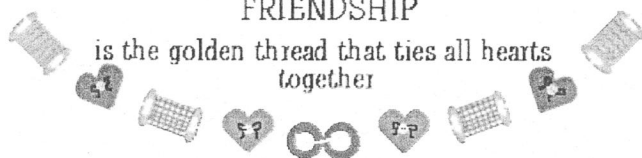
