



Municipal Utilities

The City of Carver Council held a special meeting to tour the completed facilities of the water tower, Well # 4 pumphouse and the water treatment plant.

No Parking Zone

Business owners requested a 'No Parking Zone' in front of their business due to experiencing problems with limited parking spaces for customers and owners. The 'No Parking' restrictions for 2 AM to 6 AM in the front of the business was requested. The attorney was of the opinion that this time schedule might work for this section of the street. The attorney suggested drafting an ordinance amendment for review and approval by the council. The council agreed to this suggestion. A drafted amendment is to be presented for review in the future.

Business owner was present at the council meeting to discuss concerns regarding the parking issues on Third Street East. The sheriff's deputy has been researching the issue and options for resolution. A driveway option was suggested. Special parking options would set a precedent and this option was not viable. Parking in Carver for businesses is an issue needing to be addressed. Parking issues possibly could be reviewed by the Planning Commission. The commission will be reviewing the Zoning Ordinance for updates and parking could be included in that discussion.

AT & T Site Lease

The city attorney stated that issues had been resolved with AT & T and discussions continue. AT & T representative stated that the attorneys would be willing to settle remaining issues. The city stated that space concerns were an issue. It was a council members opinion that consideration should be in the council's foresight regarding the future need for an additional fire station and/or public works building. AT & T expansion was questioned. The city's attorney stated that the entity may have the right to expand but would also be required to request an additional permit from the city to expand in the future. Motion was made and carried with all ayes approving the AT & T site lease subject to removal of wording in a specific paragraph.

AT&T requested to site a wireless telecommunication facility on the public works/fire station property. The area chosen is located behind the fire station and currently used for exterior storage. The property currently is zoned as Agricultural. In order to install a wireless communication facility, it would be necessary to rezone to Public/Institutional and require a Conditional Use Permit. The Planning Commission held a Public Hearing and the commission recommended approval of both the rezoning and the Conditional Use Permit. Motion was made and carried with all ayes adopting the resolution approving rezoning from agricultural to Public/Institutional for the Fire Station/Public Works Facility. Motion was made and carried with all ayes rezoning parts of the property to public/institutional. Motion was made and carried adopting the resolution approving a Conditional Use Permit for a Monopole Tower and associated support buildings for ATT/New Cingular Wireless PCS, LLC.

Park and Recreation

The mayor inquired about the Vehicle Fair and Corn Roast. The event would be hosting a corn roast this year.

The Park and Recreation Board supervisor was asked about the county's presentation on the 'Walkable Communities Workshop' and if the map of the city trails were available to city residents yet. The trail maps are available on the county's website, 'GOCARVERGO'. The maintenance of the website was asked about. It was going alright was the response.

Highway # 41

The City Planner attended the Highway # 41 meeting. The council questioned the status of project with the committee. More information has been requested regarding noise and other studies. The goal is to narrow exact locations for the placement of the right-of-way.

The council was given an update regarding the MNDOT Truck station meeting.

Union Pacific Railroad

Inquiry was made concerning the Union Pacific Railroad negotiations. The exclusive negotiation period ended in July and an agreement had not been reached with Union Pacific. The Joint Powers Authority and Union Pacific were extremely opposite with monetary issues. The property will be abandoned and returned to original landowners. The city will acquire some of the land. The mayor expressed concerns regarding the levee becoming part of the land returning to original landowners. This issue was being researched. Responsibility of the logjams was asked about. The Union Pacific retains ownership of the bridge and will be continued to be held responsible for maintenance.

DownTown Preservation Commercial Design

Guidelines

The City Planner reviewed with the council a CD of the DownTown Preservation Commercial Design Guidelines for the council's approval. The project was funded in part with a grant. The Heritage Preservation Commission has worked on this project since January. In July the commission recommended council approval. Motion was made and carried with all ayes accepting the DownTown Preservation Commercial Design Guidelines.

Sanitation License Renewal

The council reviewed the application for the four companies applying for the three sanitation licenses for the City of Carver. Two companies were represented at the meeting. Elite Waste Disposal discussed services with the council. Motion was made and carried with all ayes approving the sanitation licenses for the currently licensed sanitation firms in the city. Motion was made and carried accepting the proposal for sanitation collection in city owned areas.

Did You Know

John vonWalter

....that in August 1874 veteran ship builder Joshua P. Torrey was building a large-sized barge on the opposite side of the Minnesota River from Carver for Commodore Dinkle to use in transporting goods on the river. J. P. Torrey lived on Fourth Street East at Oak Street in Carver.

Dahlgren Township

The Dahlgren Township Board reviewed the revised content from the County Land Use Plan for the 2010 Carver County Comprehensive Plan concerning eligibility lots on properties within a tax zone. The Dahlgren Township Board approved the revised policy by motion.

Resident presented statements requesting support from the board supporting protection of the woods with the proposed rerouting of Jonathan Carver Parkway that would potentially affect ten acres of natural woodlands.

The board also declined passing a resolution favoring Fiber Optics Loop in Carver County.

The board reviewed the Dahlgren Township Policy Chapter from the 2030 Carver County Comprehensive Plan from the Carver County Land Management Office. Edits were requested. Notes were taken and those changes would be implemented into the policy. The board passed a motion with all ayes approving adopting the 2030 Comprehensive Plan with the proposed changes.

2010 Prosecution Agreement

The County Attorney, Jim Keeler, attended the council meeting with a presentation concerning the 2010 Prosecution Agreement. Cities have been contacted with the contracts for prosecution services with the Carver County Attorney's Office. The statutory obligations of the county dealing with adult felonies, select adult gross misdemeanors, juvenile delinquencies and civil matters on behalf of Carver County was explained. The council was told that beginning in 2010 violations of city ordinances will be prosecuted at no additional fee. There are ten cities participating in contracting with the county attorney's office for legal services. Chanhassen is the only city that does not. Contract costs for the City of Carver have increased slightly but the fines received from the county should cover the cost of this contract. Motion was made and carried with all ayes approving the 2010 Prosecution Contract with Carver County.

Alternate Urban Area Review

The City Planner explained the resolution involving the order for an Alternate Urban Area Review for the Carver Freeway Commercial Area. The planner explained that MN Rules require the city to adopt an order for the Alternate Urban Area Wide Review specifies the location and the type of development to be analyzed. The rules require that at least one scenario be consistent with the adopted Comprehensive Plan which in this case is the Carver County's plan under a "no annexation" scenario. An additional requirement involved at least one scenario that is consistent with known plans of developers. Motion was made and carried with all ayes adopting the resolution ordering an Alternate Urban Area Review for the Carver Freeway Commercial area.

Work Session

The council reviewed the 2010 proposed revenues at a special meeting/work session. They also reviewed proposed expenses. The city engineer addressed engineer fees. MnDOT is requiring the State Historic Preservation Office to staff an engineer with a background in historic bridges to check the 4th Street Bridge prior to its replacement. This requirement could cost the city additional money making it necessary to be added to the proposed budget. Concern was expressed regarding the extra cost.

The council was told by the Fire Chief that the Relief Association will be meeting the last Thursday of each month at 7 PM.

The Fire Chief also reviewed the Fire Department's proposed budget. The Compressor Filling Station is not working properly and is becoming dangerous to operate. The replacement costs were relayed to the council. The council was also told that the Rescue Truck requires replacement as well. The Administrator advised that other alternatives need to be looked at besides new purchases. Question was asked if there was used equipment available at a more affordable price.

The council discussed the need to review and tackle the Fire Department Capital Improvement project. Equipment is getting old and requires replacement. The department is to review alternatives and get back to the council. Question was asked about reallocating funds. An old Fire Department equipment fund possibly could be used.

Budget expenditures were reviewed at their second work session. Alternatives were presented to the council so that the department could purchase a compressor and an air tank filler station. Option # 2 involved grant funds from OSHA. Once the grant application is prepared and submitted, then there is a sixty day process by OSHA before the city would be told whether or not the funds were awarded. The current Self Contained Breathing Apparatus (SCBA) is twenty five years old. The authorization for submittal of a grant application was to be put on the September agenda.

The next discussion involved the presentation for options for purchasing a replacement rescue truck. These options included purchasing new or used, or bidding on a truck from the state's bidding site. This system worked well for the public works department but there were opinions that this system may not work as well for the Fire Department. The council discussed the age of the equipment, need to replace several trucks and the time schedule to afford replacement of the rescue truck. Suggestion was submitted to draft plans for a combination of old and new equipment. Replacement of the Self Contained Breathing Apparatus (SCBA) would add monies to the equipment budget for the Fire Department. The council agreed adding the amount but in the future larger items need to be discussed.

At the council meeting the council presented the motion, carried with all ayes authorizing submittal of the OSHA grant application for the Self Contained Breathing Apparatus (SCBA) system.

The council discussed building permit revenues at their second work session. There was concern that the building tax would not be carried past this year and that the estimates for building permit revenues might be high. The building inspector stated that one developer changed their strategy to draw more buyers into the development. The City Planner had projected a conservative estimate. There might be a possibility that activity could pick up during the upcoming year.

The council shared comments received from residents concerning the fact that newsletters are not being mailed out. The costs related to the newsletter without labor costs were reviewed by the council. Suggestion was submitted to mail the newsletters out quarterly to cut costs. Subscription sales of \$5 per year were also discussed as an alternative. Selling advertisements could also be an option. The council consensus was to reduce the budget line costs for the newsletter.

The council discussed scheduling the Strategic Planning work session on 19th of October. One of the items to be discussed would be Financial Management Plan and water rates. The consensus of the council that the Preliminary Budget was acceptable with the changes during their work sessions.

2009 Carver Heritage Preservation Award

The City of Carver and the Carver Heritage Preservation Commission are pleased to accept 2009 nominations for the third annual Carver Heritage Preservation Award, to go to the year's most outstanding historic preservation effort in the Carver Historic District. Last year the 2008 award went to the Gregg and Meg Witt for their restoration work on the Denny-Hammarlund commercial building at 208 Broadway, built about 1865.

The award will go to the owner(s) of properties who make the year's best effort at preserving or restoring the exterior of any store, house, barn, or structure located in the Carver Historic District. The award may also be given for historically sensitive enhancements to the Historic District, including additions, porches, outbuildings, or the infill of empty lots.

After nominations have been received in mid-November, the Carver Heritage Preservation Commission will view nominated properties and decide the annual award winner by a majority commission vote at the November HPC meeting. While the award is intended to be an annual one, there may be some years when no significant preservation effort took place, or when no property has been nominated.

The award, a plaque, will be presented by the Mayor of Carver in December at the annual Carver Holiday Party, or the first practical Carver City Council meeting thereafter. A temporary recognition sign may also be placed outside the annual award-winning property, but only if so desired by the owner.

Anyone can nominate a property for the 2009 award by using the following form and returning it to the Carver City Hall by Friday, November 13, 2009.






