


Dedicated In Memory and In Honor of "Bear" Tom Brueck

Carver County Community Development Authority

The council participated in a special meeting discussing with the Executive Director from the Carver County Community Development Authority the proposal from the organization involving property in foreclosure within the city limits. The council was informed of the authority's plans for the property since additional office space was necessary for the authority and the proposed plans are to build in the City of Carver. The proposed building would also include senior housing. The authority had in the past constructed multi-use building in other cities and statistically these sites also house a city hall, sheriff's department offices, library and the like. The meeting with the council was requested to query the interested in participating in the complex proposal. The city has been talking about building a new city hall.

Different aspects of the proposed project were discussed. Each council member had a different view while one did not like the site, another agreed with the proposal concept and the number one principle was that the city hall should be built downtown. However, an ideal site had not been found.

The authority requests upon the initiation of the project there would need to be a type of an agreement or Joint Powers Agreement with the city. Investigating costs was necessary. One Council member was interested in the library space, along with the city space, but would also like cost comparisons with previous options that the city has researched. The city planner and the city engineer would work with the Community Development Authority to obtain cost information. The mayor requested a special meeting to further discuss information gathered.

Truth in Taxation

The council held a Public Hearing for the Truth In Taxation. The council discussed the budget and the proposed property tax. One property owner inquired about his property where the homestead status had been removed. He was advised to speak with the county regarding this situation. Another citizen inquired about increases in taxes. Overall most comments that had been generated that the taxes had remained the same or even in some cases decreased. Property being questioned stated that the valuation had increased. If the owner disagreed, then they should contact the county with their dispute was the direction given to the owner. Motion was made and carried with all ayes adopting the resolution approving the 2010 final levy and the final budget for the City of Carver.

Municipal Utilities

The Municipal Utilities director discussed the proposed water and sewer budgets with the council. Question was asked about the costs for removal of septic tanks. The item was budgeted under black water conversion. The conversion is anticipated to be complete in approximately four years with a remainder of approximately ninety tanks remaining to be removed. Twenty seven tanks were removed this year. Motion was made and carried with all ayes approving the municipal utilities budgets for 2010.

Land Use Fees

The city planner informed the council that the Planning Commission held a Public Hearing regarding particular fees relating to the amendment of the ordinance related to land use matters. Concern had been stated concerning the fact that if connection fees were too high there was the possibility of hindering further development. After a lengthy discussion the Planning Commission recommended approval of said ordinance. Motion was made and carried at the council meeting with all ayes adopting the ordinance amending certain fees relating to land use matters.

Miscellaneous

The council reviewed a drafted letter regarding the City of Chaska's Comprehensive Plan. Motion was made and carried approving the drafted letter responding to the City of Chaska.

The City Administrator updated the council regarding changes in the union contract and the council reviewed this contract. Motion was made and carried with all ayes accepting the collective bargaining agreement.

The administrator proposed that all of the benefits agreed to for the union should be inclusive to non-union personnel. Motion was made and carried with all ayes allowing non-union employees the same benefits as the Union Members.

Dahlgren Township

The township clerk attended a meeting at the Carver County Government Center discussing March township elections. There are only four townships in the county still holding elections in March, the others changed elections to coincide in November. Elections costs are divided by the four remaining townships and the costs are increasing. The pros and cons will be investigated and discussed further.

The Dahlgren Township elections will be held on Tuesday, March 9th, 2010 at the East Union School. The positions open are one supervisor and Township Clerk.

The Township Board attended a meeting with the Carver County Sheriff's Department. The Sheriff informed the board that the department will be cutting back services unless the township starts to pay for services. One of the board members would talk with the Cities of Cologne and Carver inquiring about potential cost sharing alternatives. The issue will be discussed at the Township Annual Meeting in March. A board member would meet with the sheriff's department to discuss the changes expected to occur if the township does not pay for patrol time.

The Dahlgren Township Board scheduled to hold the Board of Audit meeting following the February monthly meeting. The board discussed the March elections. An alternate date for the March election was discussed in the case of inclement weather. The March elections are scheduled for March 15th, 2010. The Board passed a resolution to change township elections from March to November. This election change question/issue will be included in the March 2010 ballot for the voting township residents.

The Dahlgren Township Board received and reviewed the revised plan for the township in the 2030 Comprehensive Plan for Carver County. The township still had questions regarding wording. One of the board members will meet with a county representative to discuss these concerns. The board also reviewed Chaska's 2030 Comprehensive Plan. There were no changes from the township. The board approved.

The Annual Town Meeting for Dahlgren Township will convene at approximately 8:15 PM on Tuesday, March 9th 2010 at the East Union School. The tentative agenda items for the annual meeting include review of 2009 expenditures, 2010 budget, proposed levy, other township items and election results.

City Administrator

The council held a special meeting regarding the resignation of the city administrator effective January 29th 2010. The council accepted his resignation by motion. The administrator checked on qualification requirements for the position. The minimum qualifications were reviewed by the council. The council would like to set the minimum at five years experience in public administration and two years experience as an administrator with either a small or larger city. Inquiry was made to possess economic development experience. Council consensus was to have a committee to conduct the procedure. Committee was chosen and the administrator was directed to post the position availability.

Motion was made and carried with all eyes directing the staff to research final details and legal issues for the council to review in the future.



Freeway Commercial Alternate Urban Area Review

The council reviewed the revised Freeway Commercial Alternate Urban Area Review. The city planner included for council review copies of the comment letters, responses to letters and revisions for the Freeway Commercial Alternate Urban Area Review. There were not any questions or comments. Motion was made and carried with all ayes approving the resolution ordering the distribution of revised Alternate Urban Area Review for the Carver freeway commercial area.

Stop Sign Analysis

The city engineer reviewed the Carver Bluffs Parkway, Ramsey Avenue intersection stop sign analysis issue. The analysis involved current site conditions, collected turning movement volumes during the peak hours of the AM and the PM, and collected crash data. This was all examined to determine whether or not a four way stop would enhance traffic operations and safety. Conclusion was determined that this intersection does not meet warranting a multi-way stop control and that the control of the side street stop sign is the most appropriate traffic control for the intersection. All in attendance understood the determination and did not have any comments or questions. Question was asked if it were possible that the area warranted a "Bus Stop" sign instead. This type of effort would be appreciated. The public works director would review the issue and submit suggestions. Motion was made and carried with four ayes and one nay to erect two "Children At Play" signs area of Carver Bluffs Parkway and Ramsey Avenue area.

Sanitation Ordinance

The council discussed the city's ordinance relating to 'Garbage, Refuse and Recycling'. The city attorney reviewed with the council that there were three hauling licenses within the city. One company has bought out the two competitors. One contractor had been considered in the past. The current ordinance does not allow issuance of licenses prior to September. Waste Management representative attended the council meeting to answer any questions of the council. The council inquired about a two year Service Agreement residents are being asked to sign. The representative stated that residents are not required to sign to receive service. The net question was asked if a letter is being forwarded to residents informing them that they are not required to sign this agreement? The response given was that Waste Management wishes to continue providing service within the City of Carver. The council discussed their option and the general consensus was to amend the ordinance allowing reissuance of licenses. Question was asked if this should be two or three licenses. Motion was made and carried with all ayes to schedule a special meeting to further review this issue.

Steam Boat Days Committee

The Steam Boat Days Committee will be resuming their meetings for planning and working on the 2010 upcoming event. If interested in participating, helping, planning, giving/sharing ideas, then mark your calendars for the 2nd Wednesday in February, the 10th at the Village Hall. Steam Boat Days is scheduled for September 10th through the 12th in 2010. Look forward to meeting and seeing new and familiar faces.

Propane Powered School Bus

Bet you didn't know that school buses could run on gasoline, diesel and also be propane powered? Who makes a propane powered school bus? Bet you didn't know there were different companies of school bus manufacturer's either did you? Blue Bird is the company responsible for making the propane powered bus. This is the future the industry is all abuzz about. The 'green' phase. This is the 21st century technical wave.

Eastern Carver County School was the first Minnesota School District test-driving this new propane powered school bus offered by Blue Bird. The company allowed the school district and Positive Connections to secure temporary ownership of a propane bus for one week. The bus arrived on January 15th at the Positive Connections terminal. Its arrival drew immediate attention from drivers. Many checked out the vehicle reminding one of young men's first experience to show off their mechanical capabilities. That's what it is all about though. New technology, first one on the block to get the new item and first to bragging rights. The line of requests to drive the beauty grew fast. It was evident that not everyone would get the opportunity to climb up the stairwell, sit behind the wheel and test drive this new 'idea' bus. Many commented on the chrome wheels, the external look was much like any other school bus rolling down the road, yet somehow this one seemed different, newer, shinier and much more attractive. It had to be the newness, don't you think? Or don't you agree? Yes, that would be the better question?

"We are going to drive it in winter conditions, leave it outside overnight, and put it through its paces," said the transportation coordinator John Thomas. "We are taking our transportation contract to bid this spring and will consider moving towards propane powered buses. We believe the school district could realize significant savings in fuel and maintenance costs while doing our part to help the environment," he said.

The Eastern Carver County School currently serve nearly nine thousand students and could possibly replace buses with the propane powered buses with a current fleet of one hundred twenty buses. These buses are utilized in other parts of the country, particularly California. The buses meet the state's stringent emissions requirements.

The buses meet the new 2010 EPA (Environmental Protection Agency) requirements, provides and alternative to rising cost of diesel fuel, lower operating and maintenance costs, produce thirty to ninety percent less carbon monoxide and about fifty percent fewer toxins than gas engines. Blue Bird Propane Vision specifications state that the engine is 333 hp @ 4400 rpms, the transmission is an Allison Automatic, and the fuel range is approximately three hundred miles. Four-wheel, hydraulic and air brake systems are available. Anti-lock brakes on all four wheels comes standard on all systems. The capacity of the bus is forty seven to seventy seven passengers. Propane is readily available, economic, clean burning, environmentally friendly eligible for tax credits, safe and alternative fuel. The goal of the Blue Bird Corporation is to provide customers with maximum performance and economic flexibility to address bus engine needs to meet the challenges of the EPA engine emission requirements. The propane powered bus incorporates a robust GM 8.1 liter engine that utilizes liquid propane injection for maximum performance and efficiency.

What do the driver's have to say? The bus was at Positive Connections terminal for a week. During that week various drivers had the opportunity to test drive it during routes and charters (aka field trips). The common factors heard from drivers was that the bus warms up quickly, warmer than normal, drives quieter and has quite the power to go. General overall reaction from the drivers was that they liked the bus, were impressed with the overall operation and liked the looks of the bus. Many commented that they would like chrome wheels on their bus too. The week ended too soon and the bus moved on to be tested in other places. The "what if" questions fading off into past tense as this chapter closed on this test drive experience for Positive Connections.




What Bugs tell us about our Water



The process of using aquatic life to determine water quality is called Bio-monitoring. Carver County has 9 sites monitored annually. This year, Carver County began a new volunteer program educating citizens on bio-monitoring through macro-invertebrate sampling and identification and habitat assessment. The program is called SHEP or Stream Health Evaluation Program.

The 2009 SHEP team, consisting of 8 citizen volunteers, used macro-invertebrates to determine the water quality of two creeks in Carver County, West Chaska Creek and Carver Creek. Macro-invertebrates are small stream dwelling bugs, found usually in their larval stage, whose presence or absence, number and diversity, can tell us about the water quality of that area. Different species of macro-invertebrates have different tolerances to pollution. Thus, the absence of stone fly larva (which cannot tolerate pollution) may tell us the water quality isn't so great, while the presence of numerous stone larva may indicate good water quality.

The SHEP team completed one day of sampling to collect the bugs and 3 lab sessions to identify the bugs. Once completed, the samples were cross-checked by Carver County staff. Carver County would like to congratulate the 2009 SHEP team for their 99% accuracy on the West Chaska Creek site and 96% accuracy on the Carver Creek site.

Carver County would like to expand this program and encourage more citizens to learn about and become trained in bio-monitoring. This is an opportunity to be trained by professionals, get hands on learning and help protect our waters.
