

Dahlgren Township

The Dahlgren Township Board reviewed the request for approval of a conditional use permit for the installation of a wind turbine at the business location of Mustard Seed. The board approved the conditional use permit.

The board has been reviewing the issue of pushing snow across township roads which is illegal. Documentation will be done and warning letters forwarded. It is costly to have a third party remove snow from the roadway when driveways being snowplowed push excess snow across the roads.

Funding request will be forwarded again for the FYUY2011 Appropriations from Senator Klobuchar. The necessary forms will be forwarded to the senator's office referencing the Town Hall.

The township met with the Carver Fire Department. There was a discussion of a new fire engine. The department was asked to investigate the cost of a purchase of a new truck, or a demo truck or a used truck. The meeting was rescheduled for further discussions.

The township was asked to forward an appeal to the CenturyLink phone company to provide high speed internet to more township residents. A notice would be posted on the townships website.

Carver Lions

The Carver Lions will be presenting dictionaries again to all the third grade students at the East Union School in the month of February. This will be the third year for this program. The Lions are discussing plans for their Annual Pork Chop Dinner scheduled For April 30th. Don't forget, the Lions still collect used eyeglasses. They can be dropped off at the city hall or brought to any of the Lions events or meetings.

St Nicholas Church

Church members noted increased traffic on 4th Street, along with increased speed. The council was informed of this observation. There have been some close calls the council was told when people realize upon reaching the top of the hill that there is a 'hidden driveway'. A sign exists, however, the location obstructs the view of the oncoming traffic. Suggestion was submitted to place signs in both directions, stating, "Caution – Church Entrance". The church should discuss the issue with the staff and implement a solution.

Sanitation Licenses

Representatives from Franck's Sanitation, Organic Disposal, Allied Waste and Elite Sanitation were at the meeting. Randy's and Highland Sanitation applied for licenses however were not at the meeting. The council asked questions of the sanitation representatives present. Question was asked if they would all abide with the Memorandum of Understanding. Wide range of services for residents was the council's goal. Motion was made and carried to issue sanitation licenses to Elite Waste Disposal and Organic Disposal.

Municipal Utilities

The city engineer explained to the council that approval of Change Order #3 involved with the Carver Interceptor has been removed from the agenda because the Metropolitan Council Environmental Services had not given approval for the Change Order. The engineer requested approval from the council contingent on the Metropolitan Council's approval. The council had questions regarding the Change Order and requested documentation for the change order including the part containing trash removal. A council member inquired about the part in the change order involveing brick pavers as it was understood that these were part of the original contract. The engineer stated that they were not. Another council member inquired about the removal of a tree since there was confusion regarding which trees were to be removed The work had already been done. The council questioned the contingency amounts listed on the Change Order. Additional signage costs were questioned and the signs were rented. Motion was

The council reviewed the pay request for the 'Carver Interceptor Segment A' for SM Hentges & Sons, Inc. Motion was made and carried with all ayes approving the pay request contingent on the Metropolitan Council Environmental Services approval. The council reviewed approval of the sewer extension analysis. MN DOT had paid for the Technical Memo on Sewer Extension Analysis for Comment to the MN DOT. Motion was made and carried with all ayes approving submittal of the technical memo and analysis for comment to MN DOT.

Alternate Urban Area Review

The city planner reviewed the Alternate Urban Area Review recently discussed. The council was reviewing approval of the resolution pertaining to the adoption of the final Carver Freeway Commercial Alternative Urban Area Review. The DNR and the Metropolitan Council responded in the time period allowed. The city was asked to accept the resolution adopting the final alternate urban area review and mitigation plan. The city planner stated that future development of said area has to be consistent with the adopted final alternate urban area review and mitigation plan. If a proposed development is not consistent then the environmental analysis will be required to be updated. The environmental review is valid for five years and if a development is not fully approved within five years then an update to the alternative urban area review will be necessary by Minnesota Rules. Motion was made and carried with all ayes adopting the final Alternate Urban Area Review and Mitigation Plan for the Carver Freeway Commercial area.

Food Shelf

County Roads

The city planner told the council that the council is requesting comments for the proposed layout for County Road #11 between County Road #61 (old Highway #2123) and County Road #10. The city planner drafted a comment letter for the council's approval. Imquiry was made regarding the cost for right-of-way and construction. The current cost estimate was given by a resident. Motion was made and carried with all ayes stating that the City of Carver favored Option 1 or 2 as shown on the project map.

The council reviewed the Environmental Assessment and Work-Sheet for Highway #212 and the request authorizing Submission of Comments. MN DOT is requesting comments from the cities of Carver and Cologne. A copy of the Environmental Assessment and WorkSheet is available at the city offices or on MN DOT's website. The planner drafted a letter for the council's approval for submittal to MN DOT. Motion was made and carried with all ayes authorizing the comment letter for the Environmental Assessment and WorkSheet for Highway #212 comments to be submitted to MN DOT.


Potential City Hall

Scheduling a workshop meeting was requested to discuss the potential city hall on Community Development Authority property. There was a brief discussion on the topic. Motion was made and carried with all ayes scheduling the special meeting discussing the potential new [location to be determined]city hall, pre-ference to the Fire Hall. Request was submitted for information to be provided prior to the meeting by the Community Development Authority and the city planner.

Water Tower

The council discussed the water tower and the repainting of it. The tower had been constructed in 1987. Generally repainting of them is required every fifteen to twenty years. The current tower paint has lasted twenty plus years. KLM Engineering conducted a recent inspection. The company recommended removal and replacement of both the interior and exterior coatings within the next two years. There were also some structural repair recommendations so that the tank would be in compliance with OSHA regulations and American Water Works Associations standards, as well as to allow for safe access to the tank. This work would take approximately five weeks to complete.

The cost of this work was questioned. The engineer quoted approximately eighteen thousand for plans and specifications. Question was asked why plans and specifications were necessary to paint the interior and exterior of the water tower. Exterior painting was questioned. The Public Utilities Supervisor stated that it could be done, but the tower would still be required to drained and disassembled, therefore, it made sense to paint both the interior and exterior at the same time. Council consensus was to get more information since it was their opinion that the estimated cost for repainting was quite steep.



Snow

The mayor inquired about permit requirements if someone wanted to utilize an ATV for snow plowing on sidewalks. The attorney responded that a permit could be gotten but it would be difficult to regulate. The attorney stated that there are larger ATV's that are licensed and can be driven on the street. Different uses for these vehicles was discussed and these uses were considered appropriate for city celebrations, snow removal and the like. Further discussion was held what use should or should not allowed.

Park and Recreation Department

Special Work Session

The council held a special work session for the purpose of discussing a proposed new city hall. The city planner requested discussion pertaining to the scope of the project, as well as feedback on council's goal to accomplish. One council member was of the opinion that the sites for the city hall should be reviewed in the downtown area and that the community center be an alternate with the Community Development Authority. Another opinion given was that there was not enough space downtown as the city grows. So as that there would not be abandonment, a plan should be in place for the downtown. What would happen with the church and the present village hall. A concern was voiced regarding the expenses in this economy and taxing already burdened taxpayers. The financial consultant presented some estimates on costs and debt limits. A sensitivity analysis comparing costs for new into the future could be presented. The attorney discussed a Joint Powers Agreement with the Community Development Authority. Two council members were prepared to proceed with the proposal, however, three council members wanted more in depth information. The mayor was of the opinion that there was a need to proceed but was -. The city engineer was directed to bring more information regarding the school house building to an upcoming meeting. Request was submitted to present square foot cost comparisons between the school house building and the proposed new structure. Parking should also be discussed. The final conclusion was that there was a need for a new building for the city offices and that the city would be imprudent not to build with the proposal presented by the Community Development Authority.

Carver Fire Department March News

The Carver Firefighters have been very busy with training and getting state certified. The training has been noticed on calls; one example is the department had a house fire that we responded to, along with assistance from Chaska, Cologne, Victoria, Shakopee, Jordan, and Belle Plaine for water and personnel, and it was extinguished with saving a lot of the house and its contents.

On February 27, 2010 Carver Fire Fighters: Chief - Dan Meyer, Captain 3 - Tim Carroll, and Firefighters - Jarren Schmieg, Jarred Bowen, and Matt Lewellen participated in a challenge to raise money for the American Lung Association in Minneapolis where we went up 30 flights of stairs with full gear on and a self-contained breathing apparatus which weighs over 60 pounds. When we were all done it was hard to even laugh because it took so much out of us, but we were all proud that we had the chance to do it. This was the second year that Tim had the chance to do it. This was competitive challenge where there were over 25 different departments from around the state participating and Carver placed 10th as a group (from the top four scores).

The Carver Fire Department received a 2006 rescue boat from the DNR that did not cost us any money thanks to Assistant Chief Scott Las on finding this boat. The only cost that it took is time to go pick it up and minor repairs to get it ready for spring. This boat will replace the old rescue boat that has a lot of repair issues that cost more than what the boat is worth.

The Carver Fire Department is going out for bids to replace the rescue engine that was removed from service at the end of the 2009.

As spring is approaching, the City of Carver, Carver County Risk Management and the Carver Fire Department have been meeting and preparing for the concerns of flooding that has been predicted. The River is predicted to rise higher than it has in many years. The flood pumps and flood gates are being checked and secondary pumps are being prepared in case of any issues that may occur with the primary pumps. There is a likely hood that the need for sandbagging will occur. If you are in the flood zone, you only have thirty days before cooling is declared to get flood insurance.

As a reminder, make sure to check the batteries in your fire alarms and CO alarms. Also, make sure that you have a CO alarm within ten feet of every bedroom.






