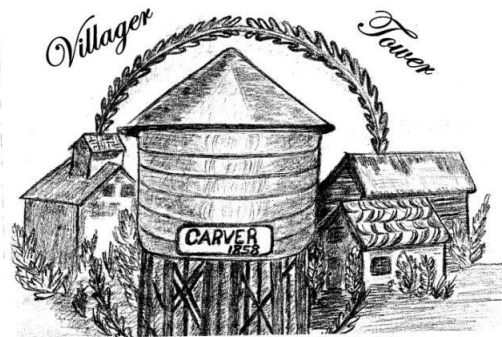

Strategic Planning

The city council established the areas and goals to review the role of the Heritage Preservation Commission and preservation within the city. Several meetings have occurred developing an action plan to implement helping with organization, communication and associated processes involving the preservation of the City of Carver.

A list was comprised of concerns with current methods utilized. Improvement processes were reviewed. Input was reviewed from various sources. Some changes were implemented to the action plan. Further review will be done. The next steps will be the review of the Preservation Action Plan worksheet and get, as well as give feedback. The council will adopt the Preservation Action Plan in the future. Discussion was also held concerning minimum maintenance expectations and application to all properties. The attorney clarified that the Equal Protection calls for enforcement of an ordinance to apply to all if an ordinance is created. Suggestion was made for a funding program being investigated versus spending funds on regulation and enforcement.

Minnesota River Crossing Project

The city planner reviewed the current updated information available regarding the MN River Crossing Project. More information is available on line, if you have a computer. It can be found on the city's website or on the Department of Transportation website under road projects. As the project progresses and more information is available, it will be available at the county's level, cities' levels, state and the newspapers will continue to give more details, as well.

Municipal Utilities

The council discussed the item involving the municipal utilities connection required with a new owner. Initially the hook-up had not been resolved with the previous owner leaving the purchaser in an awkward predicament. Owner proposed solution not in agreement with the city personnel. Disclosures by the previous owner were discussed. Property tax records possibly would have alerted a purchase as well. Impression was that the municipal utilities were in place. Septic and well passed compliance inspections as well. The disclosure issue would be the recourse. However, that is an initial start up cost without recovering attorney costs. Discussion was held regarding previous letters sent and proof. The council was of the opinion that a resolution could be reached but it would not be a cost free resolution. The council would work with new property owners. The end result still remained that municipal utilities are required. The city's fees would be on a resolution. The appropriate personnel would be scheduled to meet with owner and a resolution put into place. This type of situation should also be reviewed so as not to be repeated in the future with safeguards put into place.

Carver Fire Department

The fire chief reviewed with the council the provisions included in the Standard Operating Procedures Manual. Motion was made and carried with all ayes approving the Standard Operating Procedures Manual.

### *Highway # 41*

The city council listened to the overview given by the City Planning involving the highway river crossing pertaining to the Environmental Impact Statement written in 2007. The immediate action at this time is to review the 2007 letter and identify what large issues still exist and comment or emphasize former issues from previously. New comments will not be accepted. All governmental units involved agreed to work together. Request for an updated map of the area involving the interchange was requested. Additionally discussion was held regarding current interchange, merge issues and relevant concerns. The council was assured by the City Planner that the city's concerns were identified previously. The City Planner will draft a supplemental/review of the 2007 letter and information for the council members.

Overhead Utilities

The council listened to an overview of the Sixth Street West project by Xcel Energy's representative at the council meet-ing. The utility lines are the result of a new substation. The residents were also then made aware of the necessity for tree trimming on the north side of the street being discussed. Much discussion has been held on overhead or buried lines. Additional feedback resulted in reexamination by the council.

Clarification was requested concerning the new substation. The engineer clarified that there was a back up with Chaska Public Utilities. With the new substation, Chaska will be able to keep connection to resolve any potential power issues. An overload transmission line at the Community Park will service the new substation.

The council reviewed spacing locations, height and costs regarding the two alternatives. A design fee would be necessary to obtain a more precise cost. The city engineer stated that the estimated price included information relating to the Fourth Street project. Overall the Fourth Street was more expensive in comparison. Additionally there were concerns relating to safety and trail location of lines.

The goal was to attain a design decision to proceed. It was necessary to relieve the Chaska substation load.

Residents input, concerns and opinions were heard. The council reviewed the details of a Surcharge Program. The city attorney stated that the surcharge was more a financial than economic item. It has been looked at in the past and will be most likely come into discussions again in the future. The end result remains that the city still pays extra to bury lines and decisions will affect future decisions. Alternatives include franchise fees to assist building funds rather than a surcharge. Regardless which method, the city retains the extra cost burden for burying the lines.

The question of reliability was asked. Xcel responded that troubleshooting is much quicker with overhead lines. The life expectancy of underground lines is estimated to be thirty years approximately. Generally overhead lines last longer making it difficult to gauge which is the absolute best route. The major pointed out that the council has been very conscientious concerning communication with the public.

Question was asked if the lines would be underground the entire length. Xcel responded that the poles above ground would be left and burying could be done at a later time. Comment was made regarding the aesthetic value of trees and the impact to homeowners on both sides of the street. The comment was also made concerning the beauty of the street. Suggestions was submitted to re-examine the decision as it would preserve the integrity of the entrance into the city. Question was asked if aesthetics was a enough of a reason since that decision was tough involving the street that is and always will be the entrance into the city. The same thought processes, agreements and decisions should apply to both and any areas.

The attorney relayed to the council that an answer to the resolution/bond issue was not available at the present time. However, the project would be added to the Chapter 429 Public Improvement Bond. The city needs to assess at least twenty percent of the overall project cost in order to sell the bonds. The necessary data to answer specific questions was not available for the meeting, but modifications could be done in time. The end result is that the feasibility study needs to be reviewed further in order to see the possibility of adding the item.

Motion was made and carried with all ayes and one abstention authorizing the burial of the new utility lines down Sixth Street West. Motion was made and carried with all ayes and one abstention approving the design fee for Xcel Energy to study the costs of burying power lines on both Sixth Street West and Fourth Street.

Discussions continued regarding utility lines on Sixth and Fourth Streets. The staff had been directed to return to the meetings with financing options for the burial of utilities. The City's Bond Counsel verified costs associated with the burial of utilities could be included with the Fourth Street West Improvement Project by resolution. Also verified that his additional project cost maintains the city's ability to issue general obligation bond, At least twenty percent of the cost must be specially assessed in order to issue general obligation bonds.

Since the city has a number of utility project scheduled and an inter-fund loan would be a less desirable funding option. Local Government Aid funds have been and have been and will continue to be an unreliable source of revenue for the city. Therefore, the most reliable funding option is to include the Fourth Street Bond project. This will also includes the County Road # 11 trail project from Fourth Street West to Carver Bluffs Parkway. Question was asked of the resolution included the burying of lines on Fourth Street. The resolution did not include burying lines on the Fourth Street project. Statement was made for the necessity to stay consistent and bury the lines on Fourth Street too. The cost estimate for Fourth Street is include din the request from Xcel. Decisions on Fourth Street would be made in the future. This is a separate decision process. The funding options will be investigated further if and when that decision is made. The estimated costs to bury lines on Sixth Street were discussed.

Question was asked about Fourth Street decision being made at a later date. Administrator responded that there was a six month time format allowed for new or amended resolutions on this decision. Question was then asked if it still would coincide with Xcel's time schedule. The administrator stated that it was more an internal function regarding funding. Decisions regarding Fourth Street's future would not change in details of the current bond issue for the Fourth Street project. Other funding options need to be investigated if the decision to bury lines on Fourth Street were made. The mayor pointed out too that burying a new utility feeder line on Sixth Street was not an indication that the city would start burying existing lines in the future. The cost estimate to be presented will include quote pertaining the burial of the lines on Fourth Street. Motion was made and carried with all ayes approving the burial of utilities on Sixth Street.

The Planning Commission members continued the Public Hearing involving the amendments to the City Zoning Ordinance. A portion of the proposed revised ordinance was discussed, but the entire zoning ordinance would be continued to be reviewed in the future. The members discussed the document and will continue the reviewal process.

## *Park and Ride*

The Planning Commission held a Public Hearing on the Carver County Community Development project involving the Park and Ride Facility and related items included with the facility. The City Planner reviewed the first two phases of the project, the park and ride facility and single-family homes that will be completed simultaneously, but by different entities. The City Planner explained the engineering plans for the streets included in this phase and area part of the preliminary plat approval. The third phase is not scheduled at this time with Outlot D containing the proposed apartments for the property being discussed. The City Planner stated that the development requested approval for rezoning from agricultural to residential and Public Institutional, a planned residential development and the preliminary plat for development of single family homes, outlots, right of way and related improvements. A plan for the use and development of the open space would be provided with the application of the Final Plat and recommended that the Outlot A be developed as a tot lot. The City planner explained the variances for the city zoning ordinance requirements for the single family lots approved. The Planning Commission members recommended approval of the rezoning request. Motion was also made and carried recommending approval of the preliminary plat for said property with conditions as stated.

The council reviewed the action involving the Joint Powers Agreement between the county and the city for the construction of the Park and Ride Facility, internal street and utility improvements, as well as the improvements to the intersection of County Road # 11 and Ironwood Drive contingent upon the final approval of the agreement. The agreement with the Carver County Community Development Agency had already been approved to proceed with a Park and Ride facility located on the agency's property along the west side of the county road. This project is partially funded through the Federal Congestion Mitigation Air Quality program. The funding schedules and requirements include the utilities, collector streets, park and ride site, shelter and trails on the agency's property. This construction is tentatively scheduled to begin in late summer of 2013. The trail project south of the agency's property and the pedestrian underpass will not be constructed until 2014 due to easement acquisition timelines through the federal process. The county did not have any changes to the joint powers agreement.

Due to federal guidelines and requirements the project requires that Carver County act as the contracting agency and administrator. The city will draft the plans and specifications, acquire right-of-way and easements and provide the necessary surveying and construction inspection services. The governmental units have been meeting. The 2014 work is not included in this agreement.

The county and city cost percentages were reviewed. The most recent proposed cost sharing policy form improvements are not part of the county's five year capital improvement plan. The improvements projected for the area involve local streets and county roadways, as well as a new signal at the intersection of Ironwood Drive and the county road. The joint powers agreement is required to be approved by both parties so that MN DOT will approve proceeding with the right-of-way acquisition process. This process needs to begin in early April to meet project funding requirements for 2013 construction projections.

Cost allotments were reviewed with different phases involving the various work to be done over the time frame involved with the project. Related boards have also been reviewing the various items involved in the different areas. The staff recommended the authorization of the joint powers agreement.

Question was asked to clarify what the Congestion Mitigation Air Quality program will be responsible for. The city engineer explained that the agreement outlines what costs the Congestion Mitigation Air Quality program will cover. The engineer reviewed the breakdown with the council. The Congestion Mitigation Air Quality will cover eighty percent of the construction and right-of-way costs up to a certain amount which was outlined in the original grant application. The remaining twenty percent will be covered by local funds, indirect costs such as engineering services that are not covered as part of this agreement. The Congestion Mitigation Air Quality is paying an estimated amount plus construction costs and an estimated amount plus operations costs. Motion was made and carried with all ayes and one abstention approving the joint powers agreement between the city and the county for the Park and Ride and country road improvements contingent upon final approval by the county.

The city reviewed the rezoning and preliminary plat for the Community Development Agency's Park and Ride property. Three resolutions were discussed involving the rezoning the proposed property to Public Institutional, rezone the remainder of the property to residential and approval of the preliminary plat. The agency owns approximately thirty six acres. The proposed development involves the Park and Ride facility, single-family homes, and apartments. The planning commission reviewed the issue. The staff recommended approval of each of the associated planning actions.

The City Planner gave an overview to the city council pertaining to the three resolutions involving the preliminary plat and rezoning of the Community Development Agency's project identified as the Park and Ride Facility proposal. The ordinance relating to this will be presented to the city at a later time. One resolution involved rezoning the remainder of the property to Planned Residential Development regarding the density transfer from single family housing to future multi-family housing location. Then the council was being asked to approve the preliminary plat by resolution. Motions were made and carried with all ayes approving three resolutions involving rezoning issues and preliminary plat approval.

## *Dahlgren Township*

At the Dahlgren Township annual meeting the consensus of the participants voted on motion to return fire protection with the cities of Carver and Cologne.

The township's annual meeting participants were given a presentation by the commander with the Carver County Sheriff's Department involving coverage by a contract for police protection. Currently only major issues, accidents and/or robberies are responded to. If the township retained a contract they would have fifty two hours per year of a Community Service Officer. The township would also receive a percentage of issued citations within the township and a portion of state funds that departments pay into annually. Costs were reviewed. Motion was made and carried with all ayes contacting with the sheriff's department.

The township participants discussed roads and bridges in the township boundaries. The road repairs that were made in 2012 were discussed, along with budgeted projects for 2013. Motion was made and denied changing cost share for dust control back to one third township and two thirds residents' shares. Motion was made and carried with all ayes that the dust control will remain one hundred percent paid by resident. Motion was made and carried with all ayes to apply dust control twice during the summer and not one application.

After a lengthy discussion involving the abandonment of 154<sup>th</sup> street between County Road # 40 and County Road # 43 motion was made and carried with all ayes not to abandon the discussed street.

The next annual meeting was scheduled for the second Tuesday in March of 2014 by motion. The meeting times were also voted on to change the meeting time to 7 PM. These changes will be in effect at the start of January 2014 meeting.

## River Bluff Estates Second Addition

The Planning Commission held a Public Hearing involving River Bluff Estates Second Addition requesting a Comprehensive Plan Amendment, Rezoning, residential development and preliminary plat. The Chestnut Group requests approval for redevelopment of twenty seven single family lots on the site that previously approved townhome units. The Comprehensive Amendment is from medium density to low density residential and rezoning downsizing. The proposed project would replat the existing townhome lots and outlot A into single family lots with a reconfigured Outlot A. The private road would remain as is. The utility services located within the development are city owned and the service lines already exist. The developer requested that the excess service lines be allowed to remain, however the Public Works personnel recommends removal of the unnecessary service lines. The Metropolitan Council provides flexibility for existing uncompleted projects. The City Planner recommended tabling the issue involving the Comprehensive Plan amendment pending the redesign of the project. The Planning Commission reviewed the rezoning. Each residential development has its own specific standards contingent upon developing the property conforming to approved plans. Again the city planner recommended tabling the issue until revised plans are presented and outstanding comments are addressed.

## Carver-on-the-Minnesota, Inc.

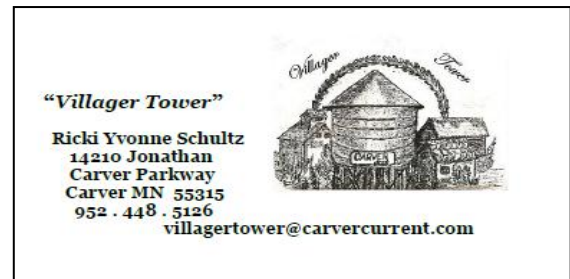

There are no questions asked. The boxes are sealed, weighed and transported for destruction by the staff of the sheriff's office. There are five locations throughout the county, they are the Carver City Hall at 316 Broadway Avenue in Carver. Hamburg City Hall at 1818 Broadway Avenue in Hamburg. Mayer City Hall at 413 Blue Ajay Avenue in Mayer. Two Permanent sites are located at the Chanhassen City Hall at 7700 Market Boulevard in Chanhassen and the Carver County Sheriff's Office at 606 East Fourth Street in Chaska.

## *Pros and Cons for Firefighters Pensions*

Minnesota lawmakers are considering a bill to add a surcharge on every policy in the state involving homeowners and auto policies.

This action would help restore pensions for policemen and firemen. According to WCCO/CBS news the issue has become very controversial.

According to the news report, public pensions took a hit when the stock market had its own meltdown in 2008. Statement was made that the two categories being discussed can be fixed by legislation. Additionally, it was stated that police and fire pensions are already being paid with auto and homeowners insurance policies. The exact amounts were not disclosed. This issue was actually the first ever tax imposed by the State of Minnesota back in 1871 according to the news report. It was also stated that there is a large shortfall in pension funds for these two groups and there is no safety net. Police and firefighters do not qualify for regular social security nor disability.

The local fire department has composed their own fact sheet to distribute. The Carver Fire Chief requested distribution.



### **Funding Support For Volunteer Firefighter Pensions**

**February 13, 2013**

- Minnesota Ranks 45<sup>th</sup> in Per Capita Fire Expenditures (48<sup>th</sup> Per \$1,000 Income) in the nation. This is largely due to fact that 18,000 of the 20,000 firefighters in state are volunteers who serve with virtually no compensation other than their pension.<sup>i</sup>
- The vast majority of these volunteers will receive a one-time lump sum distribution of \$30,000 or less for serving their community for twenty (20) years.<sup>ii</sup>
- Fire State Aid peaked in 2006 at \$31,770,838 and has fallen to \$21,995,957 in 2012; a decrease of \$9,774,881 or more than 30%.<sup>iii</sup>
- This caused volunteer fire relief's plans to; go into an underfunded status, decrease or hold benefit levels for years, an increased municipal contributions.<sup>iv</sup>
- The volunteer fire pension has proven to be an incredibly effective recruitment and retention tool which the loss of state aid has resulted in negative impacts. There were 18,734 active volunteers in 1996 as compared to 17,187 in 2010. A decrease of 1,547 or 8%.<sup>v</sup>
- According to the State Auditor Compilation Report in 2010 68.3% of all volunteers were over the age of 35 with 18% of that being over the age of 50. Minnesota, similar to the rest of the nation is facing a critical shortage of volunteer firefighters.

Your support of a \$5 surcharge on all homeowner policies will increase the fire aid to volunteer plans by approximately \$5.5 million or 34%. This will help to restore the funding decreases that have occurred over the past seven years

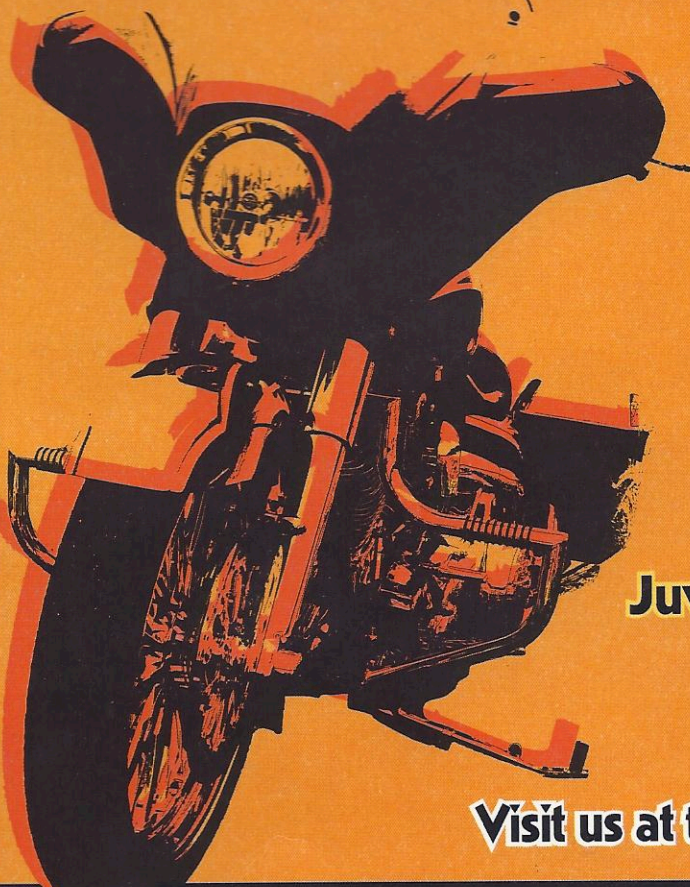
