## Water System Update

The city engineer and the Public Services Utilities Superintendent provided an update to the council regarding the city's water system. Current operations and future improvements in the city's water system were reviewed. The update included an overview of the timing of the next well ( # 5 ), past studies and the location of the proposed newest well, the future water treatment plant property, interim water treatments, other water system items and the next steps required.

The timing of the new well has been affected by the overall water demand which has been slower than originally anticipated along with the HomeOwner's Association using less water for irrigation systems. The new water tower had assisted with water demand in peak periods. Moving forward, new growth is anticipated with the developments in Copper Hills, Christy's Bluff, and Klingelhutz. Based on this anticipated growth the staff recommends building the new well in the beginning of 2016.

The future of the Water Treatment Plant property is to attempt keep the site as close as possible to a future collector road for access. Consideration to purchase land and coordinate early with the County was advised, as well. Future issues with the collector road could affect costs.

Complaints of brown water and water quality complaints have been received by the city. These complaints have increased with the use of well number four. Water quality levels can also change in the aquifer. An option might be an interim package plan and building at the well pump house.

Upcoming water system improvements that would be recommended would be well #5 in 2016, well #6 in 2022, well #7 in 2026, and well #8 in 2030. The City will continue to rely on wells to cover water storage needs until storage needs increase to make construction of water storage costs effective. Other immediate issues include repairs on well #1.

The next steps include authorization by staff to begin discussions with property owners on the purchase of the land for well number five. The staff will continue to monitor the complaints received on water quality in the northwest area of Carver. The staff will review funding for an interim treatment plant with the financial consultant and review this with the council. Locations for a future treatment plant locations will also be reviewed by the staff.

## 2013-2014 Goals

The council had received an overview regarding the Water Supply Plan. The Comprehensive Facilities Study had also recently been completed and the staff is working on a timeline for the council's review of this. The outstanding items on the goals issue include the Downtown Master Plan and a meeting will be scheduled. The recreation study is to be presented. Trail maintenance plan is being worked on, as well as the Development Standards. The budgeting process has begun for the 2014 - 2015 goals and will be scheduled in January of 2015.

## *Carver County Declaration Update*

The city engineer provided the council with an update where the president had declared MN a major disaster due to the storm that had occurred. Initially eight counties were identified as eligible within the designated time frame. Two types of Federal Aid were available to the MN communities. Public Assistance Aid which is assistance for emergency work and repair/replacement of disaster-damaged facilities and Hazard Mitigation Grant Program which is assistance for actions taken to prevent or reduce long term risk to life and property from natural hazards.

FEMA reimburses seventy five percent of the approved costs. Legislation signed by the governor in 2014 indicates that the State of Minnesota will pay the non-federal share. Carver County was later added in the disaster declaration. Once the Applicant Briefings are completed on the original eight counties, then FEMA will contact the other counties to set up Applicant Briefings.

The staff forwarded to the county the information related to private property damages from the disaster per the county's request. The information for private properties had been tracked at the city hall. The county forwarded the information to the state. It is unsure whether the state will contact the county or residents regarding their damage.

## *Copper Hills 2<sup>nd</sup> Addition - Final Plat*

The city planner indicated that the updated resolution had been provided to the council. If the updated Westwood Plans addressing the items from city personnel necessitate revisions to the lot lines or easements, then the final plat will be revised by the developer and submitted for amended approval by the council. If an off-site easement is required then a separate easement document will be required and provided for review and approval prior to the release of the Final Plat recording. The additional information was due to attempts to meet watershed district items. This may then also necessitate some revisions to their plan and change their plat. The goal is to get approval so as to allow grading to be done this year. The Final Plat application for the Copper Hills Second Addition had been submitted for review and approval. Motion was made and carried with all ayes approving the resolution amending approval on the final plat for the development identified as Copper Hills Second Addition.

## *MN River Bluffs Regional Trail*

The administrator provided the council with an update regarding the MN River Bluffs Regional Trail System Pedestrian Bridge. Design plans are underway for the MN River Bluffs Regional Trail Corridor between Carver and Chaska with construction occurring in 2015. Upgrades to the trail include paving, trailhead construction at Depot Park and the addition of a pedestrian bridge on the First Street levee easement over Spring Creek. The county's construction plans are that the proposed trail bridge will be a single span, and sit on concrete. The Heritage Preservation Committee requested railings to match the railings on the current bridges. Motion was made and carried with all ayes approving the concept plan for the trail system.

## *Well Repair*

The city engineer indicated that the pump at Well Number One was inspected recently as part of the standard maintenance operations. Repair work is anticipated every seven to ten years based on the water quality in the aquifer. After inspection, determination was made that repairs were necessary to the pump, motor and drop line. Recommendation was submitted to approve proceeding with the work to repair. Motion was made and carried approving and accepting the bid from Traut Wells for repairs.

## *2015 Capital Improvement Plan*

The city engineer is currently conducting a feasibility study on the reconstruction of Oak Street, Fifth Street East and Sixth Street East. The project will also include the creation of a trail connection from Broadway to the Lions Park. The total cost of the project will be determined with the completion of the feasibility study. Financing options would be reviewed in 2015.

## *Public Services Director*

The staff reviewed possible reorganization option within the Public Services Department with the impending retirement of Larry Revering the Public Services Utilities Superintendent. With the merger of the two departments of Public Utilities and Public Works the department has functioned with two supervisory positions. The proposed reorganization creates a new position of Public Services Director. This position is expected to perform increased duties relating to scheduling, budgeting, capital planning and project management. Additionally the new position will also be responsible for operations and maintenance of the city's infrastructure, as well as the administration arm of the department. The minimum qualification for the position to include a bachelor's degree in the related field and five years experience. The creation of the Public Services Director position effectively eliminates the public services utilities superintendent position and transitions the existing superintendent's position into a more field supervisor. Approval of the reorganization was recommended.




