Carver Square

The city planner informed the council that the Lenzen Group submitted a petition vacating the existing drainage and utility easements on the Carver Square property. The purpose of easement is to allow individuals access to property. Presently the city has an easement for limited use of drainage and utility purposes. Those easements were created at the time that the property was platted as an outlot in the plat. Presently, the plat has additional easements and includes areas proposed for vacation. Explanation was given that by vacating the easements, it facilitates a better and marketable title for the future of these lots, as well as simplifying the title examination. A Public Hearing is also necessary.

The city planner provided the council with information concerning the Carver Square Final Plat. The Planning Commission had reviewed the plat and recommended approval. Motion was made and carried with all ayes approving the Final Plat for the Carver Square development.

The city council held a Public Hearing regarding the vacation of drainage and utility easements for Carver Square. Motion was made and carried with all ayes adopting the resolution approving certain drainage and utility easement in conjunction with a plat for a development known as Carver Square.

The Planning Commission reviewed the final plat for the Carver Square property. One member inquired about the size of the outdoor play area, the type of fencing and the rock located along the east side of the property. The state guidelines and requirements for the play area must be adhered to. The fencing will consist of black chain link and the rock is temporary. Question was asked regarding if the commission would be reviewing the final plat for the other two lots proposed. The city planner responded that the final plat would not be viewed, however, the commissioners will review the proposed site plans. Motion was made and carried recommending approval of the Final Plat for Carver Square subject to the staff conditions. Motion was made and carried with all ayes recommending the acquisition and disposition of land associated with the Carver Square project is in compliance with the Comprehensive Plan.

Southwest Corridor Transportation Coalition

The city engineer updated the council ion information regarding the Highway # 61 Corridor Study. Various documents require city feedback, especially pertaining to the conceptual plans involving the intersection of County Road # 40 and County Road # 61. The mayor provided a meeting summary and expressed concerns involving the organizations governance model and fee structure. The staff will review the issue further.

Right- Of-Way

The possibility of acquiring a right-of-way is a possibility the city manager told the council. This acquisition in this right-of-way in the Spring Creek Addition could possibly allow for the extension of Green Ash Drive.

Disclaimer

The "unapproved" minutes of the council and the township have been referenced for the purpose of creating this information for residents in the City of Carver and the townships surrounding the city.

*G*ufderheide Property

The city manager discussed with the council the possibility of acquiring the Aufderheide Property on Third Street West, parallel to Broadway and on the werst bank of Spring Creek in downtown. A purchase agreement is expected to be submitted to the city for consideration.

The city manager discussed the Aufderheide Purchase Agreement with the council. The discussions to acquire the vacant property were begun in 2016. The acquisition would secure a section of the Spring Creek Levee System that is not under city easement. Additionally, consideration to redevelop the property as a parking lot as part of the 2017 project. The assessed value was discussed. The cost of the property was talked about, the impending assessment was reviewed and the related costs would be funded by the Storm Water Fund. Approval was recommended.

Floodplain

The city planner discussed the Floodplain Mapping with the council. She explained that the area was in better standing presently compared to previous maps. The Carver Creek Circle properties were inquired about. The city planner stated that according to former maps the properties were shown to be in the floodplain. Presently, some backyards are still included due to elevation. Moving forward, help is offered to property owners working through the process as relevant. Motion was made and carried with all ayes authorizing the staff to submit the comment letter to the Federal Emergency Management Agency.

Ironwood Park Field Lighting

The council discussed background information relating to the Ironwood Park Field Lighting. The Parks Commission relayed to the council that they were happy to relay that the city was moving forward with the lights. The long term plan was that the Park Dedication funds would cover this cost. Motion was made and carried with all ayes awarding the Ironwood Field Lighting project to Laketown Electric in the assigned amount.

Suburban Rate Huthority

The city manager reviewed with the council the background information relating to the Suburban Rate Authority issue. Motion was made and carried with all ayes adopting the resolution authorizing the execution of the Cooperative Agreement with the Suburban Rate Authority. Appointment discussion followed. Motion was made and carried with all ayes appointing council member Mock as the delegate to the Suburban Rate Authority.

Hallblade Development

The city planner reviewed the background information regarding the Hallblade development with the council. Question was asked about the removal of a building on property. The structure was a garage and notes had been made on the map There were significant remarks submitted at the Planning Commission. The original plan had four lots, but the developer removed one lot on the southern portion of the property. Many comments received involved water run off and traffic concerns. The city planner explained that the developer is looking at two new homes on the two remaining lots. The Planning Commission reviewed the plat and recommended approval. Motion was made and carried with all ayes rezoning for the Hallblade Development. Motion was made and carried with all ayes adopting the resolution approving the Preliminary and Final Plat for the Hallblade Development.

Trinity Development ~ *Vincent Bluffs* The city planner reviewed the background information involving the

The city planner reviewed the background information involving the Trinity Development/Vincent Bluffs across from Spring Creek Addition. The council reviewed the item involving the Comprehensive Plan Amendment required. Motion was made and carried with all ayes adopting the resolution amending the Comprehensive Plan for the Butler property.

The Planning Commission members reviewed information supplied by the city planner pertaining to Trinity Development/Vincent Bluffs. The members would be discussing Meadows at Spring Creek for rezoning, the Planned Residential District and Preliminary Plat for the development of single family homes, outlots, right-of-way and related improvements. Trinity Development and Vincent Bluffs proposed platting approximately fifty acres for a development of single family homes and detached villas. The development was requesting rezoning from agriculture and industrial to residential. Single family homes would occupy the southern portion of the site. The facade would be similar to the homes developed in Spring Creek and Copper Hills additions. The smaller lots would consist of villa homes. A homeowner's association would provide exterior maintenance of snow removal and lawn care. Buildings are maintained by the property owner. Public Hearings required for rezoning and the Meadows of Spring Creek Preliminary Plat.

2040 Comprehensive Plan

The city planner informed the Council and Planning Commission members at a joint meeting that preparation of the 2040 Comprehensive Plan will be on the agenda. The review process was explained. This plan is utilized as a guide for the development of the community, population, characteristics, employment forecast, public services and infrastructure. The planner also gave a presentation of the Carver Snapshot. Members of the council and the planning commission discussed households and population estimates, transportation and employment growth. Also discussed was median housing value, owner occupied and median rents. Also reviewed was the stock of buildable lots for affordable housing, affordable threshold and what is a healthy balance.

The city planner also reviewed the Dahlgren Township proposed Orderly Annexation area map indicating that the map was adopted after the adoption of the 2030 Comprehensive Plan. Growth of the city and annexation progression was talked about.

The city planner reviewed the 2030 Future Land Use map. This map guides involves all the land within the entire Comprehensive Plan study areas. This map requires updating for the 2040 Comprehensive Plan. Discussions involved a current map displaying the current developments and new proposed development locations, as well as the areas possessing available infrastructure.

Administration Update

The city clerk/treasurer updated the council on the new rental space, Carver Place. Feedback on the new space has been good and many like the new arrangements. Forms and registration process updating continues. The Animal Impound Agreement has been finalized. The Countryside Veterinary Clinic will be utilized for impounds. Public Services personnel and staff continue work on the mapping of Mount Hope Cemetery. The new Administrative Assistant, Brenda Good was welcomed into the office setting.

Building Inspector

The building inspector reported activities to the council on various projects within the city. The Day Care Center identified as Children of Tomorrow Learning Center is in the process of reviewing the building plans. The dental office exterior was almost completed. The final certificate of the occupancy had been issued for the Central Homes development. Another permit will be issued for the Carver Ridge 2nd Addition, Mattamy Homes continues to be busy with construction and there is not any activity presently at Christy's Bluff. Riverview Estates continues construction with four houses. The inspector continuing work with "Do-It-Yourself" homeowners. The inspector is also continuing with the development of an application process and permit system for project that do not fit under the building permit requirements.

Fire Department

The Fire Chief updated the council on the statistics for the fire calls. Reminder to those interested, the Carver Fire Department is still taking applications to fill remaining positions. Anyone interested, contact the city staff, computer access on the city's website or Facebook. The department's new hires have all passed the medical portion of their training, and are fully certified The Carver Fire Grant Committee is working on several grants for the purchase of a new CPR machine and more.

Remember to also mark your calendars. "The Carver Fire Department is hosting a Spring Safety Event & Bike Rodeo again this year on May 20, 9:00-noon. With help from the Carver Lion's and the Better Society, we are going to donate helmets and 40 bikes to kids that need them. Children's Hospital will also perform six car seat checks."

Local Huthority

The city manager informed the council of the drafting of a resolution 'Supporting Local Control' explaining further that the 2017 legislative session had produced over two dozen bills that in part restrict or regulate decisions made on a local level by a city council. The council reviewed the summary of the proposed legislation impacting local control. If the council adopted the resolution supporting "local control", the resolution would be forwarded to Representative Jim Nash, Senator Scott Jensen and the League of Minnesota Cities. Motion was made and carried with all ayes adopting resolution supporting local control.

Depot Park

The Public Services Director informed the Parks Commission that money had been donated to be spent in Depot Park for landscaping. Feedback was requested. The commission members discussed possibility of landscaping around the water tower and caboose, move and cement the bike rack, new sign and updating the playground area.

Park Master Plan

The city engineer representatives discussed with the Parks Commission the outlined two-step Park Master Plan Project. Feedback was requested from the members to finalize the scope. The Commission members reviewed the analysis of the parks involving the Strengths, Weaknesses, Opportunities and Threats.

Annual Clean-up Day

The Public Services Director currently was working on the logistics for the Annual Clean-Up Day in Carver. The event has been scheduleed for later this spring. The date has been scheduled for Saturday, May 13th at 7 AM. (Flyer with information is attached at the end of the newsletter.)

Village Hall

The city held a "Village Hall Listening Session Review" meeting to get feedback from the community concerning the Village Hall issue. Additional comments had been received since their past meeting. Those observations were shared. Each council member gave their opinion and views. The city manager summarized the follow-up answers required: verification of hall as historic property or have asbestos; treatment plant site location in flood plain; construction option timelines; debt limit regarding tax capacity; do options affect developments; school uses capabilities; cost estimates on different configurations, inflation costs comparisons, and debt analysis. Additional research necessary on the topics involving renovation of village hall, meeting space square footage, and parking.

The city manager further discussed the Village Hall Options with the council. The manager reviewed the overview from the February meeting where the council approved a Communications and Engagement plan to initiate a community discussion on community space options developed by a resident led task force. The plan included mailings and online content, and traditional open house session. Additional information and research was collected and presented. A sixth option developed for an alternate concept. This new construction option consisted of a two-story building including city hall offices, dual-purposed space for community event including caterer's kitchen and city council chambers. The six recommended options being reviewed is Village Hall repair, renovation of the present hall; the Sixth Street property; south of the Fire Station site; former waste water treatment plant site and new construction of Village Hall.

Question posed and answered regarding is the Village Hall historic? The Village Hall is located in the Historic District, however, designated as "non-Contributing" to the listed district. The historic district time line is significant of the period of 1852 to 1900. Additionally, the Village Hall was modified in the 1990's with the City Hall addition.

The manager also answered some of the former questions asked. The building does not contain asbestos material.

The treatment site and the present Village Hall site are both outside of the traditional one hundred year floodplain but both sites are in the five hundred year floodplain maps. Properties within the one hundred year flood plain, with a mortgage are required to carry flood insurance. Construction timelines and debt analysis relating to all of the options was given at the meeting. One developer urged awareness of investment impacts on property taxes ensuring competitiveness with neighboring communities. Hartman communities' developer gave the opinion that investments in the historic downtown serves as an improvement of marketability of Carver to new home buyers. The school district forwarded information relating to rental policies and kitchen/cafeteria usage availability. An analysis displaying the impact of inflation to construction costs and its relationship to project growth in tax capacity was given. Debt services comparisons were presented at the meeting.

River Bluff Estates

The city planner provided an overview for the Planning Commissioners regarding the proposed amendment to architecture for the River Bluff Estates second addition. DDK Construction's representative stated that the proposal was to modify two level homes on nine of the western lots. Discovery was that the two-story homes do not have the market demand in villa home neighborhoods. It was the construction company's opinion that the one level villas met the market demands better. The one level villa would be less expensive and the architectture in the front would be consistent with the other homes in the existing neighborhood. The location of construction was verified. Motion was made and carried with all ayes approving the revised architecture for the housing units on the west side of Highland Drive in the addition.

Sixth Street Redevelopment

The city planner provided the Planning Commission members with an overview of the redevelopment proposals for the Sixth Street Property. Shingobee gave the members a proposed redevelopment project proposal. One of the commissioners expressed opinion of wanting to see diversity in the community. Question was asked regarding the integration and acceptance of a senior housing project into an existing single family neighborhood. The representative stated that meetings are held in the development process to educate the community and engaging the neighbors early in the process. The design of the building, parking, and storage were all inquired about. A market feasibility study would be done to determine and understand a viable mix of product that support the community. It was also indicated that dependent upon the demographics and what type of senior housing facility would be built. The next step in the process would be for the Planning Commissioners to analyze both proposed based on the evaluation criteria, review the information and then submit their recommendation.

2017 Street and Utilities Improvements

The city engineer discussed with the council approval of the resolution approving the plans and specifications, and scheduling bid opening date for the 2017 street and utilities improvements. These plans and specifications include reconstruction/curb and gutter on designated streets, utility work, alleys and streetscape improvements. The recommendation was to combine the work into one project bid as the results are an attraction of more bidders and more competitive pricing. The project schedule was discussed.

The Broadway Storm Sewer Flood Station was initially proposed to be included with this project, however staff is presently reviewing combining the two flood stations into one project. The other station is located by the old railroad trestle on Main Street East. More analysis is required. Plans are to combine the two stations and do the work in 2017.

Costs association with the project will be done through assessments, general funds and bonding. The estimated cost was reviewed. The staff recommended approval of the resolution.

The Planning Commission reviewed and discussed the improvements projects, as well as the Broadway Storm Sewer Flood Station. The Commission Action found that the 2017 Street Improvements, the 2017 Utilities, and the 2017 Broadway Storm Sewer Flood Station were all in compliance with the Comprehensive Plan. The city planner explained that the city council proposes the various projects as shown on the General Location Map described as street reconstruction with new curb and gutter, walk, and streetscape improvements along various project streets. The improvements will complete the reconstruction of the downtown streets that began in 2009 with the Metropolitan Council Environmental Services Interceptor Project.

"The streetscape improvements including bump outs, trees, and decorative streetlights along the two blocks of Broadway from 4th Street to 6th Street. 3rd Street between Broadway and Jorgenson is proposed to become a one-way street to the west with diagonal parking on the north side of the street. The one-way street will reduce some of the sightline issues for east bound traffic at Broadway. Drainage improvements are proposed near the bridge, and some weight restrictions are being considered for the bridge due to its existing condition. Paving of existing alleys in the area is being proposed, and a parking lot between 3rd Street West and the alley east of Jorgenson is being proposed as an alternate to the project. The City will review the pricing and make a decision to proceed with that alternate or not with the project."

There is also various sanitary sewer, water and storm sewer work proposed on the downtown streets as well. Also as part of the utility work scheduled the city is looking to extend sewer up to Well Number # 4. The Storm Sewer Flood Station work involves replacement of existing station at the south end of Broadway with new structures, pumps, controls and piping.


Carver- On-The-Minnesota

Mother's Day / Father's Day

Did you know that the nation's first father's day was not pro-claimed officially until June 19th in 1920 by the governor of the State of Washington? However, it was not until 1972, fifty eight years after President Woodrow Wilson made Mother's Day official, that the day became a nationwide holiday.

Mother's Day origins are post- Civil War era. During the 1860's, activist Ann Reeves Jarvis urged the celebration as "Mother's Work Days" bringing together Confederate and Union soldier's mothers. In 1870, the activist Julia Ward Howe issued a "Moth-er's Day Proclamation" calling for settlement and peace. Did you know there are more than seventy million fathers in the US?

Mother's Day did not become commercialized until 1908. Jarvis' daughter wished to honor her own mother. The John Wana-maker department store in Philadelphia sponsored a service dedicated to mothers. Thanks to this association and the retailers with the foresight to see profit in the holiday, the Mother's Day observance caught on right away. In 1909, forty five states ob-served this day and in 1914 President Wilson approved a resolu-tion making the second Sunday in May a holiday in honor of the mother's of America.


Celebrating fathers was not met with the same enthusiasm. It was the opinion that fathers did not have the same sentimental appeal as mothers. On July 5th, 1908 a church in West Virginia sponsor-ed the nation's first event honoring fathers. This was a one-time commemoration in the memory of three hundred sixty two men who died in explosions at the Fairmont Coal Company mines. The following year, a Spokane Washington mother, Sonora Smart Dodd, one of six children raised by a widower attempted to establish an official equivalent to the Mother's Day event.

Washington State celebrated the nation's first statewide Father's Day on June 19th, 1910. Then the holiday slowly caught on. In 1916 President Wilson honored the day using telegraph signals to unfurl a flag in Spokane. In 1924 President Coolidge urged state governments to observe Father's Day. Many men scoffed the notion.

It was in the 1920's and 1930's that attempts were made to scrap the Mother/Father Days observances favoring a single holiday for each as 'Parent's Day'. Each year groups rallied in New York's Central Park stating that the parents should be honored together. The Depression derailed this effort. By the end of World War II Father's Day had not been signified as a federal holiday, but it was a national institution. In 1972, Richard Nixon signed a proclamation making Father's Day a federal holiday.




