2019 Fee Schedule

The council reviewed and discussed the 2019 Fee Schedule and ordinance. Recommendations are being requested for necessary changes required for the following year. Upon adoption at a future meeting, the ordinance setting these fees will take effect January 1st, 2019. Changes in Planning and Zoning are also reflected in current costs. The Planning Commission held a Public Hearing considering the proposed fees changes relating to land use and will submit recommendations. Fees for Municipal utilities were also reviewed.

Municipal Utilities

The city attorney had been directed to amend city code sections relating to water and sanitary sewer connection codes. Currently, fees are charged for connection required prior to building permit issuance. Adjustment to fees and time lines are necessary. The attorney will address these timeless, fees, etc.

The city manager presented a drafted Connection Fee Ordinance for municipal utilities connection fees for review and a decision will be required at a future meeting.

Market Survey

The city manager informed the council that work is being done on a Classification and Compensation study. The council reviewed the issue of a comprehensive study proposed for the City of Carver for conducting market study. The public sector independent financial advisory firm of Springsted will conduct a comprehensive salary survey to determine appropriate levels in other comparable area labor market. The city's pay equity report is also due in 2019.

Based on findings, revision recommendation will be submitted. Evaluation of four new positions will be updated in the compensation plan. Analysis of wages will be conducted.

Meridian Fields

The city planner presented the Final Plat for Meridian Fields. The council reviewed Phase I of the development. The Final plat for Phase II would be looked at, at a later date.

The street name change was discussed. Question was asked why Minnesota Drive was renamed from Spring Creek Drive on the west side. Spring Creek Drive was a lengthy street, the Fire Department determined that in an emergency this would be cumbersome. The street was a mina collector serving several housing developments, therefore, the name change determination spot was the most effective due to size and anticipated volume.

Question was asked regarding coordinated work on Jonathan Carver Parkway study being conducted coinciding with the intersection of this development. The response was everyone was working closely together on the development. Question was asked about a future stoplight. It was anticipated that in the future this may be feasible.

Proposal was submitted to change the name of Minnesota Drive to Monroe Drive. Motion was made and failed to adopt resolution approving the final plat for Meridian Field with street names. Motion was made and carried with four ayes and two nays adopting the resolution approving the final plat for Meridian Fields with name change of Minnesota Drive to Monroe Drive and redirecting the plat being revised reflecting name change to Monroe Drive.

Storm Water Project

The city engineer presented the information on the 2018 Storm Water Project. Question was asked if the project would be completed this year. Some of the larger segments could be completed this year but no the complete project would be finished. The main lift structure would begin late fall, early winter. The project was on hold due to the river water levels. The engineer pointed out that winter construction was ideal for this type of project. Motion was made and carried with all ayes adopting the resolution to award the contract to Kusske Construction for the storm sewer improvement project.

Fire Relief Pension

The council reviewed and discussed the Fire Relief Pension Contribution. An increase was necessary and approved from the council was necessary. "Under State Law, a Fire Relief Association is a nonprofit corporation, separate from the city. With the authority to provide pension, disability and death benefits to its members through special funds (restricted) and to engage in other activities and spend monies out of their general fund (non-restricted) that the corporation by laws permit." A "Benefit Projections" analysis had been performed. The Fire Relief Association is funded through annual city and state contribution funds that are all managed by a private investment firm. These financials are audited annually.

Ironwood Park Hthletic Field

The council reviewed the subject of the Ironwood Park Athletic Field and to approve the payment for the lighting. The work had been completed, final testing and spotting of the lights was completed in the summer with city staff present. Final review was done and final payment was required.

Ironwood Park Pedestrian Bridge

The council reviewed the notion of replacing the Ironwood Park pedestrian bridge deck with wood versus concrete. Initially, the bid had been awarded to design, fabricate, and deliver the bridge to the site with a stated delivery time. A separate bid was then awarded completing the site work and installation of the bridge. Discussion was then held regarding the anticipated temperatures. This then required a Cold Weather Concrete Plan to ensure the integrity of the concrete construction. Costs were reviewed. The staff investigated an alternative option, replacing the deck with wood similar to the Spring Creek bridge. The change would avoid costs associated with the Cold Weather Concrete Plan. The cost difference ultimately lowered the cost of a concrete deck. The bridge would be delivered mid-December, upon delivery, set the bridge and functional. The final trail bituminous paving and restoration would be completed in the spring of 2019.

Utility Certifications

The council discussed scheduling Public Hearing for Delinquent Utility Certifications to the county. The staff was directed to prepare the required notifications. Delinquent utility amounts after November 9th would be added to the certification roll for the November 19th Public Hearing. If the roll were adopted at that meeting, the proposed amounts would be certified to the county auditor for a period of one year. The rate of interest would be five percent with an additional twenty-five-dollar administration charge for one year.

Design Carver

The city planner and the Planning Commission had reviewed the process and timing of the parks and trails portion of Design Carver/ Parks Master Plan (2040 Comprehensive Plan) Additional comments were requested. The current Parks Dedication Policy was discussed and updates were necessary to the policy to reflect suggestions in the 2040 Comprehensive Plan.

Discussions were also held regarding the baseball field requests. The board had been updated on the Carver Community Youth Baseball/ Softball Association's success. With the growth over the past few years, the association had added youth MBL and traveling softball team with expectations of even further growth. Upgrades and improvements have been requested by the association. These requests were discussed. Proposal for fence removal was also presented. Removal of the chain link fence at Bluff Park and Lions Park would achieve a more inviting park. Motion was made and carried with all ayes to remove the proposed fences.

The council and planning commission member held a joint meeting to discuss issues related to the 2018 Design Carver plan. Sections reviewed included the drafted housing section, parks and trails section, land use section, sanitary sewer plan and transportation plan. The plan update involved the drafted section of the 2018 Design Carver plan involving the land use, transportation, water resources, parks and trails and housing. Three sections were incomplete involving resilience, economic competitiveness and implementation. The group discussed survey results. The majority of the responses favored more commercial and set down restaurants and how the plan could help to facilitate that type of development.

Sunny Ridge

The city planner reviewed information regarding the Sixth Street property that had been acquired by the city. The Planning Commission drafted guided principals for the redevelopment of this site. This included a preference for senior living, moderate price point, existing trees and berm to be maintained, as well as preference for a two-story structure. Trident Development proposes a seventy-unit senior facility called Sunny Ridge with forty-nine assisted living units and twenty-one memory care units. Tealwood would facilitate operations. The project is currently being reviewed as a Preliminary Plat.

The representative from Springsted addressed the council with an overview of the Tax Increment Financing for the Trident Development. The city was requested to approve the resolution approving the Tax Increment Financing Plan for the Tax Increment Financing Housing. In the future reviewal of the Tax Increment Finance Development Agreement. The reporting structure was asked about. It was indicated that the report needs to be provided by the developer annually in order to maintain the certification of the Tax Increment Financing District. The project is intended for long-term. Resale terms in the Development Agreement were inquired about. The agreement could define the terms regarding resale and inserted into the agreement. Question was asked about expiration. Also questioned was the property usage change. A Public Hearing was held. There were not any public comments on the issue. Motion was made and carried with all ayes adopting the resolution establishing Tax Increment Financing (Housing) District within the development district number one and approving the Tax Increment Financing Plan.

Sunny Ridge Imendment
The council discussed the Sunny Ridge Comprehensive Plan Amendment and approval of resolution for a text amendment to the 2030 Comprehensive Plan. The application for the amendment had been submitted to the Metropolitan Council for review. The met council's review determined that the amendment contemplated the land use but also required a text amendment allowing the project to develop at the proposed density proposed by Trident. The staff recommended approval.

Joint Assessment Services

The county reviewed the service agreement for joint assessment with Carver County. Annually, the city contracts with the Assessor's Office for assessing services in the City of Carver. Services are performed by the assessor or by one of the other licensed assessors.

Levee Certification

The city manager and the representative from WSB and Associates (civil engineering) presented the council for review the proposal to complete the Levee Certification process for FEMA. The council discussed accepting the proposal from WSB and Associates to conduct a certified levee study. Over the last year, the city manager reiterated that the city has been working with the US Army Corp of Engineers pertaining to a feasibility study for a certified levee. The study would then ultimately lead to a design option for certification. Then that would eventually lead to the elimination of flood insurance requirements for mortgage holders in the downtown floodplain. Additionally, improvements would be made to the levee system improving the city's flood protection infrastructure. The anticipated certification and accreditation process included a feasibility study/design, plans and specifications, construction, engineering certification of the levee/private engineering firm and FEMA accreditation of the levee certification. An alternative to the process would be the city 'ls request from a private engineering firm. The city had met with private firm. Mead and Hunt had been authorized to prepare a data collection report. The existing Mead and Hunt scope indicates an amount for the completion of a 'feasibility study' for a certified levee study. Due to the cost associated with this proposal the WSB firm was contacted for a more efficient lower cost alternative for conduct-ing a certified levee study. The primary distinction between the two proposals involved WSB's expedited process to develop a concept for levee certification that could be used as a tool to develop funding opportunities for future phases of the project

Have you ever questioned why we vote when we do? Maybe no one really cares why? Research on line gave the answer for those who are now curious as to why we vote on Tuesday in November.

In 1845 Congress passed a federal law designated the first Tuesday following the first Monday in November. So that there would never be more than thirty-four days between election day and the first Wednesday in December. Also, election day is held on a Tuesday so that voters would not have to travel on Sunday. Huh you say? Keep reading. Prior to Congress' decision states were allowed to hold elections anytime within a thirty-four-day period before the first Wednesday in December but this system had a few crucial flaws. Such as it resulted in results affecting turnout and swayed opinions in states holding elections later, allowing last minute voting leaking to potential outcome decisions of the entire election. Congress created a specific date in hopes of streaming lining the voting process.

Does this explain why Tuesday? A two-day window for election day was necessary since 19th Century America in the 1800's comprised mostly of citizens who worked and lived as farmers far from polling locations. Often travel required at least a day. Sunday was the day of worship and Wednesdays were market days. Tuesday then became the first convenient and practical day to hold elections. Farm culture also depicts why November was chosen. Spring and early summer interfered with planting season, late summer and early fall are harvest time. Logically, November meant harvest was completed and before the harsh winter weather.

Furthermore, federal law since the 1840's dictated that presidential elections be held every four years on the first Tuesday after the first Monday in November. Modern society deems this to be an arbitrary time to hold elections. History however depicts a lot of common sense in 1800's living conditions. Also, under federal law the elections for the electoral college met on the first Wednesday of December. According to 1792 federal law, the elections in the states choosing electors had to be held within a thirty-four-day period before that day.

In early 1800 decades, communication was slow. News only traveled as fast as a man on horseback, or a ship could carry it. In the 1840's however, news traveled much faster. Rail road handled mail and newspapers were speedier. The emergence of the telegraph system really disrupted society in the day.

There you have it. Why we vote on Tuesday in November. For more information, visit history.com, thoughtco.com and Wikipedia. Some of the information is duplicated but there is more detailed information relating to voting, the times, the history and the reasoning. This author only gave basic information. Happy reading.

There are moveable holidays. The day after Thanksgiving is also known as Sinkie Day. The Great American Smokeout occurs. Here's a good one, National Adoption Day. There is Buy Nothing Day, Cyber Monday, and the usual days, election day, thanksgiving, etc. Then one has the weird holidays. This consists of Look for Circles Day, marooned without a compass, chaos never dies day, have a bad day day, false confession day, pretend to be a time traveler and stay at home because you are well day. The following was rather interest-ing, "Movember: It is quite common for some males in Australia (especially in the city of Melbourne), and New Zealand to sport a moustache during the month of November. The custom being known as Movember (Movember is a portmanteau of the words 'Moustache' and 'November'.), and being a fundraising event for men's health issues. One's fashionable appearance often comes second to the call-ing of Movember. A similar observance in the United States, called No Shave November, involves a full beard as opposed to a mustache."

Sadie Hawkins Day

Have you ever heard of or know what Sadie Hawkins Day is? Did you know that Sadie Hawkins Day is celebrated in November in Canada and the United Sates? It's November 13th in 2018. Did you know it originated from a cartoon?



It all began in Al Capp's "Li'l Abner" Cartoon in the 1930's. In the cartoon series, the mayor of Dogpatch was desperate to marry off his (politically incorrect "ugly") not so pretty daughter. "So, he created Sadie Hawkins's Day. On this day, a race is held and all the single men were given a short head start. Then, all the single women including the mayor's daughter, chased the boys. If a girl catches her man, he had to marry her."

During Al Capp's long running cartoon, races and events grew in popularity. Sadly, it died out after forty years when the cartoon was discontinued. Occasionally, it may be celebrated on college campuses. In the real world, Sadie Hawkins dances were inspired where girls asked the boys out.

Sadie Hawkins Day was first mentioned in November of 1937 in the daily comic strip. It would prove to become an annual feature of Li'l Abner. In 1939 Life Magazine had a double page spread proclaiming "on Sadie Hawkins Day, Girls Chase Boys in 201 colleges." In the early 1940's the comic strip event acquired a life of its own. By 1952, Sadie Hawkins Day was reportedly celebrated in forty thousand known venues.

The basis of the real Sadie Hawkins Day was simple traditional gender role reversal. The female gender would take the initiative to invite their male counterpart on a date – rare before 1937 – typically to a dance. When Capp created the event, his intent was not to have it occur annually. Due to its enormous popularity and numerous fan letter mail, Capp obligingly made it tradition in his annual November cartoon strip lasting four decades.

We hope you will join us!




Fare For All
