Transit Services

The city planner discussed with the council the transit services. An overview of the history of the SouthWest transit operations was provided including the Congestion Mitigation Air Quality grant and SouthWest Prime services. Representatives from SouthWest were also present to answer questions. Issues regarding the future beyond 2019 for the Congestion Mitigation Air Ouality Grant and the operations of the SouthWest Prime services will be discussed and considered in future meetings.

Miscellaneous

The new elected sheriff, Jason Kamerud introduced himself to the city council and was welcomed. He conveyed his strategy on proceeding in his position. In spring, it was his intention to hold a meeting to provide more background information. Invitation was extended to attend the Citizens Academy held by the Sheriff's Office.

Applications for the Building Inspector position were received. The new position will be anticipated to begin March 1st, 2019.

The city manager informed the council that a meeting was held with US Fish and Wildlife personnel involving the concern of the bridge on Ash Street owned by the organization but currently located on city property. The city owns a four-acre parcel and consideration is being discussed trading this property for the bridge property for an easement along the levee.

The Carver Black Sox were awarded the Regional Tournament to be held in August of this year the council was told. The Black Sox will be meeting with the council to discussed expectations and work on a plan of action.

In the future, there may be discussions regarding burying power lines in the Community Park.

Strategic Plan

The city manager gave an overview of the Strategic Plan identified two years ago updating the council on items. These items will be revisited at the upcoming planning session.

Highway # 212 Transportation Alliance A Highway # 212 Transportation Alliance meeting had been held

where it was relayed that the county is seeking additional resources for the four-lane expansion of the highway from Carver to Cologne with feasibly could happen in 2022. MNDOT and the county are working to secure rights-of-way along the corridor. The current turning configuration located in Cologne is being considered at the intersection of County Road # 43 and Highway # 212. An overpass is also being considered between County Roads # 11 and # 43.

## QakeView Industries

The city is in receipt of a letter from the MN Employment and Economic Development agency pertaining to the application for the Innovative Business Development Public Infrastructure Program Grant for the Lakeview Industries project. The letter involved relating amount approval for the portion of Commerce Drive.

The city engineer discussed with the council the subject of Commerce Drive involving approval of plans and specifications and ordering advertisement for bids. A resolution would be required. Construc-tion project had been identified by the city for an improvement north of Mills Gas Mart and Levi Griffin Road intersection constructing a public roadway, storm sewer, sanitary sewer and watermain infrastructure. Authorization for a feasibility study, improvement hearing and ordering improvements and preparation of plans had all been completed prior. The next step in the project is to consider approving plans and specifications and ordering advertisement for bids. The project schedule was presented and reviewed. Motion was made and carried with all ayes adopting the resolution approving the plans and specifications and ordering advertisement for bids for Commerce Drive.

Pay Equity Report

The council was told information relating to the 2018 Pay Equity Report submission due every three years. The report must show data in place as of the ending of December 2018. Pay equity is designed specifically to address wage structure. Pay equity primarily affects pay structure, no pay level or pay method. The report was under the guidance of Springsted Inc using job evaluation system meeting criteria established. The report required acceptance by resolution.

# 2019 Improvement Project

The city heard an overview of the 2019 Improvement Project to date from the city engineer. An open house was planned. A summary of findings would be communicated to affected residents. Plans to involve sidewalks and trails in the improvement area project were reviewed. In the past discussion's importance was placed on connectivity and uncontrolled intersections. An alternative was submitted by council member for consideration as the opportunity is presented at this time. Benefitting was an important issue, as well. The alternative was outside project plans. The alternate suggestions may not affect assessments, However, it would then create additional discussions on sidewalk placement, as well as requirements regarding Public Hearing. Suggestions were made by the city manager if the alternative were accepted, that funding from other sources be considered. The city manager indicated that there is a sidewalk fund. Gaps have been identified in project areas. These items could be discussed and dealt with as part of the strategic planning sessions. Another opinion interjected that the alternative should be added to the connectivity discussions and project focus on the proposed infrastructure improvements on the streets and sidewalks. Comment was made that everyone does not need a sidewalk. The walkability study identified ability to walk on trails and sidewalks versus on the road.

The importance of the issue was support or changes in language for communication to be forwarded to residents prior to the next meeting which will also include the summary of the findings. The four points highlighted pertain to typical assessments for new utilities cost adjustments, street widths, sidewalk installation with three-foot boulevard and five-foot walk and typical setbacks from homes, and traffic signage. Ability to make changes will still be available when approval of plans and specifications are done.

The council discussed approval of plans and specifications and the ordering advertisement for bids. The city identified the 2019 Infrastructure Improvements Project in the city's Capital Improvement Plan. The items were reviewed within the project. A feasibility study had been authorized, improvement hearing held, public open houses were held, receipt of the feasibility report, improvements ordered, preparation of plans done, additional public open house held. The summarization of comments were reviewed by the council. Some comments involved concern of impact on yards due to the new curb line, street name change, overhead electrical lines, support for planned sidewalk installation, trees, municipal utility connections and an appreciation of effort to reduce assessment amounts. Council consensus from comments and feedback received indicated that the project was generally supported. The next step of the project is consideration of approval of plans and specifications and ordering advertisement of bids. The project schedule timeline was reviewed.

The Open House forum was held with the council. Several comments received involved the measurements of the sidewalks and the boulevards. Motion was made and failed adopting the resolution approving plans and specifications and ordering advertisement for bids for the 2019 Infrastructure Improvements Project. Further discussions were held regarding assessments. One councilmember favored ninety percent of the project. Street construction was necessary. Disagreements reverberated regarding the sidewalks on Kirche. The mayor stated that sidewalks are necessary. Former discussions involved connectivity with sidewalks being a connector between 6<sup>th</sup> and 4<sup>th</sup> Streets. There have been discussions of sidewalks up to the street. Motion was made and carried with four ayes and one nay adopting the resolution approving plans and specifications including sidewalk adjacent to the curb and ordering advertisement for bids for the 2019 Infrastructure Improvement Project.

#### 2019 Legislative Priorities

The city manager relayed that the city annually adopted legislative priorities for the impending legislative session. These priorities have been included for the council to review and comment upon. Once adopted, these priorities would be communicated to the representative and senator. There were six Legislative Priorities that include Funding for Flood Protection Infrastructure, funding for Highway # 212, Protect Local Control / Oppose Preemption, Support of Opt-Out Transit Systems, Funding Resources for Streets and Infrastructure Fees. Motion was made and carried with all ayes adopting the 2019 Legislative Priorities.

#### Prime Service

The city manager discussed the topic involving the Prime Service Agreement with SouthWest Transit for the City of Carver. A motion was necessary to enter into an agreement. The city manager reviewed the topic. SouthWest Transit's Prime service is an "on-demand" ride service model providing primarily transportation to Eden Prairie, Chanhassen, Chaska and Victoria. The service uses ADA compliant vehicles that typically provide the "first mile / last mile" of transit service. Residents have received the Prime Service in 20117 and 2018 as a promotion associated with SW Transit's primary agreement out of the Carver Station. The city had not been charged nor had an agreement been in place during that specific time frame. Notification has been received that additional monies would need to be allocated to continue Prime Services in 2019. Due to the city's budget process and the timing of the notification, the service was discontinued. Subsequently, residents utilizing the service contacted the city.

The council reviewed the Prime service model and an overview of the overall transit operations grant out of the Carver Station. Services provided by Prime are not grant eligible. The topic was to be discussed at a future meeting regarding funding considerations for service in 2019. The city attorney drafted an agreement for Prime Services in coordination with SW Transit. With the present terms, the service would begin March 1<sup>st</sup>. As part of the agreement, SW Transit offers to only charge for trips origination out of Carver.

Several citizens voiced opinions concerning the SW Prime Service within the city. One citizen commended the city for listening, favored the services, cited knowledge of use of the handicapped accessibility van, the use of others to get to work and the need for said service with the future of a senior housing facility. Also noted was that WeCAB does not offer handicapped accessible vehicles. The city manager was requested to clarify costs. The city will be charged for the use and it can vary, said amount has been allocated. The council would be made aware when that amount is reached. Usage may vary in the future as the city advertises this service. Basically, the city will be subsidizing \$ 10 per service for each ride going out of the City of Carver. It was stated that the service is not only wanted, but needed. Reports will help to monitor. It was stated that the future senior housing facility has plans to have their own transportation available to residents. SouthWest's Board also has to approve the agreement and then the city would work to advertise the service. The mayor pointed out that not only is this a transportation issue, but also a housing issue. This service is necessary but must also be realized that it is a long-term commitment if approved. Motion was made and carried with all ayes to enter into an agreement with the SouthWest Transit for Prime Service in the City of Carver.

# City Parks

The city has been approached with a concept of having a semipermanent food truck in the Community Park parking lot. The notion for several reasons is unique. There would be policies to consider. These types of vehicles are usually more frequent during specific events, during weekends and visible for short periods of time. This concept would be self-contained with both drive-through and walk-up service. There would be no connections to municipal utilities, nor would it sit on a permanent foundation. The topic would be referred to the city attorney.

City Hall

Contractors, architects, engineers, project managers were all at the council meeting to provide an update on the city hall project. A construction recap, exterior and interior activities update, schedule and budget were all discussed. Their schedule for three weeks out is reviewed weekly with the city staff. Currently, the anticipated completion date is the end of May.

# River Bluff Estates

The city requested the city engineer and Bolton and Menk to review the River Bluffs development. The primary goal for the review was the existing streets and trail conditions. The development was platted and the Developer's Agreement executed in 2004. The development was not finalized regarding the street pavement. The original Letter of Credit funds were not utilized to complete the project and has since expired with Klingelhutz Development Company. A Developer's Agreement had been executed with Chestnut Group and DDK Construction for the River Bluff Estates 2<sup>nd</sup> Addition. This addition follows the general footprint of the original scope that essentially changed the house style and utility services modifications. The latest agreement and current letter of credit on file requires city acceptance of the second lift of bituminous on the existing trail located on the Home Owners Association outlot, as well as the permanent street surfacing.

Determination was further made that the streets and trails are privately owned by the Home Owners Association and that the city would not be maintaining. However, clarification in the Developer's Agreement is necessary by the city attorney.

The city engineer reviewed the street base course pavement. Based on the original agreement, base was paved in 2004. The original pavement was designed at that time to the city's standard residential section requirements.

It is the city engineer's results that shows significant signs of failure. Weather conditions have resulted in thermal cracking causing the beginnings of pavement failure. There are also signs of oxidation. The pavement has experienced many years of stress with only a base course lift installed. Street patching has settled as well in the areas of utility services reconfiguration. Visual breakdown was also viewed on the trail in an area.

The engineer submitted recommendations. Premature failure of the street is imminent due to the stress experienced without entire pavement in place. Paving over existing mat will not resolve the existing condition in place which would only degrade after the first winter. The pavement has degraded to the point where routine maintenance alternative will not correct the underlying problem and there will be ultimate failure foreseen. Full depth pavement reclamation is the recommendation. Reasoning was given for this recommendation. It was also stated repair is necessary to the curb line settlement which has occurred. The trail recommendation involved cutting out area and patching. Other larger cracks be filled with bituminous. Resolution would be achieved. The adjacent grass boulevard on each side would require reshaping and topsoil added to restore the established turf surface.

The infrastructure report regarding the River Bluff Estates was discussed by the council. The city engineer provided information regarding the background, findings and recommendations involving the infrastructure. He was asked to review existing base course street and trail pavement conditions, and the suitability for placing pavement over the existing pavement. Recommendations were also requested to be provided on the current status of the development.

A private street exists adding and complication. The Homeowners Association was seeking advice. The attorney also supplied more detail on the developer's escrow as part of the second agreement. The question was whether or not the city desired to become involved since it is not a city street. Different remedies are available. The engineer's recommendation would be costlier of the two alternatives. The city has two options: either it is considered a private issue or the developer is made aware of the city's requirements via the city attorney and city engineer. The council's preference was proper avenues be followed to repair issue. The issue at hand remains that this development is incomplete. It is the opinion that the developer has not adhered to the Developer's Agreement. A timeline had been created, expired and not met. The city attorney's opinion was default of required in the Developer's Agreement. Question was asked if pavement degrading occurred after the created timeline. The city engineer's response indicated that the conditions were possibly caused by the heavy equipment, not just time lapse. Question was asked why conversation was not held at the default date time. The city manager explained that a smaller development's usual process does not put the wear course down until the majority of the construction is completed. This situation is unusual due to the extended time and delays with this particular development. The city's liability was inquired about. The attorney responded that the Developer's Agreement identifies responsibility required by the city. It is further complicated because of a private street. It was the opinion of one on the council that the city not become involved. Another member supported preparation of latter to the developer identifying city requirements. Motion was made and carried with four aves and one nay directing the engineer and the city attorney draft correspondence requiring the developer to meet the requirements of the Developer's Agreement, specifically the reclamation of the existing base course and then paving the new base course and wear course.

# Green Ash Drive

The council was updated on the issue regarding the Green Ash Drive Eminent Domain Proceeding. In the spring of 2017, in order to extend Green Ash Drive from the Spring Creek subdivision into the Meadows at Spring Creek, a subdivision proposed to the East. The developer was unable to secure the cooperation of the property owners. Therefore authorized the commencement of an eminent domain proceeding to acquire a non-exclusive easement over a strip of land. The acquisition of the area was complicated. The city sought acquisition of an easement area, fee title to a much larger piece of property conveyed by a contract for deed. Disputes and issues prevented the agreement of any parties involved. Since a resolution could not be reached, the city authorized commencement of eminent domain as the extension of Green Ash Drive into the Meadows at Spring Creek, and utilities located underneath, were necessary for not just utility looping reasons, but also to address significant public safety concerns for the purposes of an ingress and egress from the Meadows at Spring Creek.

Three commissioners were appointed to view, inspect and conduct a valuation hearing. The respondents never expressed any interest effectively declining participation in the eminent domain proceeding. Title and possession of the Easement Area was transferred to the City of Carver in December of 2017. There was no activity in the proceedings throughout 2018. The attorney sought dismissal of the proceeding and obtain authority to file final certificate upon payment of the city's appraisal amount with accrued interest to the respondents. Mid-January contact was made that payment disputes had arisen. A settlement conference was conducted. The ultimate agreement was to settle for the amount offered in spring of 2017. A hearing to confirm the settlement has been scheduled. It was recommended that the city settle as proceeding with a hearing could be costly. It was the opinion of the city attorney that the settlement is fair, reasonable, just and appropriate, recommending approval of the settlement and directing the city manager to execute the Settlement.

The city attorney provided information relating to the Green Ash Drive easement acquisition process to the council. The city manager was thanked for his participation in resolving and settling the matter. Motion was made and carried with all ayes adopting the resolution approving the terms of the settlement agreement to settle an Eminent Domain Proceeding Pending in Carver County District Court and directing the city manager to execute the settlement agreement.

Oak Tree

The Planning Commission members reviewed with the City Planner the Final Plat, Phase III in the Oak Tree Development. The final plat for final review was presented by the City Planner. Phase III involves ninety-seven single family homes on lots on the western half of the total project area. Phase III includes connection to Dahlgren Road.

Question was asked regarding a portion in the southwest corner the of the property. The city planner explained that this area gives access to Public Services to maintain the pond in that outlot and the city will also maintain that portion between two lots. Motion was made and carried with all ayes recommending approval of the Final Plat for the Oak Tree Phase III development.

#### United Properties

The city planner discussed with the Planning Commission the Concept Plan for United Properties. There was not any formal action necessary. The location of the topic is the southwest corner of Jonathan Carver Parkway and Highway # 212. The property is pending annexation. The parcel has been guided for commercial development since the 2008 Comprehensive Plan. The property is anticipated to fully develop with commercial users. At this time the concept plans involve a gas/convenience user on about one and three quarters acres with access from Monroe Drive. Upon approval of annexation request, rezoning application would be anticipated to be submitted rezoning of Freeway Commercial with a Planned Commercial District Overlay. United Properties and D R Horton have worked closely with construction of Monroe Drive. The county will review the Concept Plan. Utilities will be extended from Monroe Drive, a sidewalk running the length of the property and a traffic study has been submitted that will be reviewed by the county and the city.

Wireless Ordinance

The city planner and the planning commission members discussed Small Cell Wireless Ordinance. Recent changes to small technology equipment through the Minnesota legislature. Primary changes involve the Right-of-Way user statute allowing small cell technology to be permitted use in rights-of-way throughout the city with limited restrictions. Under the current law, small cell technology is permitted throughout a community with limited ability for cities to regulate their placement and impact. Cities are not allowed to prohibit small cell technology equipment in any district under current law but most communities have a permitting process through right-of-way ordinance. The City of Carver maintains an ordinance requiring both a permit and fee for any work within the right-of-way. Adherence to the ordinance will continue. However greater considerations are required to be giving to areas that may have an adverse impact on small cell technology. The city planner reviewed the small cell facility defined in the statute. Discussion and potential updates to the city code would require small cell technology a conditional use both in residential districts and throughout the Historical District. This approach would afford the city to review information with Planning Commission, council and interested parties through a Public Hearing. The definition of small cell technology would be added to the city code. This process would then permit small cell technology continuance in commercial and industrial zones but a conditional use for residential and the Historic District of Carver.


Carver Current

#### Almanac Trivia Information

Did you know that March was named for the Roman god of war, Mars? This was the time of year to resume military campaigns that had been interrupted by winter.



Was there really a St Patrick? Definitely. Did he really drive the snakes out of Ireland? Probably not, since snakes weren't native to Ireland.

St Patrick was born in Britain as Maewyn Succat. At age 16 ( around ad 400 ), he was kidnapped from his home on the west coast and carried off to Ireland to become a slave who worked as a shepherd. After six years, he escaped; upon returning home, he received his call ( in a dream ) to preach the Gospel He spent the next 15 year or so years in a monastery, preparing for his missionary work. When he became a priest, his name was changed to Patricius, and eventually, Patrick. Although some Christians lived in Ireland at the time, it was Patrick who spread Christianity throughout the land and brought an organized church into existence.

Daylight Saving Time: In March, we spring forward. How did this practice of Daylight-Saving Time (DST) begin?

The Old Farmer's Almanac ( around since 1792 ) answers your question

What is Daylight Saving Time?

Daylight Saving Time is the practice of changing the clocks forward one hour from standard time during the summer months, and changing them back again in the fall. The general idea that this allows us all to make better use of natural daylight; however, DST has many detractors. Note that it's called "Daylight Saving" ( not "Savings" ). Okay, now that that's out of the way....

When is Daylight Saving Time 2019?

When do we set our clocks forward? Daylight Saving Time begins on Sunday, March 10, at 2 AM. Remember to "spring ahead" and set your clocks forward one hour ( ie. losing 1 hour ). ( We do this on Saturday night when we go to bed. )

When do We Set our Clocks Back?

Daylight Saving Time ends on Sunday, November 3, at 2 AM. Now, we "fall back" by setting our clocks back 1 hour ( IE: regaining 1 hour ).

( The exceptions to DST are American Samoa, most of Arizona, Guam, Hawaii, Northern Mariana Islands, Puerto Rico, and the US Virgin Islands. )

Why is There Daylight Saving Time?

Here's the short history of this phenomenon....

Credit for Daylight Saving Time is often attributed to Benjamin Franklin, who suggest the idea in 1784 as a joke. British-born New Zealander George Hudson proposed the concept in 1885 but was ridiculed. The idea was revived in 1907, when William Willett, an Englishman, proposed a system in the pamphlet *The Waste of Daylight*.

The Germans were the first to officially adopt the light-extending system in 1j915 as a fuel-saving measure during World War I. The British switched one year later, and the United States followed in 1918, when Congress passed the Standard Time Act, which established our time zones. This experiment lasted only until 1920, when the law was repealed due to opposition from dairy farmers (cows don't pay attention to clocks ).

During World War II, Daylight-Saving Time was imposed once again ( this time year-round ) to save fuel. Since then, Daylight Saving Time has been used on and off, with different start and end dates. Currently, Daylight Saving Time beings at 2 AM on the second Sunday of March and ends at 2 Am on the first Sunday in November.

# Rgute # 66

In this day and age, either you know, have heard about, or know nothing about the famous Route # 66. There are songs, there was a television show, commercials, novel, or you had relatives experience the Route # 66. It's legendary, it's part of the nostalgia era, a powerful symbol of escape and loss. Ever since November 11th, 1925, driving down Route # 66 had been an



experience of a lifetime. Route 66 was officially decommissioned in 1985. The History 66 website provides information for anyone interested in learning more. While officially Route 66 no longer exists, the majority of it remains to be driven and enjoyed. Officially, the route does not exist any longer, but the majority remains to be enjoyed and driven on. The journey takes you through eight states which includes some background information on many roadside attractions that still dot the landscape. For many the trip is a trip down memory lane. Thanks to preservations organizations, volunteers, and business owners any of the landmarks can still be admired. Some treasures have disappeared. Modern road maps and GPS systems are very poor at indicating where the route ran and signs can be spotty or even missing of the old two-lane highway. "You will need a detailed map and guide before hitting the road and getting your kicks on Route 66!" You can find that detailed map on the website, www.historic66.com. The website is also celebrating its 25th anniversary in 2019! The route takes you through Chicago, Illinois, Missouri, Kansas, Oklahoma, Texas, New Mexico, Arizona and ending in Santa Monica, California.

Route 66, alias US 66, Will Rogers Highway, the Main Street of America, originally Highway 60 or the Mother Road was one of the original highways in the US Highway System. Some extra trivia information about the route is that several stretches are quite preserved, Kansas only has thirteen miles of the route 66 fame, parts of the route followed the National Old Trails Road, and during its existence the route was under constant change. In the 1930's during the Dust Bowl it was a primary route migrating west. The route supported the economics of the communities, businesses prospered from the growing popularity and the same folks fought to keep the highway alive with the increasing threat of bypasses by the new interstate highway system. Route 66 underwent many improvements and realignments over its lifetime. It was replaced by segments of the interstate highway. Portions of the route through Illinois, Missouri, New Mexico and Arizona have communally designated a "national Scenic Byway bearing the name "Historic Route 66" with the return of the name on some maps. Several states adopted bypassed sections into their state road networks as State Route 66. A corridor is also being redeveloped into the US Bicycle Route 66, as a part of their system developed in the 2010's.

Because of the geography, traffic grew on the highway. Much of the highway was flat making it a popular truck route. During the 1930's many headed west and US 66 became the main road of travel for many from Oklahoma and Arkansas. During the Depression the route gave some relief to communities located on the highway. The route passed through numerous small towns helping to create popularity of the mom-andpop businesses, like service stations, restaurants and motor courts. Much of the early highway was gravel or graded dirt. From the efforts of the US Highway 66 Association, it became the first highway to be completely paved in 1938. Several placed were dangerous. One part of the highway was nicknamed "Bloody 66". Realignment of these section was done removing dangerous curves. One section in Arizona has frightening hairpin turns and was the steepest along the entire route.

The section remained as US 66 until 1953 and still open to traffic knowns as the Oatman Highway. Despite such hazards the route continued to be popular.

During the 1950's, US 66 became the main highway for vacationers going to Los Angeles. The route took you past the Painted Desert, near the Grand Canyon, Meteor Crater in Arizona was another popular stop. This type of travel increased the burgeoning trade in all manner of roadside attractions. The fast food industry was marked as their birth. The first drive-through restaurant in Missouri along with the first McDonald's in California. These landscapes changed cemented the routes reputation as a near-perfect microcosm of the culture of America linked by the automobile.

Since the 1950's, as interstates were being constructed, section of the US 66 experienced traffic using those interstates and it was a faster means of travel. The displacement of the US 66 signage to the new freeways, combined with restriction in the 1065 Highway Beautification Act it often denied merchants on the old road access to signage on the freeway, all factors in the closure of many established US 66 businesses as travelers could no longer easily locate them or gain access to them. The route was also a foundation for many chain stores back in the 1920s, sprouting up next to it to increase business and sales. The beginning of the decline for the route came in 1956 with the signing of the Interstate Highway Act. During the nearly sixty-year existence, US 66 was under constant change. Highway engineering became more sophisticated and more direct routes were sought. By the late 1960's, most of the rural section of US 66 has been replaced.

Highway officials planned for the last section of US 66 to be bypassed by interstates in Texas, but as was the case in many places, lawsuits held up construction. The US Highway Association has become a voice for those fearing the loss of their businesses. In 1984, Arizona also saw its final stretch of the highway was decommissioned. Finally, with desertification of the highway by the American Association of State Highway and Transportation Officials the following year, US 66 officially ceased to exist.

When the highway was decommissioned, section was disposed of in various ways. Although it is no longer possible to drive US 66 uninterrupted all the way from Chicago to Los Angeles, much of the original route and alternate alignments are still drivable with careful planning. Some stretches are well preserved, some section retain their historic "sidewalk highway" form. The first Route 66 associations were founded in Arizona in 1987, and in 1989 Missouri. Other groups in the US 66 states soon followed in the revival of 'Route 66'. The State of Missouri declared US 66 as a "State Historic Route" in their state in 1990. Other historic markers now line, at time sporadically, the entire 2, 400-mile length of the road. In many communities, local groups have painted or stenciled the '66' and shield directly onto the road surface. Various sections of the road itself have been placed on the National Register of Historic Places. US 66 has been a fixture in popular culture.

The history of the route is lengthy and can be found on the internet on Wikipedia. It is very informative and interesting, as well as far more detailed for anyone interested in learning more.


