### Announcement Alext!

Per the city manager, be prepared for construction to begin on the northern section of Jonathan Carver Parkway closer towards the highway and north of the school area. The city has issued an announcement of proposed construction work to begin. They will be adding turn lanes at the intersection of Spring Creek Drive and the future Monroe Drive. The construction schedules a start date as early as June 17th with two to three weeks of expected construction depending upon weather conditions. If weather is not accommodating for the June start date, the work will then tentatively be started around July 8th, again dependent on weather conditions. The anticipated work will add dedicated left turn lanes in both directions and a right turn lane will be added to Monroe Drive. Jonathan Carver Parkway and Spring Creek Drive will remain open to traffic during the construction.



## Commerce Drive

The city council scheduled a Public Hearing to approve an ordinance renaming Dauwalter Road south of Levi Griffin Road to Commerce Drive. Commerce Drive is being constructed alongside the Lakeview Industries project which will serve future development focusing on Commercial/Industrial usage. The name denoted the types of development proposed and serve as the city's largest exhibited zone. The alignment connects to the small stub allowing access to Mills Fleet Farm Gas Mart currently identified as Dauwalter Road. There are not any properties presently addressed and Dauwalter Circle is proposed for a street in the Phase II Meridian Fields development.

The city council held a Public Hearing regarding the Commerce Drive issue. The city staff recommended the name change from Dauwalter Road to Commerce Drive as this will serve future development designed for the Commercial/Industrial area users. Dauwalter Circle is a proposed street in Phase II of Meridian Fields to retain the historic name in the community. There were not any public comments at the Public Hearing. Motion was made and carried with all ayes adopting the ordinance renaming Dauwalter Road south of Levi Griffin Road to Commerce Drive.

## Boulevard Maintenance

The city manager discussed background information regarding the Boulevard Maintenance discussions having been held in the past. Question were asked. The city attorney confirmed that only one of the three options was necessary. Notifications would be forwarded to property owners who are responsible for property maintenance. If the issue were not taken care of the city manager's preference was to 'hire out' and the bill then assessed to the property. Inspection fees applies on violations when the city was required to inspect. Motion was made and carried with all ayes adopting the ordinance pertaining to Boulevard Maintenance.

Carver County Library
The Carver County Library Director addressed the city council providing 2019 library highlights, circulation statistics, and information relating to the express libraries. The report was included in the council's packets.

# Certifted Levee Project

The city manager discussed the background information relating to the Certified Levee Project and the resolution of support. Reminder was voiced that this was for support only, not any authorization for funding. If the resolution were adopted, then it would provide the staff direction to pursue funding opportunities. Community education events and open houses would be scheduled in the future as information becomes available. Question was asked and responded that the resolution did not approve the project only moving forward to investigate funding opportunities.

The most recent plan presented has been the best plan presented thus far. A starting point for the city. Flood insurance is the barrier to the downtown area presently. The support resolution also has a broader benefit to the entire community. The mayor pointed out that this is going to be a marathon, not a sprint and could take up to ten years for completion and is supported totally. Comments reiterated that it was a community project benefitting the entire community. The materials clarified in the design standards need to align with FEMA. The city cannot do this project solely. Partners are a necessity and question if opportunities are being lost because of that deficiency. Motion was made and carried with all ayes adopting the resolution supporting the Carver Levee Certification Project.

## Carver Business Alliance

The Carver Business Alliance is a group of Carver businesses that meet every third Friday of the month at 8 AM at the Carver Place. Anyone owning a business in Carver is welcome. The next scheduled meetings are June 21st and July 19th.

# Grant Agreement

The city planner discussed the issue involving the grant received and authorization of the mayor and staff to execute the agreement. The city had received the Innovative Business Development Public Instructure (IBDPI) grant through the Department of Employment and Economic Development (DEED) for the construction of Commerce Drive which is the road north/south extending from Live Griffin Road to provide shipping access to Lakeview Industries and future commercial and industrial development anticipated in the future. The city attorney reviewed the agreement.

Request has been submitted for approval allowing the mayor and staff to execute the agreement. The total estimated project costs were reviewed, along with the grant amount awarded. The balance of the amount for the match for grant dollars will be funded through the approved Tax Increment Finance District for Lakeview Industries.

# Carver Bluffs West

The city planner presented an overview on the topic of the Carver Bluffs West acceptance of improvements and the resolution to be approved. Previously, the platting of Outlot F was platted with the potential for future development is the property directly south developed thereby requiring access to the site. Those anticipated strategies are no longer viable. The MN Valley National Wildlife Refuge Trust has acquired the property to the south and will be held in conservation. These actions disallow access for Outlot F. Hans Hagen, the current owner of the outlot is donating said property to the MN Valley National Wildlife Refuge Trust since it no longer has development potential. As part of the resolution, a condition was that the council accepts the work completed on this subdivision. The staff was unable to determine whether or not a resolution as processed after completion of Carver Bluffs West. The resolution presented presently accepts the improvements in the subdivision allowing Hans Hagen to donate the land to the MN Valley National Wildlife Refuge Trust.

# Water Filtration Skid

The Public Services Director discussed with the council the purchase request for a water filtration skid. He gave an overview of past activities involving the rental of a skid per past approval from the MN Department of Health as a pilot project to determine if unfiltered well could meet the summer peak demand. Two years of testing has yielded approval to move forward with permanent installation of filtration skid system. Working with a local contractor and the filtration skid permanently installed the treatment capacity has increased. The flow averages were discussed, along with the Mt Hope water treatment plant. With the addition of the proposed second filtration skid the water treating capacity increased. Also, it gives the city adequate time to plan for the next steps for providing quality treated water.

The Public Services Director continued discussions with the council regarding information for the purchase of a water filtration skid that would give the city adequate time to plan for the next steps for providing quality treated water to the residents. Question was asked if the skid would be added to the existing skid. The director explained that the fist skid was set up for an additional ski, therefore only a few pieces were necessary to complete the connection of the two systems. Motion was made and carried with all ayes approving the purchase of a water filtration skid from Vessco Inc in the stated amount.

## Miscellaneous

City council members and staff were given a construction tour at 316 Broadway of the new city hall construction site.

The City Manager presented an overview at the council's work session of employee compensation report that was completed by Baker Tilly.

The previous conversation held by the council regarding food truck being allowed in city parks was briefly discussed. Research by staff on ordinances and polices in other cities has been conducted and continues to be examined. Request was submitted for further direction on specific policy decisions being expected. Additional feedback was shared and the city planner will draft an ordinance for review.

# Design Carver

The city planner presented the Planning Commission with the Design Carver / 2040 Comprehensive Plan for review and feedback. A Public Hearing was required prior to the plan being submitted to the Metropolitan Council for their review. Planning Commission recommendations would be submitted to the city council prior to consideration of the resolution allowing submittal to the Met Council. There were not any comments from the public at the hearing. One commissioner commented that it was their opinion that the plan was a very impressive document, detailed, readable and available on the city's website. The Planning Commission recommended submission of the Design Carver Plan to be submitted to the Met Council.

The city planner requested approval of the resolution allowing the city planner to submit the Design Carver to the Metropolitan Council. The city planner presented an overview of the former discussions regarding updates of their Comprehensive Plan every ten years to the Metropolitan Council. Then the Met Council sets the framework and outlines requirements to the local units of government with the planning process. The Steering Committee hopes that the plan serves as a dynamic tool that is accessible to residents, members of the development community and staff. The Steering Committee worked through drafts, concepts and policies setting the tone for Design Carver. Survey results were included as an appendix to the Design Carver to be utilized supporting the goals and policies throughout the document. As part of this process, the Met Council prescribes steps that must be taken prior to plan submission. Adjacent communities and jurisdictions have six months to review and comment on the drafted plans. For informational purposes the affected groups are the City of Chaska, Dahlgren Township, Jackson Township, Louisville Township, San Francisco Township, Carver and Scott counties, Eastern Carver County School District # 112, Carver County Watershed Management Organization, Lower MN River Watershed District, Watershed Management Organization, Scott County Department of Transportation and the MN Department of Natural Resources. The comment deadline formally closes in June of 2019.

The city planner informed the council that the 2040 Comprehensive Plan/Design Carver had been sent to the jurisdictions. The Planning Commission held a Public Hearing, reviewed the documents and that there had not been any formal comments received at the Public Hearing. The Planning Commission's recommendation was to submit the plan to the Metropolitan Council.

Question was asked if the city had received the draft plan from the City of Chaska and if so, how it compared for plans in the area bordering the city. The city planner responded that the areas where Victoria, Chaska and Carver come together had been taken into consideration and will be reviewed with Future Land Use Map. Question was asked regarding the entities working together. The city planner explained that the City of Carver had requested an extension so it was a little more difficult as the city was a little behind in developing the maps. The three cities did work together and will likely be collaborating in those areas. Property bordering Carver is zoned largely as commercial industrial users and Chaska's borders are largely green open spaces, but with the new interchange there likely will be an additional commercial and industrial users. Question was also asked about the Met Council submitting comments or recommendations in areas of cities abutting one another. The city planner responded that the council does not typically look for conflicts, rather their focus is on traffic plans, street types and things next to each other work together. Comment was made that the Future Land Use Map was a valuable tool. Motion was made and carried with all ayes adopting resolution allowing the City Planner to submit Design Carver to the Metropolitan Council.

# Alley Vacations

The city council reviewed the resolution pertaining to the vacation of two alleys within city limits. The City of Carver was originally platted and recorded in 1897 per the City Planner. Several streets and alleys continue to exist in the original plat that are no longer used or maintained by the city. Presently the council reviewed two alleys proposed for vacation that are unpaved and there are no city utilities. These vacated alleys would be split evenly between the property owners on either side once vacated. There would not be any financial impact as a result of this vacation, however, a required Public Hearing was necessary.

# Community Park Improvements

The city planner discussed consent to improvements with Xcel Energy with the council. A motion to authorize execution was necessary for Community Park by the Carver Black Sox. The council was informed that the Carver Black Sox have been working on improvements to their field for their hosting of the state tournament to be held this summer in Community Park. Powerlines run through the park and an easement is in place. The Carver Black Sox worked with Xcel Energy to have the opportunity to construct a press box for the tournament within this easement area. The Consent to Improvement document allows the work to be completed in the easement area in the Community Park which had also been reviewed by the city attorney.

The city planner discussed the waiver agreement with Xcel Energy for construction in Community Park with the council. The Carver Black Sox requested to make improvements to their field involving power lines through the field.

The Black Sox worked with Xcel Energy. Xcel Energy submitted a Consent to Improvements Agreement to the council allowing work to be completed in the easement area in the park. Question was asked regarding their ability to already go ahead and do work. The city attorney explained that Xcel is effectively asking for a release from the city for any liability and an expansion of some right not currently in the easement. The press box would be within the easement area. Councilmember Sayre asked if there was clear ownership on the press box. Ownership of the press box was inquired about. The attorney pointed out that the issue is not resolved and Xcel is not concerned about the ownership. The permit and consent is with the city. The city Manager clarified that any permanent structure within the parks is considered city property. Xcel Energy composed the contract, the attorney reviewed and approved the contract. It was necessary for the council to understand and recognize what would be given up. Question was asked about permits for construction and a permit would be required. Motion was made and carried with al ayes authorizing execution of consent to improvements for the Community Park.

# Meadows at Spring Creek

The Planning Commission members reviewed the request for the final plat for Meadows at Spring Creek Phase II.

The property is located east of the Spring Creek neighborhood and south of old Highway # 212. Phase II includes the remaining seventy-four lots platted through the Preliminary Plat application. Question was asked about the gap in the sidewalk along the old highway. The city planner explained that this was the trail connection on Mt Hope Road and is private property and being actively worked on. Phase I plans are for seventy-seven lots and Phase II has seventy-four lots. Question was asked regarding the difference in the definition of a villa single family home and a regular single-family home. The city planner explained that villas are typically smaller lots and managed by a Homeowner's Association. She also stated that most are one level but there is an option to add a second level. Motion was made and carried with all ayes recommending approval of Phase II of the Final Plat for Meadows at Spring Creek along with Planning Commission's recommendations.

The City Planner discussed with the council the resolution approving the Final Plat for Vincent Bluffs of Carver for the Meadows of Spring Creek Phase II. Application has been received for Final Plat for Phase II of Meadows at Spring Creek identified as Vincent Bluffs of Carver. The first seventy-seven lots of Phase I of the Final Plat were previously approved. Construction has been active with several homes in various stages. Vincent Bluffs of Carver was prior for Final Plat approval of the remaining seventy-four lots that were platted through their Preliminary Plat application reviewed by the Planning Commission ins 2017. No major changes occurred. The property was rezoned. Access to the development is extended from Spring Creek Drive and Green Ash Drive.

### Meridian Fields

The city planner presented the Planning Commission members with the Final Plat request for Meridian Fields Phase II. It is located also south of the old highway, west of Jonathan Carver Parkway and northwest of the elementary school. Recently annexed into the City of Carver and consists of approximately forty-six acres. Phase II considers final approval of the remaining forty-seven lots for Meridian Fields Development. Question was asked regarding the naming of the road Dauwalter Circle. It was the intention to retain the historic name within the city, therefore the street within Meridian Fields would bear the namesake of Dauwalter Circle. Motion was made and carried with all ayes recommending approval of Phase II of the Final Plat for Meridian Fields, along with conditions recommended by the Planning Commission.

The City Planner presented the council with the request from D R Horton who has applied for the Final Plat for Meridian Fields Phase II. Phase I of the Final Plat received approval for construction to begin. Presently work has been done on the construction of Monroe Drive. Recently application for building permit for the model has been made. Phase II involves approval of the remaining forty-seven lots in the development. There have not been any major changes from the Preliminary to Final Plats. Property was rezoned and the proposed homes meet city code.

Access into the development will be from the new collector street, Monroe Drive and will include a sidewalk on one side throughout the development. A trail will also be constructed access from Minnesota Drive

# Carver Commons - United Properties

The city planner presented the Planning Commission members with information relating to the Carver Commons, Preliminary Plat, Rezoning and Final Plat by United Properties. Property location at the corner of Jonathan Carver Parkway and Highway # 212. The Planning Commissioners were being asked to reviewed both the Preliminary and Final Plat simultaneously, creating a building pad that could be constructed at a later date. There is not any contemplated end user, only creates a lot that could develop. All of this is an option since changes are not anticipated between the two documents. Due to annexation, rezoning is an automatic request and the proposed property requests rezoning to commercial with a planned Commercial Overlay District. Carver Investment and United Properties has owned the property since 2006. Recent development created the opportunity for them to develop. The parcel has been designated for commercial development since the 2008 Comprehensive Plan and stayed consistent through the Design Carver planning process. Commercial use for development is anticipated. The area presently being reviewed consists of roughly one and three quarters acre of the total thirty acres. The balance of the site will remain an outlot until users are identified. Monroe Drive will serve the property. A traffic study was completed with this project. When the end user applies for platting, a temporary signal will be installed at the intersection of Jonathan Carver Parkway and Monroe Drive. During the Jonathan Carver Parkway project, a permanent signal will be installed. Recommendation was made to hold a Public Hearing, provide recommendation to the city council on rezoning, preliminary plat and final plat.

## Easement Vacation

The city planner discussed with the council the resolution involving vacating drainage and utility easements for Meridian Fields property. Explanation was given regarding at the time of platting Phase I for Meridian Fields, drainage and utility easements were recorded over three outlots. Areas that were included in that platting are now being considered for platting through Meridian Fields Phase II which is not possible to plat over a recorded drainage and utility easement. Vacating these easements allows for platting and recording for Phase II. A Public Hearing would be necessary without any financial impact in doing so. The council reviewed the resolution for vacation of these easements.

Song Property Concept
The city planner introduced the Planning Commission members to the Song Property Concept. The applicant was Summergate Companies. Property roughly one hundred sixty-one acres west of Carver Elementary School, north of Copper Hills. A concept plan proposes ideas to the Planning Commission and council without formal commitment.

An Environmental Assessment Worksheet is a document providing information determining project environmental impacts associated with the project, and required if more than two hundred forty units of residential development. Property is currently in Dahlgren Township.

The development team proposed a mix of single-family homes and townhome units. Due to the mix of housing types in the concept plan, the developer requested review of a Planned Residential Development allowing deviation from the city's zoning code, common throughout Carver's development history. The current adopted Comprehensive Plan and Design Carver have guided the property as low density residential allowing two to four units per acre. The proposed development however, does not meet with the recommended three units per acre per the City of Carver nor set by the Met Council. Several streets currently lead to the Song property. Streets, access and sidewalks were all generally previewed in the concept plan. There was no formal action requested. Feedback to the developer and the staff would be accepted.

## Fire Department

The Fire Chief and Deputy Fire Chief were in attendance at the council meeting to discuss the request for the Fire Engine Acquisition request and authorization to prepare plans and specifications for the acquisition. The two representatives from the Fire Department presented information for the replacement of the Engine 12 and Tank 11 with a pumper/tanker. It would be roughly ten years before another request would be placed for a large capital purchase. The department had received a grant for a fan. Question was asked regarding disposal of the old truck. Response was given that the manufacturers were not interested in purchasing the vehicle, however, public services personnel had some ideas. Question was asked if the other truck would be returned to the DNR and the response was that was correct. The request for the new vehicle would not be used. The general interpretation from the township was favorable. The mayor stated that there was a lot of support. Motion was made and carried with all ayes authorizing the preparation of the plans and specifications for a new fire engine.

## Reimbursement Resolutions

The council reviewed the resolutions involving reimbursement resolutions with the City Clerk/Treasurer. The first resolution involved establishing procedures relating to compliance with reimbursement bond regulation under the Internal Revenue Code for the New Water Treatment Plant. The second resolution involved establishing procedures relating to compliance with reimbursement bond regulations under the Internal Revenue Code for the new well siting. An overview reviewed involved the discussion of when the city issues bonds for a capital project, they are not allowed to reimburse themselves for costs incurred for the project prior to the bond issuance date unless a reimbursement resolution is approved prior to issuance. Most cities establish procedures to ensure compliance with the regulations. This action does not approve the project, but establishes a process to reimburse with future bond proceeds for expenditures incurred in advance of construction. The language is standard from project to project, however, requires naming the potential projects and identify an estimated project cost. The city plans to issue bonds for larger capital projects. Some project costs might be paid prior to the bond issuance that could be reimbursable include engineering, legal review, design work and soil testing. Therefore, the project that have been identified include the new water treatment plant and the new well siting.

**Best Fishing Days and Times** 

One hour before and one hour after high tides, and one hour before and one hour after low tides.

During the rise and set of the Moon.




You know each and every Carver Lion is busy and working somewhere around the community. If they aren't up at the Community Field helping, then they are over at Lions Park getting ready for the Youth






