Hawthorne Ridge

The Community Development Director discussed with the council the reviewed and approved plans involving a trail system that incorporates the existing driveway for Hawthorne Ridge Trail driveway. The connection would provide access to the Snake Trail (Broadway) giving access to the downtown area. The developer is required to provide work on the driveway per the approved plans. The trail is identified as a minimal maintenance trail.

The council was also notified and discussed long-term maintenance of the trail system. With the rainfall staff recognized significant deterioration and concerns. Several areas of the trail show significant erosion and many exposed tree roots. This erosion is anticipated to continue. There are two culverts; one culvert has been damaged requiring stabilization prior to public trail opening. That work would be the responsibility of the city. The trail system throughout the Hawthorne Ridge development would be planned and constructed throughout the entire site providing full loop throughout. Access to the downtown area would be from Sunny Ridge and Sixth Street. Another financial consideration for the city is that if the driveway were preserved as a trail connection, this impact would be required to be included in the 2020 budgeting process. The recommendation due to the current and future condition was staff evaluation. Staff analysis of the current conditions did not recommend preserving the driveway due to the amount of erosion incurred in one season. It was also established that the Public Services Department did not possess the equipment required for maintenance of this site. The developer was made aware of discussions, as well.

The City Attorney stated that the council needs to determine whether the trail would be maintained.

The policy should also include the decision whether or not costs would be incurred to maintain and signs indicating that it is minimum maintenance trail posted.

Green Step Cities

The Community Development Director presented information relating to the GreenStep Cities program encouraging best practices and acknowledging cities working towards more sustainable practices. The program is voluntary. Information was presented to the council. Representative would be invited to a future meeting to present additional information.

Jonathan Carver Parkway

The Community Development Director discussed with the council the 2019 strategic plan and the identification of necessary committee creation. Discussion have begun regarding creating a steering committee to facilitate landscaping and design work to be required for the Jonathan Carver Parkway project. The purpose of the committee would be to gather a diverse group to help guide design work to be completed by Bolton and Menk. The committee would consist of eight individuals also to include governmental units' representation and residents. The scope of work would include review and recommend design features inclusive of wayfinding, landscaping, plantings, trail connections, lighting, median design, downtown connections, and signage. There would be four meetings over the winter and spring.

The city manager informed the council that the county had initiated plan design for an improvement to Jonathan Carver Parkway in 2021. The Corridor Study recently completed would be used in the design process for the anticipated improvement project. The City will be responsible for costs associated with the project, based on Carver County's Cost Share Policy and in addition to the City's "local share", other local improvements to streets, in addition, sanitary sewer will require consideration. Project consideration and scope for council review has been prepared by the city engineer. The council will be asked to consider an inter-fund loan from the Municipal Sewer Fund. That funding will cover the costs of the preliminary engineering and design services for the project. The task areas included involve project review, coordination, communications, local streets, sanitary and the development of a landscape plan. The estimated project costs will be developed over the next several months. Those costs, along with the city's participation amounts will be considered by the council in the form of a joint power's agreement with the county in 2020.

The city engineer discussed the Jonathan Carver Parkway Improvement Project update and process summary with the council. The study had been completed in June of 2019; construction was planned to start in 2021. Representatives from varying firms were also available at the meeting to answer questions. Question was asked about lane closures during the construction to be expected. The engineer stated that determination of project staged would be planned in the final design phase. The city would be involved in making those decisions. Question was asked if planning could be scheduled, when school was not in session and the response was that when the staging plan was determined, details like that would be included. The county would lead the right-of-way acquisitions process with city concurrence. The city manager stated that bonding would be done for the entire project, but the loan payment would be paid exclusively from the sanitary sewer funds. Efforts would be made to avoid retaining walls and easements.

Question was asked if the corridor was originally planned to go to Levi Griffin. City engineer stated that different aspects were discussed. The county stated that work north of Highway #212 is mainly lane reconfiguration with signal head adjustments. The city manager pointed out a pedestrian underpass at Cherry Circle. The county's cost share, if considered a regional linking trail would be a fifty percent cost. A trail on the east side of County Road #11 and north of Monroe Drive and Spring Creek Drive would then be a hundred percent cost to the city. Cost sharing with the county is determined by consideration as a linking trail. If the underpass were a linking trail, then the county would be responsible for cost sharing. Connectivity from south to north via trails was discussed at length and opinions declared along the discussed corridor.

Safety concerns at Fourth Street were asked to be addressed, along with the budget. There was not a merging lane going north out of Fourth Street. Costs for pedestrian bridge was inquired about. An underpass in the area of the Community Park and the Fire Station was brought up. Question was asked about the city being conventional or development driven category in the cost participation policy. The engineer confirmed that the city is under the conventional category. Question was asked clarification for landscaping funding cost sharing. The county would only participate in landscape if there were state-aided funding. There are guidelines to be adhered to as well.

Oak Tree

The Community Development Director also discussed adoption of a resolution with the council involving the drainage and utility easements vacations in the Oak Tree development. Drainage and utility easements had been recorded in portions of the Oak Tree property, which also include property that is part of the fourth phase that was platted previously. There is not any construction permitted for drainage and utility easements to be built for Phase IV requiring vacation. Vacation of the outlot is required prior to the final plat of Oak Tree IV addition. There would not be any financial impacts related to the easements. Recommendation was submitted to hold a required Public Hearing along with the approval of a resolution vacating easements.

The Community Development Director discussed with the council the topic regarding the Oak Tree Phase IV Final Plat. The council reviewed the resolution approving the Oak Tree Phase IV Final Plat. Three of the four phases of the development were previously reviewed and approved by the council. At that time of the preliminary plat, the lots in Phase IV were slated to be traditional single-family homes. A request has been submitted changing to the villa product for the balance of the nineteen lots because of the success evident in phase one. There would not be any changes in lot quantity, size or approved setbacks. The discussion included the topics of the lots and zoning, streets, access and sidewalks, utilities, park land dedication, improvement fee, buffers and landscaping. In addition, there was not any financial impact to the city involving Oak Tree Phase IV. The Planning Commission recommended approval.

The council held a Public Hearing regarding drainage and utility easement vacation for the Oak Tree development within the city. There were not any public comments received at the hearing. Motion was made and carried with all ayes adopting the resolution vacating drainage and utility easements for Oak Tree. Motion was made and carried adopting the resolution approving Oak Tee Phase IV Final Plat.

2020 Law Enforcement Plan

The Carver County Sheriff and Commander met with the city council to review and discuss the information for the contracted police coverage. There were two options for the city dedicated to police services. Appropriation for the two contracts has been included in the 2020 budget.

City Manager's Report

The city manager presented the city council with a proposal for a Governmental Fee and Cost Allocation Analysis. This analysis would review charges for the Building Inspections Department and provide guidance for allocation of funds to operate the department. Currently, there are not charges allocated for overall costs involved. The analysis would help develop formulas and methodologies to allocate the appropriate funds. The work would be done in fall. Funding would be from Professional Services throughout all departments in the budget.

The city manager also clarified that the Fire Chief's term I for two years. Therefore, applications are being accepted for this term as part of the Standard Operating Procedures.

The Community Development Director provided an update involving the access point for Lakeview Industries. The company has requested relocation of the entrance further west of the present designation due to the topography and utility installation. City staff has been reviewing the plan revisions and working with the company on the proposed changes. A Developer's Agreement amendment will also likely be required.

Construction Updates

The city engineer provided updates to the council involving construction projects throughout the city. The updates included city projects along with housing development projects. The mayor commented on the 2019 Infrastructures Improvement project going smoothly and the job site activities being visible. Question was posed regarding the drainage at the Sixth Street site involving the Hawthorne development. The most difficult portion of the pipe connection had been completed the city attorney relayed. This project will be in the restoration phases for homes affected. Question was asked regarding the status of Carver Ridge. Response was that the parking lot was primarily done and hope is that it will be substantially completed by December to open in early 2020.

Fire Engine Hcquisition

The council discussed the replacement of the Engine 12 and tanker with the Fire Chief. Question was asked if the Engine 12 had been purchased new. The response was that the engine was thirty-one years old and had been purchased used from the City of Eden Prairie. The tanker question was answered with this equipment being thirty-eight years old and has been in the city's possession since around 1990. The tanker would be returned to the DNR when the department is finished with it. The mayor asked if the city would be keeping the unit if it were no longer working which was the plan. Storage of the unit was not an issue. The shelf life of the hose was inquired about. Hoses are tested annually and generally necessary to replace as the twenty-fifth-year approaches. The department personnel will be making a final trip to Wisconsin to complete the specifications process on the new equipment purchase approved. The anticipated delivery date would tentatively b June of 2020. Motion was made and carried with all ayes adopting the resolution authorizing the purchase of a Fire Engine from Macqueen Emergency for the stated amount.

South West Transit Prime MD

The Community Development Director presented information to the council relating to SouthWest Transit Prime MD Service proposal. This would be an additional service offered. It is an ondemand ride service offering transportation to hospitals and clinics for non-emergency trips within the current service area, as well as select locations outside the service areas. A representative from SW Transit was also present at the council meeting to answer questions. Comment was submitted regarding the proposal being a great idea. The service would be a shared ride with fewer destinations resulting in less individual riders. The cost would be \$5 each way that started and ended in the City of Carver. Question was asked if the contract would be updated to include Waconia. At this point, the Waconia facility is the only facility who has agreed to subsidize the trip. However, it is anticipated that the service will grow to include other communities. Ridgeview Medical Center has agreed to subsidize the fee costs. Trips would include the 212 Medical Center for a fivedollar cost each way to Carver. Prime MD serviced area includes many clinics within the service area, Ridgeview Medical Center in Waconia is being added. In the future, it is hoped that Shakopee and St Francis would partner. Question was asked about pharmacies. Response given was that Prime MD is solely for medical appointments with a medical provider. Budget allocations for the year 2020 were inquired about by the mayor. The city manager responded the amounts allocated for the year 2020. However, with the new service those costs are unknown at this point. The city would be contacted throughout the program regarding the balance of funding of the year. Additional funds could be added to continue the service throughout the year. If there were a shortage, the council would be notified. Question was asked about how much the city had used thus far and the answer was that it was below the allocated amount. The mayor indicated that it was imperative to have foresight moving into the future to ensure the service was not discontinued.

Discussion pursued with a councilmember favoring the service involving Prime, but not the Prime MD. Further expressing concern with subsidizing when insurance plans cover costs. It was the mayor's opinion of a greater need for the Prime MD service. There was a concern of competition offering similar services and setting precedents, not favoring subsidizing the Prime MD portion of the service in the agreement. Comment was made regarding Carver Ridge offering the same service for their residents. SouthWest Transit was not making any profits on this service. It was the mayor's opinion also of another firm being able to offer similar services. Comment was also submitted that most insurance plans do not cover transportation costs for medical appointments. There was also praise given for the option availability, and the opinion of not agreeing to reimbursing costs. The city manager pointed out that the Prime MD service could not be utilized if the city did not participate in that service. Another councilmember was of the opinion that the service would be used more than the Prime service. Question was also asked regarding educating customers ensuring scheduling for the correct service. The response given was that it was part of the process to educate clientele. Motion was made and carried with four ayes and one nay entering into the agreement with SouthWest Transit for Prime MD.

2020 Pretiminary Levy Certification

The council was presented with the 2020 Preliminary Levy by the city manager. The City of Carver is required to certify a preliminary levy to the county. A series of budget meetings had been conducted discussing various expenditure options involving the General Fund necessary to fund city operations. Once the preliminary levy is certified to the county, it cannot be increased. The city council schedules a truth-in-taxation hearing on the preliminary levy during December to receive comments and determine the final levy and budget.

The mayor provided an update regarding the Community Survey. The City of Chaska personnel were enthusiastic about their involved and recommendation that the City of Carver follow suit. One councilmember had reviewed another cities' survey questions and answers over a period. Another councilmember indicated difficulty with the survey and the Jonathan Carver Parkway improvements plan. Question was posed to consider funding the survey from the Special Capital Fund that could assist in decreasing the levy amount and would prefer other options with different vendors for the parkway improvements. The mayor did not favor decreasing the levy amount at that meeting but consideration prior to the final levy adoption could be discussed. Other cities costs were briefly discussed. Reminder was voiced regrading varied pricing on the number of questions asked. A survey would be a means of attaining a benchmark. Motion was made and carried with all ayes adopting the resolution certifying the 2020 Preliminary Levy.

United Properties / Kwik Trip

The Community Development Director discussed with the Planning Commission members the topic involving the United Properties property and the proposed Kwik Trip platting. She presented the board members with the Replatting, Preliminary and Final Plat, along with Rezoning request for the United Properties and Kwik Trip proposal. Representatives from the Westwood and Kwik Trip were at the meeting to answer questions. Question was asked about parking stalls including gas pumps. Confirmation was that there were thirty-two stalls and pumps. A sign permit would be applied for as part of the zoning process. The Planning Commission held a Public Hearing. There were not any public comments received. Board members asked questions relating to the location and expected visible sites. The exact location of the station, ponds and additional development was given, Question was asked about enough turn lanes for access to the car wash and traffic signal installation. Coordination with the corridor project time lines were discussed. The tentative schedule for the station is breaking ground this fall, construction next summer and an opening in October. Question was asked about plans of a traffic light at the corner of Monroe and the entrance to the development. Response was that at this time there were no plans for a traffic light. Question was asked pertaining to the use of recycled water. City ordinance requires a percentage of water be recycled. Response was that it was certain that this could be achieved and if it were not, the car wash would be removed.

Motion was made and carried with all ayes recommending approval of the Replatting, Preliminary and Final Plat for United Properties and Kwik Trip.

Fourth Street

The Planning Commission board members reviewed a request involving property located on Fourth Street. The request involved a west lot split. The application involved request to divide current lot into two. If approved, both lots meet the minimum requirement of the zoning district and anticipated to also meet setback requirements. Access for the second lot is expected to be accessed from the alley on the rear of the property. Utilities would need to be extended and are available. The Planning Commission recommended approval of lot split.

2020 Elections

The council will review the resolution to be adopted designating a polling location for the 2020 elections in the City of Carver. The designated precinct location will the Carver City Hall at 316 Broadway.

Parks Master Plan

The Parks Commission has been working on the Parks Master Plan for quite some time and have drafted a final draft. The draft was forwarded to the city council. The commission went through several planning processes throughout the development of the plan and reviewed countless versions of the document. The drafted plan encompasses park development for the city through 2040. Several new parks were contemplated in the plan, along with redevelopment of existing parks based on community feedback and the work of the parks commission members. The Parks Commission recommended approval of the Parks Master Plan to the council. The Parks Master Plan develops the park dedication fees be required at the time of platting, as well as sets the amount of city contribution to the parks system annually. Dedication amounts would be increased for residential projects and the city's contribution to be increased annually and commercial/industrial amounts would be decreased. Additional detail and methodology would be considered to the proposed park dedication numbers.

The Parks Commission members discussed the full version of the Master Plan. Request was submitted to include more pictures and maps, as well as additional details to include acreage of each park. The plan will be discussed further in the future.

Storm Sewer Improvements

The city engineer stated that the city has been engaged in discussions with the county evaluating joint opportunities for stormwater management associated with the development runoff into or through the Jonathan Carver Parkway Corridor. There will be a need to outlet stormwater from Oak Tree developments into the eastern portion of the Jonathan Carver Parkway corridor and the county roadway project will need similar discharge pipe in addition to stormwater ponding that accommodates future corridor expansion projects planned for 2021. The county has funded a study reviewing alternatives combining the city and county needs for discharging stormwater for the future project. The recommended alternative from the study was a jointly used storm sewer pipe through the city's community park in addition to a pond expansion. The county and city would be cooperating parities. The ponding location is beneficial for the county but on city property, therefore the land for ponding would be a contribution to the project by the city. The pond outlined also impacts an existing trail system. The trail would be relocated to the boundary of the pond or to an approved location. Cost evaluations were also included in the study processes for all alternatives. The recommended alternative considered the lowest cost option meeting stormwater regulatory practices. The project will be tied to agreements requiring specific negotiations on cost splits. Typical splits for a highway project per policy split costs by percent contributing flow to a drainage system. This will be applicable to the entire stormwater system for the project including the above issue's project area. A negotiated element for oversizing of pipe associated with the city development drainage outside of the corridor project area may be required. Currently the city funds allocated for this are from a bond issuance for the 2018 stormwater project. The bond funds are an excess expected amount for the city's share of the joint stormwater pipe with the county. The two entities will see a reduction in overall costs associated with the stormwater into a joint stormwater pipe versus separate facilities. The project schedule is to be defined further but necessary in the years 2020 and 2021. The staff and agency recommendation are to construct a jointly utilized stormwater pipe through and beyond the city's community park as reviewed. Construct a stormwater management pond in the Community Park for the stormwater treatment and management needs of the future Jonathan Carver Parkway expansion project.

Long Range Financial Plan

The city manager discussed and presented the long-range Financial Plan and 2020 Enterprise Fund Budgets at the work session. The council had directed the staff to recalculate the budget with an estimate for a water treatment plant. The next steps include the engineer and public works putting together a presentation starting the process for the design of a new water treatment facility.

Franchise Fee Study

The city manager along with the city's accounting firm's representative presented information about franchise fees. These fees allow cities to charge a utility fee to both electric and gas companies for operating in right-of-way. The fees are intended to reimburse the city for costs incurred from utility companies digging within the right-of-way and compromising the city's infrastructure. Staff was requested to research for implementing franchise fees. The city manager would draft a work plan for consideration.

2019 Referendum

The superintendent and assistant superintendent from the Eastern Carver County Schools attended the council meeting to discuss and answer questions regarding the 2019 Referendum. Voting is scheduled for November 5th, 2019 election. The present location of the bus garage has been in the school's possession since about 2000. All three referendum questions will be an increase of thirty-six dollars per month. If the referendum were voted down on question three, the monetary impact was questioned. That answer was not available at the meeting. Class sizes were asked about and the response was it varies dependent on grade levels, buildings and students entering each grade level. East Union School serves as a great release valve as growth continues. There were not any plans to close East Union in the near future. Question was asked about the Operating Levy per student lower than neighboring districts. The response given was that District # 112 has approved versus what other communities have approved for operating funds. Demographics are not considered, but what each district has asked voters to approve. There is a maximum amount per student. The district has been seeking a better location for the bus garage for some time. Contingent on the referendum passing, there is an agreement to acquire the bus garage previously owned by SouthWest Transit. Renovations would be required at that site.

2019 Improvements Project The project engineer reviewed the 2019 Improvements Project. The council would be required to review two resolution involving the said project. The council will be required to adopt the resolution declaring the cost to be assess and ordering preparation of proposed assessment and adopt the resolution for Hearing on the proposed assessment for the 2019 Infrastructure Improvements Project. The contract for the work has been awarded for the Infrastructure Improvements project. A portion of the costs will be assessed to adjacent properties. Project costs have been estimated and final assessment amounts have been calculated. Final assessment amounts have been developed based on the Special Benefits Analysis prepared by an appraiser. The next step in the process is for the council to hold an Assessment Hearing and adopt the final assessment roll.

Riverside Park

The Parks Commission members were updated on the Riverside Park and flooding conditions. Drone images were presented displaying the damage to the shoreline of the river at the park site. Water has receded. The staff and members discussed options to stable the banks at the park site. Discussion of adding riprap along the banks to keep the shoreline in place during future rising waters of the next flooding event. The result is that this site will continue to experience unstable conditions due to flooding forcing it to be unusable.

Htt-Hazard Mitigation Plan

Carver County Emergency Management Specialist presented an update to the council regarding Carver County's Multi-Hazard Mitigation Plan. The hazard plan serves to reduce or eliminate longterm risk to people and property from hazards, identify risks and vulnerabilities and develop long-term strategies from future hazards. A Multi-Hazard Mitigation Plan must be developed with county, city and other personnel representatives to work together. Councilmember questioned why the land identified belonged to the US Fish and Wildlife was listed as in the city.

Another question was asked why the city was named in sections pertaining to areas not in the City of Carver, which included Carver Creek and County Road # 40 for possible upgrades for rain events and another for Dahlgren Road for storm water design and bank erosion. The explanation given was that it did mean that the city is responsible but is located within the City of Carver. The city attorney stated that the mitigation plan does not make the city responsible. The county representative stated that the city is not bound but worthy to have listed in case funding becomes available. Information was requested regarding NWS Storm Ready, Firewise USA and Everbridge programs. A brief update of each program was given.

NWS Storm Ready - Sponsored by US National Weather Service

Firewise USA - National Fire Protection Association -**Reducing Wildfire Risks**

Everbridge - Company selling communication services for notification of emergencies

The next question involved the timeline for approval of the Mitigation Plan. The response given was that actually the plan expired last year, approval as soon as Mitigation Plan. Question was then asked about renewal of the plan being required every five years from its adoption date. The plan has been approved by FEMA pending adoption by Carver County. Question was asked if the plan would require changes to ordinance or modifications to the Comprehensive Plan. The Community Development Director stated that it would be similar to what occurred with the flood ordinance. Question was asked about the levee under the Mitigation Plan but the city manager was of the opinion that FEMA funding was the umbrella for the possible was the best. If a disaster were to occur, the county would still be eligible to apply for grants but funding could not be received until FEMA approves the levee due to the declaration of a natural disaster by the Governor in 2011. Question was also asked regarding climate change being included in this exercise. The response given was that Homeland Security Emergency Management Plan Department required inclusion in this plan. The Public Services Director stated that the plan was what would be followed which was the reason it was put into place. A climate change event was explained as how climate is effecting our disasters across the state, the country and the world. "It is looking at how climate change is impacting the frequency or magnitude of events."

Comment was made referring to the Rapids Lake US Fish and Wildlife that possibly the cost value was so high due to replacement cost due to a natural disaster would be priceless. Comment was also made that it would not b wanted to show assets lower than they should be perceived.

The county representative inquired about the city seeking levee certification and if there were any options for funding. Following up with information regarding a state mitigation officer who could clarify whether or not there would be funding available for the city's levee certification.
