Community Service Hward

The mayor presented background information relating to the city's Community Service Award. The award this year had been presented to Mrs Greg (Lori) Osterdyk and daughter, Sydney, since Greg passed away recently. Greg was an active volunteer in the community, as well as having served on the council as mayor for several years. The council recognized and thanked Lori and Sydney for Greg's never ending giving to the city. Motion was made and carried with all ayes renaming the Community Service Awards in the City of Carver from this point forward to be named the Greg Osterdyk Community Service Award.

Employee of the Year Awards

The 2019 Employee of the Year Awards were presented to Public Services, Jason Hanson and Fire Department, Toni Dauwalter. The employees were thanked for their hard work by the council.

Kwik Trip

Carver Commons development was discussed with the council by the Community Development Director retarding the proposed Kwik Trip store. Work is tentatively scheduled to possibly begin spring of this year. Representatives were at the council meeting to answer questions. Council member inquired about anticipated changes to the site because of the expansion of Johnathan Carver Parkway. Response was given that there is appropriate ponding for the Jonathan Carver Parkway project and beyond pertaining to Monroe Drive. Expansion at a later date of the car wash was inquired about by council member. Statement was made that the anticipated car wash will not be added to the site at this time. The car wash proposal was removed due to the requirement of the reclaim ordinance, which could not be accommodated. The city does not monitor the required reclamation. Question was asked about changed store size due to the removal of the car wash proposal. Interior retail store layout would not change but the total building space is different. Motion was made and carried with all ayes adopting the resolution amending the Final Plat resolution for the development of Carver Commons.

Request was submitted by the city attorney that the attorney and the Community Development Director to have authority making minor revision to the Developer's Agreement. The changes would not affect the substance of the agreement. Motion was made and carried with all ayes approving the Developer's Agreement subject to minor revisions deemed appropriate by city staff.

Pet Store Ordinance

The City Manager discussed with the council the request submitted to the city from the Human Society of the United States. The proposed ordinance primarily regulates the sale of animals. Certificate of Source display requirement and subjection to inspections ensuring compliance. Representatives were available to answer any questions. Statement was issued regarding support of the ordinance and the fact that the city was being proactive prior to a placement of a store within the city. There was discussion suggesting a Conditional Use Permit. The city attorney related that a permit is used to regulate land uses and not recommended for this purpose. Motion was made and carried with three ayes and two nays directing the staff to prepare a Humane Pet Store Ordinance Modeling the Ordinance adopted by the City of Eden Prairie.

Parks Master Plan

The Community Development Director presented the council with the Parks Mater Plan, along with the updated Public Land Dedication Ordinance. The council was told that the Parks Master Plan included project is to be completed from the date of adoption through 2040. The Parks Commission had recommended approval and adoption. The proposed ordinance included changes from both a community park and neighborhood park to just a community park fee, references to the updated Parks Master Plan and included a trail construction as part of the community park fee. Approval for the ordinance had also been recommended by the Parks Commission.

Inquiry was made regarding money allocation for the trail from the Carver Bluffs Park to the proposed dog park.

Property directly east of site to make that connection. Should acquisition occur, it would be possible. Notation was made for appreciation of work conducted on the Parks Master Plan since members are all volunteers. Motions were made and carried with ayes approving the resolution approving he Parks Master Plan and adoption of the ordinance updating the public land dedication ordinance.

Franchise Ordinance

The City Manager discussed the drafted insert pertaining to the Franchise Ordinance/Fees proposal. Communication was essential to get residents fully aware and that it was important to have a fiveyear plan identifying projects.

Green Step Cities

The Community Development Director reminded the council of their previous discussions pertaining to GreenStep Cities program requested by councilmember to participate. A representative from the Green Plains Institute will be Attending future meeting to provide additional information.

The Great Plains Institute representative presented information pertaining to the GreenStep Cities Program. The program is an action-orientated and voluntary program offering a cost-effective, free, peer-focused path for sustainability work. The program is voluntary, self-paced and membership is free. Technical assistance, recognition and continuous improvement framework is provided to members. The issue will be discussed in the future for consideration and vote.

Discussion was held at the council meeting relating to the voluntary program for municipalities in Minnesota that is recognized and to improve on sustainability and quality of life goals identified as the GreenStep Cities. The program is tailored and based on municipality size and each community is able to choose best practices that are program eligible for a deeper dive into the program. The identified cities are recognized on a tiered scale with one-step recognition for entering the program up to five steps for program champions. Entering is required to be recognized. Gaining additional steps, there are several best practices implemented to begin work determining potential projects based the framework. Several of the best practices have already been met.

Water Treatment Plant

The city engineer discussed and presented information relating to the expansion of the water system in the city. The council directed the staff to proceed with the recommendation expanding the existing water treatment facility. Authorization to proceed will be discussed further.

Carver On The Minnesota

The city manager discussed the submitted request by Carver on the Minnesota who is proposing to have music played at the Church by the River site. The council directed the staff to set parameters.

Miscellaneous

The Public Services Director provided the council with updates relating to the ice rink maintenance. Flooding of the ice ring continues dependent on weather.

We Cab

The Board Member representative from WeCab attended the council meeting to provide an overview of WeCab. The organization is comprised of a network of volunteer providing safe, affordable and flexible supplemental transportation. Currently there are nine residents utilizing the service with using the service fifty times. The organization is dependent upon volunteers and donations. The city was thanked for their monetary support.

Jonathan Carver Parkway Project The Project Communications Specialist from Bolton and Menk

presented the council information at their work session meeting pertaining to the upcoming Jonathan Carver Parkway Improvement Project. Bolton and Menk has been hired by the county to handle project communications. The individual also is the city's liaison. At the work session, multiple topics regarding the project were discussed. The design of the project was scheduled for January through April of 2021; construction is tentatively scheduled to begin in April 2021.

Timber Creek

The Community Development Director presented the council with paperwork relating to the Timber Creek Environmental Assessment Worksheet. Summergate and Westwood Engineering completed an Environmental Assessment Worksheet in relation to the Song property identified as Timber Creek. The worksheet gives the interested parties a complete view as to how the project may effect the community. The Timber Creek development proposal consists of two hundred and seventy unattached units and seventy-four attached units. Determination in March will be conducted to decipher the necessity of an Environmental Impact Study. The following step includes the planning process to include annexations, rezoning, preliminary and final plat.

Municipal Water System

The city engineer discussed with the council the water system expansion projects including plans and specifications. Council reviewed information to decide on authorization of plans and specifications for the stated project. The city is growing community requiring the existing water system to be expanded in order to support the growth. Currently, the water system meets current and future average day demands, however, the system is nearly at capacity to meet the maximum day demands. It is critical that the city proceed with improvements. Determination identifying the necessity has been made. The following components included in the overall water system expansion involve additional municipal well capacity and wells, expand the existing water treatment plant and complete upgrades to the existing water treatment plant. The drilling of two municipal wells had previously been authorized. The next step in the process involves the preparation of the final plans and specifications for the projects. The council reviewed the project schedule. Financing would involve the sale of bonds, city funds would be utilized to service the bond debt, and a preliminary budget would be suggested for financial planning.

The only exception would be that the road is not accessed by the annexed land. The attorney would clarify verbiage. The next proposed changed included the township waiving the per acre fee for property annexed for tax-exempt purposes after township approval of the tax-exempt purpose. The third proposed change will also be clarified by the attorney involving assessing properties in the township.
