Rental Policy

At a council meeting a councilmember requested a reevaluation of the Rental Policy specially involving the item of a Building Host requirement for rental of four hours or less. It was discerned that the majority of the rentals involved

Civic organizations. It had been determined that the old facility facilitated more rental than the newer building. Comment was made regarding being saddened to see rentals being utilized elsewhere. Continual tweaking of the policy was necessary was the council's determination. These could be pursued at a work session. Price comparisons were also discussed for possible reviewal.

Fee Schedule

The council reviewed the drafted ordinance amending identified fees charged by the city for the fee schedule. Estimates for an additional water treatment facility is anticipated. A long-term financial plan determined necessary increases to generate positive cash flows for future system improvements and growth. The council is considering fee increase for utility connection charges. Question was asked when the last increase for utility fees were incurred. The city manager responded that last year was the increase of fees and a base fee added, as well. It had been several years prior since there had been an increase the council was told by the mayor. Motion was made and carried with all ayes adopting the ordinance amending said fees for the city.

Pet Store Ordinance

The council was presented with information relating to the Humane Pet Store Ordinance involving the limitation regulating sales of cats and dogs in pet stores requiring a certificate of source for each animal to be posted, as well as the city's right to perform an inspection of the premises. Question was asked regarding the certificate stating where the animal's origin was and that the stores could not euthanize said animals. The ordinance was for the purpose of discouraging puppy mills. It was not pertaining to the hosted adoption days. Motion was made and carried with all ayes adopting the ordinance related to the sales of cats and dogs in pet stores.

Incentive Program

The city manager informed the council that the staff has been exploring promotion of an incentive program pertaining to Beverage Server Training for the liquor license holders. Two establishment owners were in favor of the idea. Attendance would result in credit on liquor license. Future discussions would be feasible to discuss further. The city attorney has been reviewing the topic, as well.

Spring Safety Event and Bike Rodeo

Special Meeting

The city council held a special meeting for the purposes of the discussion of the Declaration of Emergency related to COVID-19 (Corona Virus) to consider Emergency Policy Amendments. The council reviewed the Resolution involving an extension to the period of Mayor-Declared Local Emergency. Motion was made and carried with all ayes adopting the resolution extending the Mayor-Declared Local Emergency.

Information was also discussed relating to the Employee Reference Manual and the Fire Department Standard Operating Procedures Policy Amendment. Motion and was and carried with all ayes adopting the Emergency Policy Amendment.

The city manager stated that notifications regarding city function ability closures has been related to the public. Changes to deadline dates will be communicated to the public given the circumstances pertaining to the local emergency due to the current pandemic. Changes would also apply to extension of special events at the city hall and the Church-by-the-River scheduled functions.

Due to the disruption the council discussed contingency plans for required city functions such as building inspections and meetings. Suggestion was submitted to change meeting times. The council was informed tht SouthWest Transit has temporarily suspended service out the Carver Station. The County Library has also suspended servicing the Express Library. The Carver Station has been closed and will remain closed until those serves are resumed.

The mayors four priorities during the pandemic in involve keeping the citizens and the city staff healthy, maintain essential services expected in the delivery of fire, police, water, municipal utilities, flood protection and snowplowing, support and advocate the business community and to maintain government transparency. Meetings would continue to be accessible and information shared. The mayor encouraged practicing distancing.

The city manager told the council when inquiry was made regarding Lakeview Industries that partnerships were being created and working on developing a face shield to help the medical industry combat the virus. The city and the county were working Lakeview Industries to identify additional space to create extra productions area.

Great River Greening Grant

The Community Development Director informed the council that the staff applied for a natural resource restoration and enhancement grant through Great River Greening for work in Creek Side Park. The grant supports projects by both the Park Commission and the city that include improvements to the Carver Creek, presservation and creation of woodlands enhancing the flood plain. The staff of Great River Greening drafted a project estimate and identified funding partners interested in the project. A letter of Support creates a strong application for funding sources. Park dedication dollars could be utilized for the required matching funds.

Timber Creek

The Community Development Director discussed with the council the Timber Creek Development and the Environmental Assessment Worksheet. The council reviewed adoption of the resolution adopting the Finding of Fact, Conclusion and Record of Decision for development. Summergate Companies and Westwood Engineering completed an Environmental Assessment Worksheet relating to the Timber Creek development located on the Song property. The proposed project includes single family homes and townhomes.

The council reviewed the worksheet. Agencies and feedback have been reviewing and commenting. The purpose of the worksheet presents findings impacting necessity of an Environmental Impact Statement. It was the staff's opinion that a statement was not warranted. The next steps for the project include applications for annexation, preliminary plat, rezoning and the final plat.

The Community Development Director updated the council on the Timber Creek Environmental Assessment Worksheet for the proposed Timber Creek project. The next steps for the project include applications for annexation, preliminary plat, rezoning and the final plat. Question was asked about the feasibility of this project when the road will be closed for the Jonathan Carver Parkway improvement project planned for 2021. Access would be maintained via a frontage road from the Highway and the Town Road. Question was asked regarding a change to the timeframe schedule. The director explained that unlike the development identified as Summergate that develops lots and then sells, this development has multiple contractors. The infrastructure sets the staging process. The city will not have control over market demand changes to the timelines. Questions were asked regarding development. The director explained the reasons for the Letter of Credit where something to occur and the work is stopped, the city utilizes the mechanisms in place in the Developer's Agreement to go in and finish the work. Motion was made and carried with all ayes adopting the resolution and adopting the Findings of Fact, Conclusion and Record of Decision for the Timer Creek **Environmental Assessment Worksheet.**

Cable Communications

The city council held a Public Hearing pertaining to the Cable Communications Franchise Application. Information was reviewed by the council from Comcast and Jaguar for the applications. A summary of services provided. Jaguar would service both residential and commercial services. Jaquar Communications was also recently acquired by MetroNet which increases their capital and ability to expand.

Community Development Agency

The Community Development Director presented the council with information relating to the Community Development Agencies Grant Agreement. The agency has been working towards the development of a second building at the Carver Creek site and exploring financial options for the project. Request had been made for the city to apply for a Community Growth Partnership Initiative grant for site work on the property for this project. The coordination, site work and payments would be completed by the agency. Grant dollars awarded for the project. There is request from the city for matching funds. The agency is actively seeking financing options to make the project feasible at this time. The concept plan had been reviewed by the city already. The council discussed the issue at length with questions. Motion was made and carried with three ayes and two nayes approving the Community Growth Partnership Initiative Grant agreement with the Carver County Community Development Agency.


