Co-Vid 19 Phasing Plan

The city manager discussed with the council the Covid-19 Phasing Plan. The city's service counter has been closed and facility rentals suspended since March. Staff had been working mainly remotely. The Fire Station and the Public Services Building remain closed to the public for an indefinite period. The staff is working on phased re-opening plan. The Governor lifted the "Stay at Home Order". The strategy one plan if the city hall service counter will be "Open by Appointment". However, services will be handled by remote means and then if necessary, an appointment will be scheduled. Park shelter and field reservations remain suspended. City Hall and Church-by-the-River rentals will plan and implement public health and social distancing throughout city buildings. Indoor park restrooms, concession stands and Riverside Park campsites will remain closed for the remainder of the season. The Phase II Implementation Milestone would be effective June 16th. The city will remain in Phase I if the county public health statistics indicate an increase of the virus. Council and commission meetings are to be held in the council chambers. Video conferencing will be available. There will not be any scheduled meetings in the $\bar{\mbox{R}}\mbox{apids}$ Room. The city hall service counter will be open. Facility, field and picnic shelter rental will be available with maximum occupancy adhered to. Staff will transition to normal "on-sit" working hours. Motion was made and carried with all ayes adopting the Covid-19 Phasing Plan presented.

Sky View Lane

The interim city planner discussed with the council the alley vacation and lot combination request in SkyView Lane. The council reviewed resolutions relating to the approval of the alley vacation and the lot combination. The two lots are separated by an alley. An alley vacation would consolidate the two lots. The alley vacation would be split evenly between the adjacent property owners once vacated. Recommendation was submitted that the municipal utilities easement maintained. The Planning Commission held a public hearing and recommended approval.

Community Development Agency

The Community Development Agency Deputy Director addressed the council regarding the Livable Communities Account Acknowledgement Form concerning their proposal to construct a structure within the city as discussed in previous meetings. The city attorney weighed in with his opinion regarding the grant being applied for by the CDA.

The attorney indicated tht the if the city signs the receptivity agreement and the grant were awarded that the city could still be obligated to match the grant. There were still many unknown details for necessary approvals. It was understood that the agency was the back up source for the funds, however, the city could still be accountable. If the city were to pursue, recommendation was made to have a binding agreement with the Metropolitan Council for the reimbursement of the match prior to signing a receptivity agreement. Additionally, the city does have the right to make a match prior to signing. It would be a policy decision, along with timing and a city review and approval of the grant application.

Miscellaneous

The new Public Services Director, Chad Shell was introduced to the council by the city manager.

Design Carver

The Planning consultant discussed the resolution regarding the Design Carver Final Approval, the city's 2040 Comprehensive Plan. The seven-county region of the Metropolitan Council are required to update their Comprehensive Plan every ten years. The Met Council sets the framework and outlines of requirements and then the local units of government are charged with the planning processes. The Planning Commission held a Public Hearing. The proposal was submitted to the Met Council. Approval has been recommended. The council reviewed the resolution.

City Well

The city attorney addressed the council pertaining to the issue of the city's reviewing alternative sites for a new city well. One site identified was located at the Meadows at Spring Creek. The location was an undevelopable outlot in the subdivision. However, the outlot is subject to a Homeowners' Declaration and not possible for the city to obtain a conveyance of the property. There are however, certain utility easement rights. An agreement was reviewed that would permit the construction of a city well on the outlot. The agreement is in the best interest of the city and recommended to approve entry into the agreement.

HTV Ordinance

The city attorney communicated with the council regarding the ATV Ordinance. The ordinance was first codified in 1997 and has had prohibitions on the use of all terrain vehicles on city public right-of-way's, sidewalks and trails. Minor modifications were made relating to snowmobiles and the use of ATV's during Steamboat Days. Otherwise, the ordinance has been substantially unchanged since its original adoption. It was deemed that the definition was antiquated. The attorney's recommendation was that the definition of an ATV be more consistent with the State's definition. An updated version should be sought.

St Nicholas Catholic Church

The current mass schedule at Guardian Angels is 4 PM Saturdays, 8 AM, 10 AM and 12:30 PM (Spanish) Sundays. Please note that at this time no masses at St. Nicholas because of the size of our church. Please see the June 7 bulletin for important details for attending mass in person.

Even though churches are opening, the dispensation from the obligation to attend Sunday Mass continues. Be decree of the Archbishop, no one is obligated to attend Mass.


