Southern Valley Alliance

The community engagement coordinator attended the city council meeting to present information regarding the Southern Valley Alliance. Services provided for Scott and Carver counties were highlighted. Question was asked about plans for the provision of a shelter. It could be possible in the future. The council was also made aware of an upcoming fundraiser in April at Mystic Lake entitled the 22nd Annual Jeans and Gems Gala. They have other fundraising events and ways to help, donate or learn about their services.



Representative Jim Nash

The council heard the legislative update from Representative Jim Nash at the council meeting. He provided an overview of several issues that he has been working on at the legislative level. He also shared his support of the levee project submitting his disappointment that the project funding had not been included in the bonding bills. He stated that he will continue working to get funding included in upcoming budgets. Question was asked if a small bonding bill would be possible this year. The response give was that legislature first needs to set the budget and a lot of work is required to be completed by the end May and could not predict if completion this year could be achieved. Prediction of Local Government Aid was asked about. The representative responded that he would be surprised if cities saw a change in the formula which would result in cuts. The state's budget forecast was inquired about. He indicated that there will be a budget deficit and the next forecast forthcoming.

Carver Levee

The city manager reviewed the budget summer for the preliminary design costs associated with the levee improvements. The scope developed was within the available budget. The monies for the budget limits reflected current funding partners were reviewed. The project purpose and intent of the preliminary design phase to further develop the levee concept plans for a more detailed level of design. For the purpose to generate necessary information to further project funding, permits and bring the project closer to bid documents. At this phase, the tasks to be completed include Communications/Administration communications required throughout the project.

There are anticipated to be three key areas pursued to include tasks identified for public engagement, stakeholder coordination and the funding administration. Then to be followed with the Geotechnical/Seepage Analysis to include the geotechnical investigation of the levee. Soil borings will be retrieved for the purpose of providing understanding of material required to be used to construct the levee. Then the Preliminary Design with the concept design previously developed will be updated and refined. The preliminary design identifies the construction and grading limits. Survey data of the levy from Survey/Easements will provide field survey of missing areas and critical features. The tentative time schedules were reviewed by the city.

The council reviewed the information from the city manager on the certified levee project, engineering proposal. The council was being requested to approve the proposal from Bolton and Menk to conduct engineering work for the levee. The council went over past information relating to the steps involved with the issue. Most recent the city has been notified of receipt of grant fund to advance the levee project. The grant funds would be used to conduct survey work, soil borings and additional engineering work required. The council had reviewed the engineering proposal.

Carver Farmer's Market

The Community Development Direction discussed the issues of the Farmer's Market with the council. Previous feedback, discussions and interest the council reviewed the discussion of the community gardens and community success the city staff had been working with the county and the SouthWest Chamber of Commerce to present a Farmer's Market in Carver during the summer of 2021. Chaska and Victoria Farmer's Markets are both coordinated by the chamber and have expressed interest in coordinating a similar event in Carver. A dedicated coordinator is available at the chamber. Staff would assist the chamber coordinator with marketing efforts, social media and day of coordination. The chamber is also submitting a grant application. In the future the council was told what those costs could cost annually. The temporary location for a Farmer's Market in 2021 would be the Community Park. IN the future it was discussed that the site would be the Carver Station.

WeCAB

The city council was thanks for their continuous support for the WeCAB supplemental transportation program. WeCAB are now into their 2021 funding year. The city was told that during the pandemic, the number of volunteer drivers and riders had increased except for two months last summer. They have provided continuous safe service with their dedicated volunteer drivers. WeCAB's expenses increased because of the pandemic the council was told.

Even through all of the challenges, WeCAB continues to thrive and grow, and continues to serve the City of Carver. WeCAB has nine riders who identify Carver as their home and we have provided 125 rides. There are not any volunteer drivers from the city, however there is one dedicated dispatcher who consistently volunteers one dispatch shift (four hours) per week. She has been a volunteer with WeCAB since 2014. They are also continuing to strive to register more riders and volunteer drivers from Carver and would appreciate assistance in the recruitment mission.

Miscellaneous

The city council was introduced to the new deputy from the Carver County Sheriff's Office, Dustin Purpur who is the night deputy. The city welcomed him.

The city manager discussed the legislative priorities which the city annually adopted these for the impending legislative session. Once adopted these priorities are submitted to Representative Nash and Senator Julia Coleman. The manager presented the 2021 Legislative Priorities for consideration. Motion was made and carried with all ayes adopting the 2021 Legislative priorities for the city including the additional remote meeting requirements.

The public service director discussed with the council the necessity of a dump truck with sow plowing equipment. Request was submitted initiating the purchase process for a new truck. As the city grows, an additional large truck is needed to allow maintenance of the high level of service during snowstorms as well as providing an alternative in the event of mechanical breakdown of existing fleet vehicles.

Timber Creek

The community development Director presented information to the council regarding the Timber Creek annexation. The property proposed for annexation is located west of Carver Elementary. The council had reviewed an Environmental Assessment Worksheet and the concept plan for the development. The staff continues to work with the developer and their engineer pertaining to the preliminary plat plans expected to be reviewed by the council sometime in winter. Upon annexation approval for final review and approval and the review complete the city will secure land use control of the property for rezoning and preliminary plat approval. Information review ensures compliance with the Orderly Annexation Agreement and meets required conditions. The council was informed that the next steps include rezoning, preliminary plat and final plat pending annexation approval. Summergate Companies are the same company involved with Summers Creek development in Lakeville. Question was asked of how much of the one hundred sixty-four acres were buildable. The response was that this question is still being worked through that a lot of the topography indicates it is steep and unbuildable resulting in a large portion that will most likely be preserved as an outlot. Motion was made and carried with four ayes, one abstention approving the annexation of the property in accordance with the orderly annexation agreement.

Downtown Improvement Project

The city manager and the city engineer discussed information regarding the downtown improvement project for improvements at Broadway and Main which would result in a four-way stop at that intersection. A coordinated design with Carver County highway and the city was coordinated and this section is officially identified as Carver County Road # 40. The county highway department is requiring either sidewalk bump-outs or parking stall elimination in order to meet standards for sight lines to incorporate a four-way stop intersection. An expanded infrastructure project was developed addressing multiple miscellaneous improvements. The council discussed the options. Motion was made and carried with four ayes and one nay directing the city engineer to prepare plans and specifications for the downtown improvement project with the intersection option at Broadway and Main for dual bump-out.

SouthWest Prime

The community development director reviewed with council the agreement with SouthWest Transit regarding SouthWest Prime. Previously the city approved the contract with SW Transit for Prime services in the city which is an "on-demand" ride service model offering transportation to various cities. Ridership numbers were reviewed. The contract for the city to consider extends the prim service through 2021. These contracts are reviewed annually. Recommendation was submitted approving the contract. SouthWest Transit will also be investing in two electric vehicles the council was also told.

Dahlgren Township

Dahlgren Township 2021 newly elected supervisors are Paul Modeen and Brian Genrich with Doran Brahee as the Treasurer. Their Board of Organization personnel include Jeff Thompson, Chairman, Paul Modeen, Vice Chairman, Deputy Clerk, Theresa Willems and the Deputy Treasurer, Lori Cox. Congratulations everyone!

Smart Water Program

The Smart Water Program is the project proposed as a new program by the Carver County Water Management Organization to encourage residents to use smart controller on their irrigations systems. Smart controllers link to local weather conditions providing exactly the exact amounts of water required for lawns and gardens. The program is aimed to conserve groundwater resources and prevent additional run off by increasing the efficiency of irrigation systems. The conservation of water supplies will save residents and municipalities financial resources and protect groundwater supplies. The program will team up with Rachio offering smart irrigation controllers at discounted prices. Interested cities will partner with the county allowing the availability of the program to residents.

"This new program is built of the first pilot years of the Chaska Irrigation Efficiency Program. The Smart Water program will be different in format and delivery, but the overall goals remain the same. The new format allows for great flexibility for partnering cities, is easy to join, the best feasible method to extend this program county wide, and provides residents benefits such as more choices of controller and free delivery to their home." The Carver County Water Management Organization will serve as the 'parent organization for partnering cities. Cities interested will enter an agreement with the country for a year committing to funding and marketing. The city will be invoiced prior to the launch of the program. A website will be created for the county program and hosted by Rachio. Funding and costs Partnering cities will determine how much funding they'll put toward the program each year. Cities can choose to provide further incentives for purchases. Cities advertising the program will so through outreach methods. Access to Rachio's marketing to help advertise for the program.

Current status of the Carver County Water Management Organization is that they are currently working on setting up the contract with Rachio, Inc. to create the landing page. The next step will be for cities to sign partner agreements with the county to commit to their determined funding amount and marketing for this year.

The public services director discussed with the council the spring clean-up day agreements. The council was required to accept the proposal from the sanitation service. The discussed proposed date for the annual Clean-up Day was Saturday, May 15th. The purpose of the event is to prevent and discourage items from being improperly or illegally disposed of throughout the community. The event involves residential curbside pick-up of waste removal.

Eligible items for pick up include furniture, mattresses and exercise equipment, while ineligible items include paint, appliances and hazardous materials. With the addition of new homes and the large volume of trash in 2020, the size of the trash area has been reduced from 8' x 8' x 4' to 6' x 6' x 4', which shall be noted in the Clean-up Day Flyer.

Community Gardens

The city is offering the use of a Community Gardens project and will be available in downtown Carver at the Church-by-the-river at 109 Main Street East for the 2021 growing season!

There will be two available options – raised beds (4' x 8') and ADA compliant planter boxes (4' x 4'). Access to irrigation and compost bins will make it easy for new and experienced gardeners to enjoy the benefits of growing their own produce in a convenient location.

Registration begins February 1. Plots are available for \$20 plus a \$20 security deposit.

Registration and program details are available on the city's website under 'Community Gardens'.

Funding for this is being provided through the Statewide Health Improvement Partnership (SHIP) Grant Agreement administered through Carver County Public Health.
