Municipal State Hid

The council discussed with the Assistant Engineer the Municipal State Aid System. This program allows participation in the Municipal State Aid System Program since the city has surpassed population count to provide funding assisting with construction and maintenance of the street system. Streets throughout the city were discussed. As the program grows, needs could change. System revisions may be requested and required City resolution approval. Inquiry was made if County Road # 40 was included in part of this system. The assistant engineer stated it could be applied for in the future by the council. Amount of funds anticipated to be received were also discussed. The assistant engineer explained that the Pavement Management Plan programmed amount on an annual basis based on the cash flow projections. Question was asked if the state funds were guaranteed. The response given by the city manager were that they were unaware of any cuts to state aid funding. The city attorney stated that funds are generated from the taxes paid for registration of vehicles. Clarification was requested for formula decision on selected streets. The assistant engineer further explained that there were flexible segments in street determination but selected streets can be changed in the future. The city manager detailed the connection details interconnecting to the Pavement Management Plan along with its evolving with the plan. Additionally, a small portion of streets are within the City of Chaska. Work is being done with staff and the City of Chaska to include areas in their portion with their Municipal State Aid plans. Motion was made and carried with all ayes adopting the resolution establishing Municipal State Aid System for the streets in the City of Carver.

Miscellaneous

The city manager informed the council nominations were being accepted for the Greg Osterdyk Community Service Awards. The city manager informed the council that Dr Holder of Carver Dental is the recipient of the 2022 reg Osterdyk Community Service Award. Congratulations to Dr Adam Holder.

The city attorney updated the council on their ability to change speed limits son local roads. The council has the ability for certain city streets without conducting a traffic analysis with MnDOT. There is an option to reduce speeds lower than 25mph on some streets. Several requirements are necessary when this is done. A summary of applicable statutes would be forwarded to the city manager for the council.

The Heritage Preservation Commission discussed the historic kiosk approval. The community development director presented the information of the content for the historic kiosk to be installed at the corner of Jonathan Carver Parkway and 6th Street encouraging the public to visit the downtown Carver area. Finalizing the content would be discussed further.

The city council recognized the employee of the year with an Employee of the Year Awards Presentation by the mayor. Administrative Assistant, Tedie Fahey was one recipient, the other went to the Building Official, Bryon Madson. Congratulations!

Annually the city is required to annually designate official representations and appoint responsibilities within the organization. The 2022 year is no different than the past. For anyone interested in those appointments, you can, if you have computer access, go the city's website to reference the minutes for that information.

South West Prime

The Community Development Director discussed with the council the agreement with SouthWest Transit for the SouthWest Prime MD. Previously the city had reviewed and approved a contract for Prime services in the City of Carver. "Prime is an "On-Demand" ride service model offering transportation to Eden Prairie, Chanhassen, Chaska and Victoria. The existing contract states that the city is charged for rides that originate in Carver at the established rate. On an average there are one hundred fifteen trips per month originating in Carver using Prime for 2021. The council reviewed the contract which extends the service through 2022. These contracts are reviewed annually. Prime MD provides service to hospitals and clinics for non-emergency trips within the current services area of SouthWest Transit, along with select locations outside of the service area. Both SouthWest Prime and Prime MD are included in the 2022 budget, along with allocation. The staff will monitor budget amount throughout the year while providing updates to the council.

Ironwood Park

The community development director discussed the preparation of Plans and Specifications for Ironwood Park. There has been programming of newly expanded park area in Ironwood Park. Due to the Timber Creek development, the Ironwood Park has been expanded approximately by three acres of additional park land through the park dedication requirements. Proposed improvements include upgraded skate park, shelter with casual seating spaces and permanent lawn games, full-sized basketball court, robust trail system and an outdoor classroom adjacent to the Carver Elementary. There will be several unprogrammed spaces that could develop into future based needs and budget considerations. The council then discussed inclusion of relocation of bathroom facilities, parking expansion in addition to a drop off zone in the parking lot and also an expansion to the pavilion. At an open house residents submitted request for pickleball courts. Access and lights were also brought up at that time. The proposed improvements were tentatively scheduled to begin late spring 2022 with a fall completion. Initial budgeted costs were reviewed. A more refined budget would be prepared upon the completion of the plans and specifications. The project proposed to be funded from the Park Dedication Fund with revenue generated from development fees and an annual General Fund allocation. The council discussed a motion to prepare the plans and specifications for the Ironwood Park proposal.

The Ironwood Park Improvement Project proposed plans and specifications for the expanded park area were discussed again and reviewed by the council. Motion was made and carried with all ayes authorizing the preparation of plans and specifications for the Ironwood Park.

Levee

The city mayor told the Planning Commission members that the House Capital Investment Committee toured the Carver's levee. The Senate Capital Investment would be returning to review the levee again. The city is pursuing funding options for the levee improvement project.

Snow Plowing and Ice Control Policy

The public services director discussed with the council a motion to adopt the 2021-2022 Snow Plowing and Ice Control Policy which included recommendations and edits. The purpose of the discussion involved resident input pertaining to new roads, new trails and budget considerations, as well as equipment and staff safety. The council reviewed the drafted policy for the snow plow schedule, route maps and trail map.

The council reviewed again the plowing and ice control policy with the public services direction who presented an updated policy. Inquiry was made if the levee trail will be plowed by the city. The city manager stated that Carver County is reviewing their policy with consideration of a plan to reimburse cities for work done to maintain county portions. Question was then asked about the City of Chaska clearing the trail from their end. The city manager was not aware of the city's plans and would follow up with them. Clearing the ice rink was asked about, as well. The public services direction stated that city streets and trails are prioritized before cul-de-sacs and the ice rink. Motion was made and carried with all ayes adopting the snow plowing and ice control policy.

Sign and Pavement Identification

The city manager discussed with the council sign and pavement identification policy. Discussion regarding removal of "Slow Children" and "Children at Play" signs to begin in May of 2022 was held. Occasionally requests have been received relating to street signage, pavement markings and other traffic control measures. Overall, the council handled such requests. These types of requests have increased along with becoming more complex. A drafted Street Sign and Pavement Marking Policy has been completed in an effort to develop a uniform request process and establish consistent decision-making criteria. The objectives utilized involved a systematic process to address traffic concerns with an easy-to-follow program; evaluate traffic concerns; informing residents of issues; and to incorporate traffic strategies program.

The city manager again discussed the sign and pavement marking policy with the council which will be administered by the city engineer using specific objectives. Motion was made and carried with all ayes adopting the sign and pavement marking policy removing all "Slow Children" and "Children at Play" signs beginning in May of 2022.

Gilbert Property

The community development director presented the concept plan for the Gilbert property located directly south of the Meadows at Spring Creek to the Planning Commission members. The property is approximately fifteen acres to be accessed from Mulberry Lane. The Concept Plan designates a development consistent with the City's Comprehensive Plan. A recorded cart path has been recorded which the staff and the developer will work to resolve and remove at the time of the development. The bluff ordinance was significant in this area. An overview of the ordinance was reviewed along with the statement that the city would not allow deviation from it. Plans were not finalized. The architect designing the homes in Tim Whitton. The community development direction anticipated villas or detached townhomes with a Homeowner's Association would be the direction of the development. Development representative stated that the market will drive the plan with different offered plans. Question was asked by commission member if larger but fewer homes would be constructed. Response given was that the city needs to meet the density requirements. Discussion was held on multiple items.

Sixth Street West Improvement Project

The city engineer gave an overview of the Sixth Street West Improvement project. Councilmember pointed out the traffic change from a stop to stop for traffic relative to the pedestrian crossing is very important at the 6th Street and Broadway intersection. Above the minimum standard signage will be done in this area. The widths were discussed of the area. Motion was made and carried with all ayes authorizing the preparation of the plans and specifications for the 6th Street Improvements project.

Parks Advisory Group

The community development director discussed a Parks Advisory Group involving the Parks Master Plan. There has been a large volume of feedback and increased public engagement with interest in park development and redevelopment. The staff has been brainstorming regarding increased interest in the parks area issues. The Parks Commission historically operates similarly to the Planning Commission and City Council where formal monthly meetings are held. The staff proposed an idea involving a larger group of residents to work together in the capacity of a parks advisory group to meet for brainstorming, education about parks funding, maintenance and development and local events to promote community and Carver parks. The parks advisory group would also provide feedback and ideas to the City of Chaska for event execution under the city's recreation agreement. This formal role of park plan approval would shift to the Planning Commission who is tasked with park work through development and review of the Comprehensive Plan. The goals for the proposed group would increase public engagement and education, listen to a wide range of community members relating to park development and redevelopment, as well as foster community events and meeting attendance. The proposed group requires ordinance amendment with implementation of the proposed model.

Truth in Taxation

The council held a public hearing involving the Truth in Taxation information. A senior citizen attended the meeting discussing the impact on personal tax impact of senior citizens requesting reconsideration. Request was mad for some sort of relief be applied for seniors, as well as consideration of an annual cap for property that had not been improved. Additionally, request was submitted to find some budget cuts to consider delaying some expenses to a future date. Another citizen was present for clarification and request also to reconsider the proposed budget and tax levy on behalf of retired citizens within the community. No action would occur at the present time however in the future the consideration and adoption of the final budget and levy would occur. The council had opted not to adopt the franchise fees which would have resulted in additional charges on resident bills for services such as cable and electricity.

The council discussed the 2022 Property Tax Levy and Budget at their meeting requiring adopting resolution certifying the levy. After reviewing the process and the numbers from past meetings throughout the year. A new Finance Director position was also identified in the city's strategic plan. The fund revenues expenditures, financial levy history and recommendation to approve the resolution were all discussed. Motion was made and carried adopting the resolution with all ayes certifying the 2022 Property Tax Levy in said amount. Motion was made and carried adopting the resolution with all ayes approving the 2022 Budget.

Policing Services

Council discussed and reviewed the contract for police services. Amendments to the contract were discussed and reviewed. Motion was made and carried with all ayes entering into the contract for Police Services with the Carver County Sheriff's Office.

River Side Park Redevelopment

The community development director discussed the RiverSide Park Redevelopment plans, an item identified as an action item in the Strategic Plan. Discussion focused on using the park as a hybrid of active and passive uses with the goal of highlighting natural features. The proposed concept shows portions of the park with natural prairie planting with mowed trails as opposed to current conditions of fully mowed park area. Another idea involved adding a vehicular river overlook in the park. Mention has been made that many visit the park to relax in their vehicles during the day and for lunch time. The archery range, campsites and robust tree canopy would remain intact. A phased approach is necessary based on budget constraints. Future projects could include bird habitat viewing, improvements to the camp ground and an additional overlook towards the existing wetland. The Parks Commission reviewed the proposed concept and were supportive with phase one. Phase One includes the vehicular overlook and native prairie seeding. Funding would come from Park Dedication. Future phases of redevelopment would be reviewed by the Planning Commission and council prior to execution. It was also deciphered that with native plantings that there would be less maintenance work required.

Utility Infrastructure

The council discussed authorization of preparation of a trunk area charge study for the Southwest and Big Woods future growth areas with the city engineer at their meeting. There has and continues to be future growth in the local community. This growth has been an increasing adjoining development primarily occurring on land directly adjoining recently developed areas. As development conventionally occurs, the extension of the city's trunk municipal utilities systems are also generated with this contiguous development. In the area being discussed there will not be any directly adjacent land readily available for continuing development. However, future growth areas identified within the Comprehensive Plan will be required to be reviewed for feasibility of expansion. The two areas recognized within the Comprehensive Plan are in the southwest area and the Big Woods areas. This area combined represents a significant portion of growth potential. The planned uses offer opportunities of housing, commercial and industrial development potential. These areas are not directly adjacent to developed property within the city, trunk utility extensions to service the areas, requiring considerable infrastructure costs. These large trunk system expansion costs could render the stated property as undevelopable without action by the city. Trunk area charges proactively provide a means to distribute a major trunk utility infrastructure expansion cost evenly to the properties directly benefitting from the expansion, paid back over time as the area develops. This charge structure can make these major noncontiguous growth areas feasible to develop from a cash flow perspective. The council reviewed the concept of utilizing trunk area charges allowing trunk utility infrastructure projects at former meetings. The recommended next step involves the city engineer to study the utility system costs, recommending area charges to extend trunk municipal utilities to the areas defined in the southwest and Big Woods proposed future growth areas.

Next Steps Concept Plan

The community development director presented the council with the concept plan for Next Steps Learning Center. The location is proposed for the Carver Commons area. The property currently home to Kwik Trip with additional commercial users anticipated. The daycare center meets intent with the zoning district of the property. Next Steps Learning Center has two other locations, one in Chaska and the other in Chanhassen. The stie plan plans accommodate one hundred eighty-nine children. Also plan shows four outdoor play spaces, site access and parking meet required infrastructure for the building. Hours of operation planned were Monday through Friday with the hours of 6:30 AM to 6 PM. Carver Commons streets are private with plowing and maintenance the responsibility of the property owners. Utilities are available. Trail access to the building site was also discussed. Request was submitted for rezoning of Planned Commercial Development to accommodate the building layout. The proposed project has been reviewed by the Planning Commission who were supportive of the project. Projections anticipated to be quick with the platting process. The Planning Commission and council would expect to consider the Preliminary Plat, Rezoning and Final Plat at one meeting since the platting of commercial property generally is far less complex. If approvals continue on schedule, the learning center anticipates opening its doors in early winter of 2022.

2022 Street Maintenance

The assistant city engineer discussed with the council the 2022 Street Maintenance Projects requesting authorization of preparation of Plans and Specifications for said projects. Existing streets continue to age with new streets added to the existing system. Whereas, it is important to develop and follow a systematic approach to street maintenance. Recognizing this facet, the first Pavement Management Plan was developed. The first phase of this system identified areas requiring maintenance. The next step in the process is preparations for final plans and specifications for the project. Funding the project was also discussed.

State Opioid Settlements

The city attorney discussed the Ste Opioid Settlement with the council. The review of the resolution involving approval of the memorandum of Agreement between the state and local governments and authorization participation in National Opioid Settlements was reviewed. Recently, the MN Attorney General's Office finalized settlements with certain opioid distributors and manufacturers. These settlements are part of national opioid litigation. All MN cities are eligible to participate in the settlement, but to do so, a city must approve and sign the agreement. The resolution presented provides the requisite authority. The agreement and two participation forms were reviewed. Participating in the settlements required the city to release any claims. The cities are entitled to receive local allocations under the settlements with populations more than thirty thousand, local public health authority and those with initiated litigation on their own. The agreement supplied a list of public entitled public entities for allocation. Carver is not included on this list. Although the city is not entitled to direct allocations, only cities that participate in the settlements are eligible for future grant money and other potential programming that might originate settlement dollars. It is unknown if the city will participate in future state or county programming, but failure to participate in present settlement procedures will likely preclude later participation. There is a push for all cities to sign because it will have a substantial impact on the total dollar amount received. The attorney recommended participation.



Derek often works in his shop late into the evening, as such, Nicole went to bed for the night thinking he was in the shop. When she awoke in the morning to find him not in bed, she called a friend to come help look for him. Derek was out in the elements, suffering from his injuries all night. Their loyal dog stayed with him the duration of the night and barked to alert the friend to their location."



Courtney's January Input

As I look forward to 2022, I'd also like to take a look back at 2021 and share the 10 items that, in my opinion, were the most noteworthy in our community.

- 10. Veggies Galore 2021 was the inaugural year for the Carver Farmers Market and our Community Gardens. Both were great additions to our community and made it easier to get fresh produce in Carver.
- 9. New Website Early last year <u>CityOfCarver.com</u> got a much-needed facelift! The updates to our website produced a modern, more user-friendly site, which is searchable and easy to navigate.
- 8. PHEV Purchase In July we purchased a PHEV (Plug-in Electric Hybrid Vehicle) for our Community Development Department, which uses it for daily building inspections. The vehicle runs on electric power with a gas backup when the battery has been exhausted. So far, we haven't had to refill the gas tank!
- 7. Space Study After working with architects and engineers on a space study, we identified the need to construct a 9,600 sq. ft. vehicle and equipment building. The proposed building site would be just west of the existing Fire Station/Public Services building. The Space Study also identified a need to construct an 820 sq. ft. addition on to the south side of the existing Fire Station to house firefighters' turn-out gear in a room separate from the fire garage, with its own ventilation system.



- 5. LRIP Grant Carver won a \$1.25M Local Road Improvement Program (LRIP) grant from MnDOT which will be used to make improvements to 6th Street West. The project will include full-depth pavement reclamation, enhancements to the storm sewer system to alleviate flooding, and pedestrian and bicycle mobility improvements along the corridor, and will take place this summer.
- 4. Levee Progress Last summer and fall we had visits from Representative Tom Emmer, and both the Minnesota House and Senate Capital Investment Committees, all who walked the levee with me and learned about the City of Carver's need for funding to make improvements to this vital piece of infrastructure. I'm hopeful 2022 will bring additional funding to continue our momentum on this project!
- 3. Watering Ban Last summer amid a drought and on some of the hottest days of the summer, we had a watering ban for eight days. With two new wells and our Water Treatment Facility expansion which will all go into service this year, in addition to repairs to the existing well we are making this winter, I'm confident we won't have another watering ban anytime soon.
- 2. Pavement Management Plan This plan was built around an annual investment in street maintenance, while incorporating recommended street maintenance best management practices such as bituminous mill and overlays, reclamations, a seal coat and crack seal program, and reserving funds for miscellaneous repair needs. The repair and replacement of streets as identified in the Pavement Management Fund will be financed through the Street Maintenance Fund which is part of our General Fund Budget NOT Franchise Fees.
- 1. JCP Improvement Project The most memorable event in Carver last year was the Jonathan Carver Parkway (JCP) Improvement Project. After seven months of construction, we now have a beautiful corridor which will safely and efficiently move traffic throughout our community for a long time to come!



continuing whether or not access will be allowed through adjoining neighborhoods. The Orderly Annexation agreement is being referenced as to how to handle the situation.

The Carver County Parks representative presented a preliminary plan for a park at Miller Lake to the Dahlgren Township board members. Statement was given that that in initial discussions at this time is that there are not any specific decisions on what the park will look like such as boating, camping etc. Resident expressed concerns regarding gravesites near the proposed area. Assurances were given that the sties would be preserved, as well as incorporated into the park design. Request was submitted to name the park "Miller Park". Concerns were also given from township residents near the proposed park regarding potential trails connecting the park to Waconia and Carver. Land owners would be consulted and worked with in the future if trails were to be built.

Additional information found on line states that Miller Lake is a hundred forty-acre, class forty-three lake. The lake connects with Carver Creek and then ultimately to the Minnesota River. Also discussed was the sportfish community of fish in the lake. Miller Lake is surrounded by private land and no public access exists. Therefore, it would be very unwise to go searching to access the lake. Warning: This is for information purposes only regarding the discussion of preliminary plans to create a park by the county.


