## Mayor Courtney's March Update

The City of Carver has a great system of parks and trails. We're fortunate to have some unique natural features and lots of outdoor space to explore and enjoy in our community. Carver stands apart from may suburban communities with an estimated 50% of its overall land area preserved and protected as either public parks or natural habitat, including nearly 600 acres within the Minnesota Valley National Wildlife Refuge. This month, I'm going to share more about what goes into the planning process for new parks in Carver.

In 2019, Council adopted the Parks Master Plan, a guiding document that supports and sets the framework for park development in the City of Carver through 2040. The Parks Master Plan contains lots of information, including details on future park needs and development.

Within the Parks Master Plan four search areas have been identified, each which could develop into parks in the future. One search area is downtown Carver. The area which has been identified for a future park is near the intersection of Broadway and Main where a Public Services building/the former fire station now stands. The preliminary concept for the new downtown park includes a community gathering space featuring a splash pad. For development of a park to occur in this area, demolition of the building will be necessary. Right now, the downtown park isn't expected to develop

until 2026 at the earliest.

More immediately, construction on an expansion to Ironwood Park, which is located west of Carver Elementary, will begin in the spring. The 3.5-acre expansion will include a park pavilion, outdoor classroom, basketball court, skate park, seating areas throughout the park and permanent games including corn hole and ping pong.

So, how are the planned future parks paid for? Construction of parks is paid for through the Park Dedication Fund. The Park Dedication Fund generates revenue from an annual contribution from the City's General Fund (=property taxes) and fees collected from new development. Money from the Park Dedication Fund can only be used for the acquisition and development or improvement of parks, recreational facilities, playgrounds, trails, wetlands or open space based on the Parks Master Plan.

#### Public Works Department

The city council welcomed and introduced two employees. Both gentlemen will be serving as Public Services Technicians III in the Public Works Department. Welcome to Carter Borg and Austin Buetow.

#### Miscellaneous

The Fire Services Agreement was discussed with the council relating to the Dahlgren and San Francisco Townships. Motions were made and carried with all ayes adopting fire services agreement with Dahlgren and San Francisco Townships.

Resolution regarding support of housing and local decision authority was discussed by the city manager pertaining to the League of Minnesota's efforts to apply changes to the legislative proposes that negatively impact local decision-making authority relating to planning and building inspection services. The mayor added that the resolution also supports several of the city's legislative priorities. Motion was made and carried with all ayes adopting the resolution in support of housing and local decision-making authority.

Council member took the time to thank Parks Commission members for their time and efforts while serving. The Parks Commission will be replaced with a parks advisory group.

#### Special Event Ordinance

The city attorney reviewed the issue of discussing the Special Event Ordinance. He provided the council with preliminary information for developing and adopting an ordinance that would regulate special events which was also identified as a priority in the city's Strategic Plan. Large special events require significant public resources such as additional police patrol, fire safety accommodations, road closures, parking issues, and insurance coverage. There is also the impact regarding the overall health, safety and welfare of the community. Numerous Minnesota cities have adopted this type of ordinance to ensure events in the communities are handled in a systematic way. Ordinances of this kind provide clear sets of rules and expectations while at the same time providing an orderly process for the planning and execution of the events. Information provided to the council involved the item relating to the Authority to Regulate involving the constitutional considerations since there would be a relativity broad authority to regulate events. One-size-fits-all ordinance doesn't exist, common components are the guide to composition. The contents of the composition intentions are to protect the city and the public from the risks and liabilities inherent to large events, provisions regarding penalties and enforcements. The requirements are to provide useful enforcement tools. The next process required is the city's consideration of the ordinance and preparing the rough draft for review and discussion.

## Housing Development Update

The Community Development Director updated the council on the housing development where the Carver County Community Development Agency has been working towards a second multifamily structure that is adjacent to Carver Crossing. For several years the site has been platted along with the approval of Copper Hills. Funding was recently received through Carver County making the project feasible. The building concept includes one hundred three multi-family units split between independent senior living identified as 'Carver Oaks' consisting of forty-three rooms and general occupancy, sixty units, identified as 'Carver Place'. The proposed units meet with both the city's Comprehensive Plan and the density established in the Planned Residential Development district approved for in the existing units in Copper Hills and Carver Crossing. There is not any active application presently but will be soon. The conversation during the council's work session included providing a history of the property and previous approvals, along with providing an overview of the proposed project. The Planning Commission reviewed the information. There is no financial impact since the project is in the conceptual stages.

The Planning Commission members discussed the Community Development Agency's Concept Plan on Hartwell Drive. As stated, the units for senior housing and general occupancy housing were reviewed. Question was asked if the Community Development Agency had any other owned or managed properties. The agency manages Bluff Creek Apartments which has eighteen units. The proposed project has one hundred and three units which is the maximum allowed for zoning. Request had been submitted to be cognizant of the views and landscaping affecting residents in the Copper Hills development. Residents from Oak Tree development recently submitted feedback regarding additional landscaping and screening of the parking lot. Other requirement items were reviewed and discussed and questions answered.

## Housing Action Plan

The Community Development Director gave background information relating to the presented Housing Action Plan draft. Questions were asked pertaining to updating feedback into the plan and former discussion of items were inclusive. The director indicated that the 'develop and administer an inclusionary housing policy with requirements' was added. Another council member inquired about revisiting the plan and if discussions could be included with the Strategic Plan. A date stamp on the plan was also discussed. Concern was voiced pertaining to the developer's requirements mandating fees. This requirement related only if there was an affordable housing component involved along with city funding or resources, not in all developments. The initiation of Carver Crossing the developers and the Community Development Agency already had funding in place. Clarification was reiterated that affordable housing does not mean a new single-family home nor is the Housing Action Plan a part of the Strategic Plan. This is an on-going plan requiring continual reviewal. Additionally, smaller cities need to start with some form of a plan with the fact in mind that the smaller cities do not have all the resources a larger city may have. Motion made and carried with four ayes and one nay adopting the Housing Action Plan. The city Manager also clarified this was an adoption of a Housing Action Plan not a formal policy. The plan would be discussed further and policies developed as necessary from this point going forward.

### Green Step Cities

The Community Development Director updated the council on the GreenStep Cities program that is Minnesota based and a voluntary program encouraging, supporting and celebrating work that cities have been doing related to energy efficiency and renewable energy. The city joined as a Step One City requiring a resolution to join the program. Staff anticipated advancement in the program based on practices already being completed. The staff completed reporting on the six best practices required to advance to a GreenStep Step Two City. There is not any financial commitment outside staff time.

#### Fire Department

The Fire Department informed the council that four members of the Fire Department have graduated the Fire Academy. Congratulations.



## Temporary Limitations

The city attorney discussed the issue relating to statutory limitations on temporary on-sale intoxicating liquor licenses. The city has authorizing to issue temporary licenses to said organizations. State legislature has imposed some statutory limitations on all Minnesota cities, regardless of their populations when issuing of temporary licenses. Specifically, no city can issue more than twelve days' worth of Temporary Licenses per location in a single year. Additionally, a city with a population of more than five thousand may not issue more than one Temporary License to any one organization, one location, within any thirty-day period unless issued in connection with an officially designated community festival which now means the City of Carver is subject to the thirty-day limitations described. This results in the fact that accurate records pertaining to temporary licenses that are issued inclusive of the council, organizations, event locations and dates of the events to ensure compliance. Communications with organizations and applicants should be reminded of the limitations when applications are presented for consideration. Provisions within these limitations were also discussed. The council retains the discretion to decide organizations issuance of licenses adhering to the limitations. Provisions were reviewed. Conclusively, the staff and the council must be mindful of the limitations related to the Temporary licenses, inclusive of the applications relating to population size and how they relate to the requests submitted.

### Organizations Updates

The council and the Community Development Director discussed amending city code ordinance relating to commission appointments in city organizations. These amendments need to reflect important goals to be accomplished in the city's formal commissions. It was discovered that the terms of the Planning Commission terms are not appropriately staggered. Four seats are set to expire in March. The ordinance, if adopted would correct the issue establishing a shorter two-year term for the two alternate members scheduled to begin respective terms in March, thereafter all members, including voting and alternate would serve staggered three-year terms. Also, existing code language relating to the planning and heritage preservation commissions pertaining to alternate and member vacancies is not clear nor consistent. Adopting the amended ordinance would clarify that both commissions have a first and second alternate. If one or more voting member were not present, the alternate would be authorized to vote in their place, as well as vacancies be filled with the first alternate, replacing second alternate to first alternate. Then the council would make any appointments necessary to fill vacancies that are not automatically filled by this process. Finally, the discussion turned to the recommendation to replace the city parks commission with a parks advisory group comprised of community input and feedback regarding the city's parks and recreation programs. The ordinance discussed, if adopted, would remove all existing code provisions establishing the city's parks commission. The city's staff would facilitate meetings of the newly formed parks advisory group anticipated to gather two to four times annually where residents attend a roundtable discussion with staff to discuss parks and recreation programs.

This less formal approach would be similar to the community engagement achieved through the Carver Business Alliance. The ordinance if adopted would supplement the planning commission's role to include the provision to advise the council on issues related to public parks, recreation and greenspace ensuring consistency with the Comprehensive Plan. Removing the parks commission requires a unanimous vote of the council per state law.

#### Conduit Bond

The city manager discussed a conduit bond issuance and to authorize a Public Hearing. The city manager called for a public hearing to be considered regarding issuance of educational facilities revenue notes. The city received a request to participate in the issuance of conduit revenue bonds by Taft on behalf of Southwest Christian High School. State statutes allow cities to issue such bonds. This transaction does allow the borrower the ability to obtain better interest rates. The city takes no risk in the transaction, has no role in payment of bonds and does not pay debt service or any other costs related to the transaction, nor does it have any effect on the City's credit rating. The city can only issue said stated amount in bank-qualified bonds per calendar year reducing the city's bond capacity. It is not believed that this would impact the city's borrowing needs in 2022. Under this proposal, based on the stated amount of refinancing conduit debt issued, collection of administrative fee related to the bond issuance would also occur.

## Great Greening Grant Hyreement

The Community Development Director updated the council pertaining to the Great River Greening Grant Agreement for Creekside Park. The city partnered with Great River Greening for applications to Environment and Natural Resources Trust Fund and the Outdoor Heritage Fund. The applications were awarded funds from each organization. The city is required to mate stated monetary fuds from the Park Dedication fund. This funding applies to streambank stabilization, floodplain site preparation and seeding, removal of invasive species and grant administration. Question was asked regarding an open timeframe for park area marked 'to be programmed'. The director answered that there was no requirement in the agreement. The anticipated plan is to have feedback from the Parks Advisory Group. Inquiry was made questioning the agreement would help prepare the site becoming a long-term park. The answer was yes. Council member expressed request that the Park Advisory Group be involved in the development of the park. Moving forward would involve the general design in the Parks Master Plan. The presented draft may be modified as the plans progress but the work with Great River Greening will not impact the general plans for the park. Question was asked about timeline for completion of any other park would be impacted. An issue was not foreseen seeing strong development funding the Park Dedication Fund. Tentative planning of the downtown park completion was also asked about. The completion was thought to be estimated in 2026. Completion of site preparation while completing the downtown park should not be affected by funding. The site budget had been put together enlisting the correct resources. Question was asked if another grant from the same organization could be explored for streambank stabilization at Riverside Park. This possibility was already inquired about. Follow up would be pursued. Motion was made and carried with all ayes to enter into a grant agreement with Great River Greening for development of Creekside Park.

#### Carver Business Alliance

Carver Business Alliance "The Carver Business Alliance is a collaboration of business owners, community leaders, and local officials working together to promote, enhance, and create opportunities for commerce in the City of Carver. Business roundtable discussions are held and City of Carver updates are provided at each meeting." They meet every third Friday of the month at 11 AM at the Carver Village Hall. Anyone owning a business in Carver is welcome. The next scheduled meeting is March 18th.


