# Third Street Bridge

The council reviewed at their work session information relating to the Third Street Bridge project with the city engineer who discussed the history of the bridge, needs, the status and the next phase. Further discussions will be held to authorize proceeding with Plans and Specifications.

#### Green Step Cities

The Community Development Director at the councils work session updated the council on their participation status with the program. The staff advanced to a Step Two City by completing reporting of the six best practices required. These steps were completed based on daily practices throughout the city. Recognition will he heard and recognized in June at the League of MN Cities Conference. An annual update of the program had been requested.

#### Miscellaneous

The city manager informed the council at a work session meeting that Bolton and Menk's staff member will be working with the city while the Community Development Director takes a leave of absence in spring.

City staff conducted interviews for the Finance Director position narrowing it to two candidates. The city manager will conduct the final interview along with the city engineer and attorney to offer the position to the final candidate.

The part-time administrative assistant will be missed and was a great asset the council was informed as she has accepted another position, elsewhere. Other information relating to the new decorative lights were erected on Jonathan Carver Parkway, the first two monuments were unveiled and two other monuments on the northwest corner are to be completed. The council held a special meeting to interview members for both, Planning Commission and Heritage Preservation member vacancies.

The first meeting for the Steamboat Days committee will be held within a few weeks.

The Public Services Director discussed the purchase of road salt for the 2021-2022 contract were discussed with the council. Each year the city bids on road salt with the State of Minnesota as a cooperative purchasing venture member. For the 2021-2022 season request has been submitted for three hundred tons of salt for the allotment to the current contract which would fully replenish the reserves. Previously the city had to make two smaller purchases throughout the season based on current needs. At this time, the department would like to make one large purchase to restock the supply.

## Gettysburg Leadership Institute

The council discussed authorization of the city manager attending the Gettysburg Leadership Institute in Pennsylvania. The ICMA (International City/County Management Association ) is an international organization committed to developing and advancing professional local government management to create sustainable communities. The ICMA had developed a credentialling program to recognize professional local government mangers qualified by education, experience, adherence to high standards of integrity and an assessed commitment to lifelong learning and professional development. The city manager of Carver has been recognized by the ICMA as a Credentialed Manager since 2010. The ICMA is hosting Gettysburg Leadership Institute to provide significant opportunities for professional development. The city council found it beneficial and worthwhile to send the city manager to this institute.

# Funky Minds

The council extended a thank you and credit to Shelley Rudolf and Anna Edlund who spent much time on hosting the Light and Seek event with ice crystal luminaries. For similar types of events check Facebook pages

The Light and Seek event per the Funky Minds leadership was a lovely weekend with ice lanterns spreading light in a magical setting in Riverside Park, and along the MN River levee to downtown Carver. Funky Minds is a non-profit organization based in downtown Carver and was founded in 2003 by Anna Edlund. "The goal of the organization is to build the local community by expanding the hearts, minds and futures of local youth through a variety of no-cost initiatives. Those initiatives include after-school activities, summer programs, homework assistance sessions, community beauty-fication projects, civic engagement, volunteerism and access to technology for youth who do not have it."

#### Community Gardens

The council needed to approve the Carver County SHIP (Statewide Health Improvement Program ) Grant Agreement for the Community Gardens, Phase 2. In 2020 the council and staff created a plan for the installation of the community gardens which are presently located on the site of the Carver-On-The-Minnesota church site in downtown Carver. Two phases for the gardens were included in the plans. Phase 1 was the creation and installation of said plots. Phase 2 includes additional plots. Phase 1 installation occurred in 2021 which was very successful with reservations for all eighteen plots. Based on this success the city will proceed with Phase 2 in 2022. Additionally, the city expressed interest in adding perimeter fencing to discourage small critters from taking produce. Reimbursements were received for expenses incurred in Phase 1. Cost estimates for Phase 2 have been estimated.

With that process in mind, the city applied for additional SHIP funding. Notification had been received that the requested funds will be awarded if the city continues to move forward with their plans. The gran provides funds for supplies. The city's responsibilities include in-kind contributions in the form of labor and other miscellaneous expenses.

## Water Treatment Facility

The city engineer discussed the change order involving the Water Treatment Facility Improvements project. The project includes new construction on the existing treatment facility. In addition to the new infrastructure, substantial internal upgrades and reconfigurations are being made within the existing facility to complement the overall facility expansion. The substantial amount of reconfiguration required and to provide continuity, the painting of interior is recommended. These costs would be paid with the project budget. There is sufficient contingency programming within the original bonding budget to fund the change order cost.

#### Sixth Street

Sixth Street is a State Aid Street. A parking update will be completed by the city engineer. The engineer spoke of standard document for a state aid route. Part of the application process inquiries about road width supporting parking on both sides which in the case of this street, it is not. Therefore, there has to be a State Aid Resolution to document stated parking will not be allowed by the city. The document must be provided with the Plan and the Resolution to be attached to the application. Authorization of the Plans and Spec has already been approved. Presently there are not any guidelines for 'no parking' signs but posting will be required.

The assistant city engineer discussed with the council the parking restrictions on Sixth Street West. The council had established previously the necessity for reconstruction on the street serving as a main collector street between Jonathan Carver Parkway and the downtown area, along with surrounding regions. This street not only serves to accommodate vehicles, it also is utilized by pedestrians and bicyclists. Due to the city's recent application for local road improvement program administered by MN Dot the project was selected for the grant program with full funding. Additionally, Sixth Street West is a state aid route on the City's Municipal Sate Aid Street System. Therefore, state aid rules must be followed for funding eligibility. One of those rules involves the widths accommodating park. The street involved is not wide enough to allow parking. Bike lanes are also scheduled to be installed prohibiting street parking, as well. A parking restriction resolution will be necessary in order to obtain state aid plan approval and project funding. The restrictions would be implemented in conjunction with the completion of the improvement project scheduled to be substantially completed in the fall of 2022.

The city engineer discussed the Plans and Specifications for the Sixth Street West Improvements. The council reviewed the resolution to approve the plans and specifications and order advertisement for bids. Previous needs were identified previously to reconstruct the Sixth Street West Road which serves as the city's main collector. The failing corridor conveys significant amounts of stormwater runoff that cannot adequately be maintained with the existing storm sewer system that has led to localized flooding and icing issues, as well as private property impacts.

Funding request had been submitted to improve safety, address transportation deficiencies and contribute to development. The Sixth Street project was selected for the grant program with full program funding. The council reviewed the major components that would be addressed. The definitive project schedule cannot be completed due to the current market conditions resulting in historical supply delays impacting completion dates.

Statutory Liability Limits

The council along with the city clerk reviewed the discussion of a motion to not waive statutory liability limits was held at the council meeting. The council was told that cities obtaining liability coverage from the League of MN Cities Insurance Trust must make a decision on whether or not to waive the liability limits to the extent of the coverage purchased. In the past, the city opted to not purchase excess liability coverage. Additionally, the city had also opted not to waive the monetary limits established by MN statutes. If the city chooses to not waive the statutory tort limits, an individual would be able to recover a large sum on any claim which these tort limits apply to. Limit amounts were discussed. These limits apply regardless whether or not the city purchases the optional excess liability coverage. If the city were to wave the limits and did not purchase excess liability coverage, a claimant could potentially recover a far more substantial amount for a single occurrence. With this option the tort cap liability limits area waived to the extent of the members liability coverage limits and the LCMIT per occurrence limit amount. The total all claimants could recover for a single occurrence which the statutory tort limits apply would be limited regardless of the number of claimants. If the city waives the statutory tort limits and purchases excess liability coverage, a single claimant could potentially recover an amount to the limit of the coverage purchased. The total all claimants would be able to recover for a single occurrence which the statutory tort limits apply would also be limited of coverage purchased. There is not any additional cost to the city for not waiving these limits. The city in the past has consistently chosen not to waive liability limits.

# Next Steps Learning Center

The Community Development Director discussed the Preliminary Plat, Rezoning and Final Plat for the Next Steps Learning Center with the Planning Commission. Reviewal of project approvals, hold public hearing, location and size were reviewed. The property is in the Carver Commons located in the southwest corner of the Jonathan Carver Parkway and Highway 212 intersection. The Planning Commission reviewed the Concept Plan for the Next Step Learning Center. Overall, both government units had positive feedback for the project with the request for an additional trail into the site. This area is commercially zoned parcel. Area is developed as the Carver Commons. Kwik Trip was the first business on the property having opened late in 2020. United Properties is the current land owner as a commercial property investment company. United Properties and the city have been working together to acquire additional tenants to fill out the commercial node at the corner of the major intersection in Carver. It is anticipated that there will be additional commercial users on the site. Next Steps is a childcare facility with locations in Chaska and Chanhassen seeking to expand into the Carver are having submitted an application for a Preliminary Plat, rezoning and Final Plat for the reviewal of the Planning Commission and the council. The Concept Plan shows a building, parking lot, and four outdoor play areas. The information included conforms to the Concept Plan and had been reviewed by the Planning Commission. Development and approvals of comercial projects move through the process simultaneously due to the nature of the site and the number of buildings. Staff completed review and the project meets the requirements of both the Preliminary and Final Plats. Both steps are requested to be reviewed simultaneously by the Planning Commission. A daycare is a permitted use in the Freeway Commercial District and meets the intent of the ordinance. The overall sit is zoned Freeway Commercial and this project requires a Planned Commercial District ( PCD ). Reviewal of the bulk regulations and deviations requested by the developer were reviewed. Streets within the Carver Commons are private. An extension is required to the stubbed street to offer access into the Next Steps site. The staff and the developer worked on the trail connection from Monroe Drive into the site. The trail will be on the west side of the full access into the Kwik Trip site. Additional users in the Carver Commons will also be required to connect into the trail system. The Planning Commission will review the information, as well as staff presentation, along with the project requiring a Public Hearing by the commission. Then the Commission will forward their recommendation onto the council.

#### Employee Survey

The city manager discussed the Employee Survey draft - Strategic Plan item with the council requiring staff direction and feedback. The council identified an initiative to conduct an employee survey. Two drafted surveys have been created for review. "Due to some distinct characteristics between the part-time and full-time employee experience, a separate survey was created for part-time employees within the Fire Department in cooperation with the Fire Chief. The survey is planned to be administered in May, with the help of an online survey tool. The intention is to conduct the employee survey on an annual basis, in order to provide the ability to measure results from year to year. Employee respondents will be able to take the survey anonymously. Once the survey has been completed by employee participants, the City's leadership team will review and report the results to the City Council. Based on the data provided, a corresponding "action plan" will be created and reported to the Council and shared with members of the employee team to address opportunities for learning and growth within the organization."

Employee Service Recognition

The following employees were recognized for their service by the Mayor, Courtney Johnson. They were Firefighters, Joseph Grady, Michael Griesinger, Shaun Cox and Corey Trebiatowski. The other employee recognized was the Deputy Clerk, Brenda Good.

#### Carver Business Alliance

Carver Business Alliance "The Carver Business Alliance is a collaboration of business owners, community leaders, and local officials working together to promote, enhance, and create opportunities for commerce in the City of Carver. Business roundtable discussions are held and City of Carver updates are provided at each meeting." They meet every third Friday of the month at 11 AM at the Carver Village Hall. Anyone owning a business in Carver is welcome. The next scheduled meeting is April 15th.

#### Brookeview Development

The Community Development Director discussed the Brookeview Preliminary Plat and rezoning application with the Planning Commission members. Background information was reviewed regarding the application by Manley Development. The property is located south of Meadows at Spring Creek with an extension via Mulberry Drive. Question was asked for details regarding a private street versus a public one. The assistant city engineer explained that a public street meets the city's standards. Private streets on the other hand are roads that do not meet city's standards. Those are reviewed by the city staff determining approval or disapproval of requests. Statement was made that private roads still meet fire code requirements. The development is requesting a reduction to add the buffer with landscaping. Question was asked if residents would be responsible for maintenance and plowing which was clarified as correct. Question was asked what responsibilities would be handled by a Homeowner's Association. The development did not anticipate a creation of a Homeowner's Association. Inquiry was made regarding the type of parking planned for. Additional parking at this time did not exist. If additional parking were added, it would distract from the buffer. Question was asked about the responsible party for Outlot A. Expectations at this point are that the city would be responsible. The maintenance of erosion control and trail system requirements would be similar to the outlot in Hawthorne Ridge. Member expressed concern of erosion and the city's responsibility if erosion were to occur. The community development director pointed out that erosion concerns would be the responsibility of property owners which would likely be the homeowner's association. The Planning Commission board opened the Public Hearing on the Brookeview development. Multiple residents asked questions, voiced concerns, objections as well as expressing their opinions during the hearing. The Community Development Director, Assistant Engineer and the City attorney provided information for clarification. Fire truck access in a cul-de-sac is ninety-two feet. Density calculations will be done by city staff. An unfavored trail can reevaluated. Th letter of credit held by the city does not decrease as the project progression. Streets are public in front of homes; city cannot regulate parking on those public streets. Any vehicle parked for an extensive period of time should be reported to the police department. Developer comments are not related to Land Use Application. The project is entirely in the city limits so the Carver County Land Management is not required to review the project. Squares on the map signify buildable areas not house locations. Location of the constructed house deems construction of a deck. The construction engineer is on site ensuring construction compliance is upheld. The city has no financial gain aside from tax base and park dedication funds. City code defines a significant tree as eight inches in diameter or greater as the requirement to be followed. The city's role is not to either watch or determine the types of homes being constructed. A lighting plan would be upheld minus light pollution into existing homes. Background checks of developers are not role cities assume. Cities are held to a different standard regrading street construction where a public bidding process is required. The city's responsibility is street maintenance and is not equipped to do the construction of the street. Privacy concerns are open for discussions along with resolutions. Developers are not hired by the city, rather property owners choose someone who then comes to the city with a plan. A builder who doesn't want to follow the set up plans, requires re-platting involving the requirement to be heard by the Planning Commission and the city council. Then the process starts over at that point. Since Mulberry is a public street, there is no plans to erect "No Parking Signs". The types of homes proposed to be construct are not known since a builder has not been selected. That information would be forthcoming and shared when knowns. Expectations that a storm water pond would be constructed and the city would maintain. The bulk of scrub trees will be removed from the lot. Since the builder at this time is not known, the fees are not determined either which would be established at the time a builder is determined. The Parks Master Plan was adopted in 2018 which is an ongoing plan being worked on constantly. The city had moved from pocket parks to a more regional park allowing for greater development.

Park Dedication funds pertaining to approval of plans and specifications for an expansion of Ironwood Park, investing a substantial amount of monies into that park. A concrete skate park, a basketball park, pavilion, an outdoor classroom for Carver Elementary and some extensive trails will all be added to the future parks planning goals. This Master Plan is a good resource and available on the city's website.

Construction costs are outrageous presently. However, it is the developer's decision whether or not to move forward with their plans and projects. The Sheriff's Department has been alerted and requested to monitor traffic in the Meadows area related to construction traffic. PRD is Planned Residential Development which is a process in the City's code; not a variance. To obtain a variance a hardship must be established to allow an amendment to a rule. A variance is not necessary for a Planned Residential Development (PRD). Rezoning-2 to Planned Residential Development is common for cities relating to smaller and larger sizes in districts. The Park Dedication requirements are defined by land and finances. Much of the Park Dedication funds have been allocated for Ironwood Park. Additional plans are in site for additional parks that would include dog park, splash pad, and a full baseball/softball complex in the city's growth area. A comment pertaining to fifteen percent of a Planned Residential Development being preserved for a common open space where a bluff area would qualify.

The assistant city engineer addressed the storm water management issue. During the Concept Plan approval phase, staff worked very closely with the developer's engineer regarding this issue. An extensive network of pond and filtration basin controlling storm water leaving the site was completed. To prevent erosion of the bluff, discharge would be routed through the existing storm sewer system. It was considered a big accomplishment for this project.

A storm pons system has also been reviewed on the east side of the property being reviewed. The systems have been designed for a hundred-year rainfall event which is the highest design standard for storm sewers. Bluff protection and erosion control throughout the entire development project will use a silt fence aligning the bluff setback.

East/West private drives with the cul-de-sac discussion involved explanation that grading with bluff setbacks does not allow for homes to go on the north side which essentially are backing the existing lots within the Meadows at Spring Creek. It is not possible to get a road across the area either. Topographic perspective, the grade naturally drops off to the south aligning with home placement back yard grade decrease.

Question was asked if the review process with the Watershed District has begun. The project is within the Lower MN Watershed District. There is a municipal agreement with the watershed board where the city reviews and administers all storm water permitting rules for the district. The city's ordinance are consistent with the district's rules.

Regarding the topic of staff reports, recommendations and the Public Hearing processes. It is standard practice for city staff provide a written report to the Planning Commission prior to a public hearing. The reports contain staff recommendations about the project. The Planning Commission makes its recommendations after hearing public comments. Nothing done on the application deviates from the standard practice that the city utilizes with any land applications. Denying land use applications are not valid reasons based on comments regarding the developer. The Planning Commission focus is on the merits of the application, public input and items brought to the board's attention.

The issue of letter of credit is the city always protects its interest and the interests of the community in development agreements. The development agreements always include a financial security requirement. This ensures proper construction. These letters of credit are irrevocable and always required. It is a guarantee by a federally insured bank to pay the city if there is a developer default. Terms cannot be changed by the developer while the city has the opportunity to draw on the entire amount.

The commissioner inquired about the side yard setback decrease meeting the requirements. The Community Development Director stated that additionally to the side yard setbacks, the request made was lot size decrease.

The city does not gain financially from development projects. The residents benefit from lower taxes and new parks.

The function of the Planning Commission is to protect residents and property owners, along with those who in the future desire to relocate in the area. Outlot A is almost as big as the developed area. Therefore, protecting a large piece of property in that outlot. The number of houses was questioned. The director explained that the city sets the density, not the specific number of lots. The developer establishes the number planned lots. This project meets the density requirements, but the number of proposed lots can be reviewed. Different calculations are run. Statement was made that there was a lot of input received. The Planning Commission establishes their recommendations to approve contingent upon decisions made by city staff, developer and residents. The commission does not have the right to deny a developer who meets the requirements. This particular development could be tweaked. Comment was made that it would be valuable to further research for the upper cul-de-sac to create a more acceptable buffer. Public, private street issues require more amendable solutions. Buffers, landscaping and size of some lots was reviewed in more depth. Density issues were discussed. Question was asked about density. The director pointed out that the density is set with the Comprehensive Plan and the Met Council sets the standards that the city must meet including the density requirement. An amendment could be made to the Comprehensive Plan but most likely would not be supported by the Met Council. The entire parcel is fourteen acres with only approximately six acres that are buildable. Question was asked about if the issue was approved at that meeting would it mean that approval of that would be for twenty-four lots. The director stated that the option would be to recommend approval of the Preliminary Plat with the intention that the staff and the developer return with density calculations. Board would like to see revisions to the plans. The land owners have the right to develop but it would be preferable that compromises are made prior to final approval. Statement was also made that lot numbers preferred to be changed and a reviewal of the summary meeting occur with the developer and the neighbors. Another comment was stated that favor of improvements to the disruption of the neighbors, lots numbers, improvements with the private street via landscaping and buffering. The attorney advised that the Planning Commission had two options. The first is a recommendation contingent on staff and developer seeking other options regarding the reduction of lots. The issue would be reviewed again by the Planning Commission. The next stop is the issue presented to the council to make a decision based on the findings. The second option was to table the recommendation giving the staff the opportunity to research options. The Public Hearing has been held and the public would be welcomed back to listen to future discussion. Question was asked if consideration of zoning request and preliminary plat could be separated into two separate meetings? The city attorney stated that it didn't make sense to separate the two actions. Question was then asked if there time to review different scenarios before the council meeting. The director stated that developer's purchase agreement could be affected but the Planning Commission there were two options to be chosen. The Planning Commission was reminded that they were recommending the final decision was the councils. Motion was made to recommend approval of the preliminary plat for Brookeview with the condition that the staff review the density and other options. Further discussion was held pertaining to concerns proceeding forward, allowing the council to make the final decision which basically then took the Planning Commission out of the discussion. Concerns were understood but the council would ultimately make the decision with the Planning Commission's input included. The council liaison stated their appreciation of the opportunity to hear the resident's input and feedback as it was very valuable. The Planning Commission's input, resident input and the commission's recommendations are all important facets of the governmental functions. From a timeline perspective, it would be feasible to move forward with the second option proposed by the attorney tabling the item. Question was asked whether or not the Planning Commission tabling the item would throw the project timeline. The director replied that it might affect the developer but the city I on a different timeline. A roll call vote was conducted with all ayes and the motion carried. Motion was made and carried with all ayes to recommend approval of rezoning for Brookeview with the condition that the city staff and the developer work together to review density calculations. Question was asked if there would be a Public Hearing for rezoning. The director stated that there will not be a Public Hearing but the council can choose to take public comments.

The Community Development Director discussed the Preliminary Plat and Rezoning of Brookeview with the council.

The council reviewed the adoption of the ordinance to rezone the property, and adoption of the resolution approving the Preliminary Plat. The proposed Concept Plan had been reviewed previously. Applications were found to be complete and in accordance with the City's Comprehensive Plan. The present Preliminary Plat shows twenty-two lots versus the original twenty-four lots. Plans and the Preliminary Plat additionally display two cul-de-sacs for home access and a proposed trail connecting into the city's larger trail system. The developer is Manley Development and will be sold to a builder once the planning process is complete. The project was reviewed with resident feedback by the Planning Commission. Significant changes to the Preliminary Plat and plans were completed. Those changes included lot reduction, realignment of Brookeview Court and with additional landscaping throughout the site. The changes reflected in an updated project information packet was delivered to affected property owners. t

The rezoning request involves changing from Agriculture to R2 with a Planned Residential Development ( PRD ) overlay. The rezoning request includes deviations from the R2 district on lot size with sideyard set back. Similar projects include Oak Tree, the Meadows at Spring Creek and River Bluff Estates. The Preliminary Plat and proposed plans have been reviewed by the city staff, adhering to adopted city standards and are similar to recent developments throughout the City of Carver. Feedback from the Planning Commission meeting were considered, resulting in changes in both the Plat and the plans. The Planning Commission unanimously recommended approval including requests to decrease lot count and increase buffering. Adopt the ordinance rezoning the property and approval of the Preliminary Plat were also recommended.

# Employee Policies

The city manager discussed the Employee Policies and amendments to the Employee Handbook with the council.

The city has a series of policies that document employee work place rules, leave provisions, fringe benefit and other related procedures. The council was being asked to consider approval of amendment to the Employee Handbook. Non-DOT / DOT provisions relate to rules established by the Department of Transportation for employees performing duties under the commercial driver's license. Staff consistently reviews and recommends amendments to these policy documents. Consideration for adoption by the council that amendments primarily include language clarification, updates to employment law and recommended formatting by the city attorney.

2022 Budget Amendment
The city manager discussed the 2022 Budget Amendment resolution. The manager reviewed the decision as part of the 2018 Budget that the city funded a part-time Administrative Assistant position. The position initially was created to handle increased and essential receptionist duties. Over time, the position has evolved into a more significant role, providing elevated customer and internal support services for the administration, community development and public services departments. As this workload and complexity increased, a second position was created in 2019. He further explained that the duties were split into a 'morning' and an 'afternoon' shift. Recently, the city has experienced a vacancy in one of the part-time positions, taking the opportunity to look at short and long-term staffing needs in this area. Based on the expanding workload, the increasing resilience of the position to provide core duties and services, the transient nature of the position and the ability to delay an additional full-time "Permit-Tech" Hire, a concept was developed to transition the existing part-time positions into one full-time position. A budget amendment is necessary to be considered and adopted. This creates a budget gap.

They had talked to Sara in advance and she promised them that she would serenade them or her beautiful grand piano while they shared their treats with her. The air was void the sounds of the piano keys being struck. Territory had learned that Primo Piano Studio began lessons in September of 2021 teaching beginning and intermediate students to play the Grand or upright piano inside the house. She had spent all summer getting everything all lined up and ready. Lesson consisted of weekly afternoon and evening lessons. Monday through Thursday from three in the afternoon until eight those evenings she was teaching eager, sometimes reluctant students the joys of music. Patiently, Sara explained that it merely meant to exemplify their capabilities as a pianist establish expectations, goals, method books and requirements. There are three semesters she upholds, Fall, Spring and Summer. Territory also learned that Sara most recently had been teaching lessons online and is happy to have been able to return to working one on one again with her students to help to shape them into competent musicians. She also talked about how rewarding it is to see the look of accomplishment on her student's faces when they master a musical piece after many hours of hard work.

Sara does online, or thirty minute and forty-five minute in person sessions. Her thought process evolved that for studying for an advanced repertoire and competitions with the benefit of digging deeper into the complicated techniques and studying of the more complex elements of music theory. Her lesson format basically involves the fact that there is a lot of variety in what a lesson appears as because each student is unique. Sara pointed out that every student progresses uniquely based on their natural abilities, the amount and quality of practice along with the individual intrinsic motivation. Sara's style is an emphasis on quality versus quantity and is mindful of incorporating technique, theory, and music history in every lesson. Territory learned that meant tempo, articulation, symbols, composers, theory, analysis, dynamics, etc. Her goal is that the student learns the building blocks of Music, not just one song. It had not ever occurred to Territory that there was so much more than just sitting down and running your fingers over those eighty-eight keys to create such melodies that were resonated throughout the airwaves.

Territory also learned from Sara that important skills are learned and developed studying music. That music education opens the path to life-long learning, if not helping to develop self-expression and creativity. She also told him that music has shown to improve recall and retention of vocalization, along with improving math skills. Territory could identify with her theory that music brought not just enjoyment but also relief from stress. "Working hard and achieving a goal can provide a great sense of accomplishment. Making music is also a great source of stress relief." Music can and does become an enormous coping strategy through very difficult times. Last, but not least, Sara pointed out to Territory that music is the building of the foundation to relationships.

"It's nearly impossible to make music with another human and not form a connection! Music is collaborative." Sara impressed upon him.

While playing piano is often considered as a solo activity, it is not. There are those listening to the creation of the sounds being infiltrated throughout the air to permeate the ears of those listening being it human or mammal. Then there are the cases when there is an accompaniment with other musicians, other instruments, concerts, events or social gatherings.
