# Mayor Courtney's Message

In Carver summer isn't over until after Steamboat Days so even though school is resuming, we've still got a few more days to enjoy the season. Here are my updates for September:

2024 Budget – Speaking of the changing seasons, with the exception of a few months at the beginning of the year, it's almost always Budget Season in Carver. Later this month City staff, City Council and I will be working to put the finishing touches on our Preliminary 2024 Budget and Tax Levy, which is required to be set by end of the month. This is also known as the "not to exceed" number which will be the basis for the property tax statements you'll receive in your mailbox later this fall. Thefts from Vehicles - The Carver County Sheriff's Department has reported, and more than a handful of our neighbors unfortunately have experienced, trespassing issues and thefts from unlocked vehicles in the last month. The good news is this easily prevented. The Sheriff's Department recommends removing or hiding all valuables from your vehicle,

locking the doors on your vehicles, home and garage, and turning on your exterior lights. If you see any suspicious activity, please don't hesitate to call 9-1-1.

Joy McKnight - Last month Joy McKnight resigned from her role as a Council Member due to time constraints. Cannabis Ordinance - In July Carver adopted an ordinance making the use of cannabis flower, cannabis products, lower potency edibles and/or hemp derived consumer products in a public place like parks and sidewalks in the City of Carver a petty misdemeanor. This is similar to the restrictions on "open containers" of alcohol. The City of Carver also adopted an interim ordinance prohibiting the operation of cannabis businesses in Carver through Jan. 1, 2025 which will allow the City time to study local regulation of these businesses in Carver.

Council was introduced at a work session to the concept of a Ten Year Staffing Plan by the City Manager for the purpose of familiarizing the council with financial impacts and plan elements of said topic.

# Zoning Ordinance Updates

The Community Development Director updated the council at the work session on the ongoing Zoning Ordinance update progress of the Planning Commission board. Items carried over from the Work Session: 4. Zoning Ordinance Update Erin Smith, Community Development Director Community Development Director Smith provided an update on the zoning ordinance update discussion that began during this evening's Work Session. The Planning Commission has done some work on revisions to the zoning code regarding lot standards and zone regulations, straight zoning versus use of Planned Residential Developments (PRDs), and accessory dwelling units.

# Hawthorne Ridge Trail

The council discussed the item regarding Sixth Street West to the Hawthorn Ridge Trail Connection with the Community Development Director who provided details on the rustic trail system throughout the development.

The topic of the Zoning Ordinance updates was discussed further at the council regular meeting. The Planning Commission has been reviewing revisions relating to lot standards, zone regulations, straight zoning versus the Planned Residential developments and accessory dwelling units. Direction from the council was requested.

# Creekside Park

The Community Development Director updated the council on the DNR Outdoor Recreation Grant for the Creekside Park. The city was awarded grant funds from the DNR's Outdoor Recreation Grant Program. The council plans to begin developing preliminary construction plans to include dog park areas, pickleball courts, trails, paring lot and other park amenities. Tentative construction dates would be 2024 or 2025. The future Creekside park is located at the former wastewater treatment plant site at the intersection of Jonathan Carver Parkway and Main Street West.

# Cannabis

The City Attorney discussed with the council the Interim Ordinance regarding Cannabis Business. After holding required Public Hearing the actions recommended following are a motion adopting an interim ordinance authorizing a study and imposing moratorium on the operation of business of cannabis within the City of Carver, and the publication of interim ordinance. Past information was discussed again to refresh past talks regarding authorization of eventual establishment of cannabis businesses in the state. Statutes within the act allows local government units studies to be conducted for the purpose of considering adoption oar amendments of reasonable restrictions to adopt an interim ordinance applicable to its jurisdiction for the purpose of protecting the planning process and the health, safety and welfare of all of its constituents. Recommendation submitted was for the city to adopt an interim ordinance prohibiting the operation of cannabis businesses within the city until January 1st, 2025.

The provision allows the city to review anticipated model regulations which the Act contemplates will be prepared by the State Office of Cannabis Management. The City Attorney drafted a corresponding resolution authorizing summary publication. Prior to adoption of the interim ordinance a Public Hearing is required to be held.

The City Council adopted an interim ordinance prohibiting the operation of cannabis businesses in the city. The interim ordinance remains in place until January of 2025. During which time the city will pursue studying local regulation, licensing and zoning of said businesses.

The council continued discussions on the interim ordinance providing the government units a planning tool and time to prepare to manage the cannabis issue going forward. Councilmember inquired about what the city was waiting for if the Office of Cannabis Management had been put into place. The City Attorney clarified that this organization exists on paper only thus far and has to established yet including the rules and regulations. The City Attorney clarified that no one can sell stronger cannabis product until a license is secured from the State of Minnesota which likely will not happen until 2025. An interim ordinance allows preparation time. Motion was made and carried with four ayes and one nay adopting an interim ordinance authorizing study and imposing a moratorium on the operation of cannabis business within the city. Motion was made and carried with all ayes adopting the resolution authorizing publication of the interim ordinance.

# Miscellaneous

A resident attended the council meeting requesting additional speed limit signs along Mt Hope Road specifically addressing traffic turning off of Chaska Boulevard. The council and the sheriff's department is aware of the situation with patrolling increased in the area. The addition of speed limit signs would be researched by the staff.

The City Manager gave an update on items being followed up with to include the 2024 Well House Rehabilitation (Wells 1 and 3); 2023 Plans and Specifications; former County Road #40 Task Force; Grant Funding Opportunities; Collective Bargaining Agreement; Negotiations; Park and Pedestrian Underpass Security; Kirche Hill Drive; Community Park Parking; sign requests; 2024 Employee Pay Scale Adjustment; "Open Range"; Pay System;

Local Emergency Operations Plan; City Offices/Operations Closed; and Utility Billing Clerk's Retirement.

Mayor Courtney Johnson was appointed to the League of Minnesota Cities Board for a three year term. Congratulations were extended to the mayor.

The Deputy Clerk discussed the motion approving a Temporary On-Sale Liquor license for the Carver Lions pertaining to their 50<sup>th</sup> Anniversary Celebration planned for October 18<sup>th</sup>. The event will be held in the Village Hall at the Carver City Hall. As per required, upon approval license is required to be approved by the Alcohol and Gambling

**Enforcement Division.** 

The City Manager discussed the topic relating to Digital Sped Sign Installation Criteria Concept. The council supported this proposed concept. The item would be managed through the budgeting and construction process rather than by an official city policy.

# Recreational Cannabis Ordinance

Question was asked of the council for their opinions regarding the creation of an ordinance regulating smoking marijuana on the streets. The City Attorney stated that an ordinance provision makes it a petty misdemeanor which is a code violation resulting in a fine. The item was discussed and will be pursued in the future.

The city adopted an ordinance which makes the use of the cannabis flower, products, lower-potency edibles or hemp-derived consumer production in a "public place" a petty misdemeanor.

The City Attorney discussed the City Code Amendment regarding Cannabis/Hemp Use in public. An ordinance amending city code to prohibit the use of cannabis and hemp products in public places is required. Authorizing publication of the said ordinance would also be required. The recently adopted statewide legislation legalizing recreational cannabis authorizes cities to adopt an ordinance deeming it a petty misdemeanor to use cannabis or help derived consumer products in public. It is legal to possess and use these products and without such an ordinance they could also be used in public places if not separately prohibited by another existing law similar to the Clean Indoor Air Act. The item had been addressed and preparations for defining public place was thought about in advance. The different levels of fines were discussed. Amounts of fines discussed reflected the same fines allocated for liquor violations. If the council expressed interest in alternative fine amounts, it was feasible. Fines are subject to state-mandated court fees and surcharges. The proposed ordinance was reviewed by the sheriff's office and the county attorney's office.

Clarification regarding establishments possessing on-sale licenses legally selling THC beverages can do so legally and contents can be consumed on site only exempt from public ordinance. Consumer cannot walk down to park to consume just as you can't have open alcohol container off site. Question was asked if the ordinance was clear enough to separate allowing the sale and consumption on establishments to not allow consumption in public. The attorney indicated it was as far as the city could go with regard to a public place and the ordinance provides clarification for law enforcement. Motion was made and carried with roll call vote of all ayes adopting an ordinance amending city code to prohibit the use of cannabis or hemp products in public places. Motion was made and carried with roll call vote of all ayes adopting the resolution authorizing publication of the ordinance.

# Outdoor Sidewalk Café Ordinance

The council discussed and reviewed information at a work session meeting regarding the changes to the Outdoor Sidewalk Café Ordinance being reviewed. The required Public Hearing is scheduled for the Planning Commission Board to hold. After the Public Hearing the council will consider final adoption of the ordinance.

The purpose of the Sidewalk Café is to allow eligible businesses the opportunity to expand utilizing the city's public right of way. Due to the requirements being subject to interpretation and updated ordinance was recommended.

Those changes include updating the definition; adding a purpose for allowing the outdoor sidewalk cafe and identify license requirement where allowed; clarifying required information; reviewal process and conditions for approval; identifying the criteria and performance requirements in the approval process; and detailing the inspection and enforcement criteria. In addition to these updates to the ordinance, that the regulations be put under the Zoning section. The next step in the updating process is to schedule a Public Hearing by the Planning Commission for the purpose of public input and Planning Commission recommendations. Following the Public Hearing the council will then consider final adoption

The City Clerk reviewed the topic regarding the adoption of the Sidewalk Café Ordinance amending chapters with the council along with adoption of the authorization for summary publication. An overview of past discussions occurred.

The current ordinance is listed in the zoning code and should be in the business section along with some requirements was the reason for the proposed changes and updates. The proposed changes were reviewed by the council and upon further feedback, not to allow "vaping" was also added to the amended proposal. The City Attorney however recommended the word, "smoking" clarifying the use of electronic delivery devices. The Planning Commission held the required Public hearing for the zoning changes and recommended approval.

# Certified Levee Project

The Project Engineer and Assistant City Engineer presented an update on the Certified Levee Improvement Project.

This presentation included updates relating the background and status, funding, delivery schedule and the work plan, communications plan and the next steps to pursue.

The council adopted a resolution participating in funding from the MN Flood Hazard Mitigation Program.

The City Engineer discussed the DNR Flood Hazard Mitigation Program Grant Funding. A resolution required approval for funding assistance. The application had been filed in connection with the concept plan to certify the city's flood levee. The funds will be utilized to conduct survey work, soil borings and additional engineering work required to move forward. Receipt of all funds allows for the project to move forward with design and phased construction project. Construction phasing is dependent upon possible receipt of additional funding also applied for the Fiscal Year of 2024. Receipt of additional funding is dependent upon adoption of the resolution for the amendment of the DNR grant agreement to incorporate additional funding. Resolution requires identifying a source of funds ability to be used to satisfy the city's total local match requirement based on the 2020 census. Based on discussion with the state, the city's match requirement will met for the levee system.

Motion was made and carried with roll call vote of all ayes adopting a local government resolution for flood hazard mitigation grant funding assistance.

# Equipment Purchase

The Public Services Director discussed the purchase of a Bobcat for the department and the city. This equipment would be utilized year round. Allocated funds were budgeted from the General Fund Capital Improvement Plan for the requested purchase. The funds allocated were discussed along with the purchase of a Kubota with excess funds carried over from the previous year and is currently unavailable due to supply chain limitations. This reallocation of funds would be planned for the 2024 budget.

# Hometown Bank

The Community Development Director discussed with the council the resolution relating to approval of the Preliminary and Final Plat for the Hometown Bank. Approval and authorization execution of the Developer's Agreement for the Carver Commons Third Addition was also requiring approval. The Concept Plan had been reviewed by the council formerly. The bank layout is consistent with their other facilities but slightly smaller. The site includes outdoor patio space for coffee users and trail access from Monroe Drive. Adjacent streets will be privately owned and maintained. A Public Hearing was held by the Planning Commission. The Planning Commission recommended approval of the project.

Applicants for the Hometown Bank proposal attended the Planning Commission meeting to answer questions. The Planning Commission held a Public Hearing. There were not any public comments received. Planning Commission members had numerous questions and comments. The anticipated opening date was for next spring. Motion was made and carried with all ayes recommending approval of Preliminary Plat and Final Plat for Hometown Bank.

The Community Development Director discussed land use approvals regarding the Hometown Bank project. Traffic items were discussed further. Trail easements were talked about. Concern was expressed regarding the topography of the trail. The Community Development Director indicated that when the land north of the site is begun to be developed, it will allow another trail connection to help. Motion was made and carried with all ayes with roll call vote adopting the resolution approving the Preliminary and Final plat for Hometown Bank. Motion was made and carried with all ayes with roll call vote approving and authorizing the execution of the Developer's Agreement for the Carver Commons Third Addition subject changes.

# Employee Pay Scale

The Finance Director discussed with the council the Employee Pay Scale requiring action from the council to a percentage adjustment to the Employee Pay Scale. As part of the collective bargaining agreement the city annually reviews the pay scale. Adjustments are required based on the results of calculation using the consumer price index.

The City uses an "Open Range Pay Scale System" determining and managing employee pay. The open range system allows the City to determine pay based on market conditions, budget, and the local economy as indicators for the City to determine and negotiate employee pay. The pay scale establishes a pay range for each pay grade. Pay grades are determined for each position based on the responsibilities, experience, and education required for the position. Motion was made and carried with roll call vote of all ayes approving the percentage adjustment to the Employee Pay Scale effective January 1st, 2024.

# Yoning Ordinance

The Community Development Director presented information on the drafted ordinance adoption pertaining to the topic of chickens. The acceptable location standards were being required. After adoption of the ordinance known coops would be required to register and meet the requirements collectively adopted by the Planning Commission and council. Code requirements and ordinances in other cities was discussed. Since it is an updated ordinance a Public Hearing would be required. Fencing stipulations could be added. A coop would be considered an accessory structure. Question was asked if enough room was available on small lot. Presently, two accessory structures are allowed if setbacks are met. Smaller lots night not meet those setbacks. There was also discussions regarding Home Owner's Associations adopting their own rules. A new zoning code could specify minimum lot size to house chickens limited smaller lots from having close to residential properties. Registration fees, selling restrictions and setting guidelines should be established were all discussed.

# Speeding

Several residents attended the council meeting regarding speeding occurring in their development. Option inquired about included flashing speed sign, speed bumps, more stop signs, speed limit change. The neighborhood is suspected to be utilized as a detour, plus expressed concern of speeding with the number of children in the neighborhood. The council was aware of the issue, received several complaints and have discussed the issue with the sheriff's department. Patrolling and enforcement of speed will be continued to be pursued. The City Engineer is working on the placement of a radar tracker to measure the speed and volumes of traffic. When data is available, it will be reviewed. In the meantime, the residents asked to contact the sheriff's office.

# Steamboat Days

The council discussed the closure of specific streets during the annual heritage celebration event held in downtown Carver. The City of Carver has celebrated its heritage for over fifty years with the Steamboat Days Festival which is a great community get together. The celebration includes food vendors, water fights, live music, sidewalk vendors, fireworks, a parade and more. The city authorized the closing of Broadway from 4th Street to the levee, Third Street from Jorgenson to Oak Streets on Friday and Saturday, September 8th and 9th. Sunday, September 20th for the parade route the closure of Broadway from 6th Street to 4th Street.

The council reviewed the motion approving aa Temporary On-Sale Liquor License for the Carver Lions during Steamboat Days. Their tent will be located in downtown at Third Street West. Motion was also reviewed for a temporary On-Sale Liquor License for the softball tournament at the Community Park on Sixth Street for the Carver Lions was also reviewed. Upon council approval the licenses will need to be approved by the Alcohol and Gambling Enforcement Division at the MN Department of Public safety.

# Classifteation and Compensation Study

The City Manager presented the Strategic Plan to the council at a work session. The City Manager discussed with the council the Classification and Compensation Study requiring approving on a proposal from Abdo to conduct a study. This study includes examination of responsibilities, associated pay and work performed by positions within an organization. The exercise creates opportunities for expectation alignment, career path progression, and tests and analyzes the pay structure for positions. A study was done in 2013 and a small update in 2019. An initiative to conduct a new classification and compensation study was identified in the most recent Strategic Plan. Additionally, a study necessary was also identified as an Action Plan follow-up to an employee satisfaction survey conducted in 2022. Abdo was selected to assist with a new study including introduction and project orientation; comprehensive job description review; position classification evaluation; labor market employers criteria and selection; market benefit and compensation analysis; classification and compensation system and compliance testing; final documents and system presentation; and implementation and system and administration training/support. The proposal all employees in every department. This timing puts the council in a position to review study results in advance of the 2025 budget process.

The City Manager reviewed the topic of the 'Peer City Cohort' review with an overview. This topic will be part of the upcoming Classification and Compensation Study.

# 2024 Utility Improvement Projects

The City Engineer discussed with the council authorization for preparation of plans and specifications pertaining to the 2024 Utility Improvement projects. A complex water distribution system is operated and owed by the city providing reliable water supply to residents and businesses in the city. As the city continues to grow and system components age, it is critical to properly maintain the system minimizing the risk of failure which could impact system reliability. These facts have been recognized and the city has identified several improvement projects in its long-term financial plan. Several improvements to the water system are planned programs for the upcoming year. The summary of the scope of these projects were discussed at their meeting. The next step is to final plans and specifications. The proposed outline of the schedule was also reviewed. This project is programmed in the 2024 Capital Improvement Plan. Motion was made and carried with all ayes authorizing the preparation of Plans and Specifications for the 2024 **Utility Improvements Project.** 

The council authorized the City Engineer to prepare plans for the 2024 Utilities Project. The plans primarily involve several electric and technology control upgrades to the water collection and distribution system for the city.

# 2024 General Fund Budget

The City Manager discussed the General Fund Budget with the council. The council reviewed the first draft of the 2024 General Fund Budget. A drafted budget and tax impact analysis will be done and reviewed in the future. The annual budget along with corresponding property tax levy accounts are one of the most significant policy decisions by the council. Due to the growth the necessity for successful management of this growth, service levels and effectively plan and be responsible as stewards of public tax dollars it is imperative to be successful. Identifying, planning, and prioritizing needs with respect to the overall property tax impact is the central focus of every budget process by the city. Although the budget identifies the needs and priorities, the property tax levy indicates how much of the need will be funded through property tax revenue. The overall property tax levy is separated into three categories: General Levy, Debt Service Levy, and the Street Maintenance Levy. The City Manager reviewed the percentage increase for total levy increase also indicted in the proposed 2024 Budget. The tax impact analysis will be provided once it is updated with the taxable market value information. The total levy cannot independently predict tax impact, especially in a rapidly growing community. The calculation of taxable market value and total tax levy, along with fiscal disparity data, will ultimately provide the City Council with the best line of sight to the budget's tax impact. Similar to 2023, the City is anticipating significant growth in taxable market value, as new construction values increased for residential along with the commercial/industrial facets. Overall market values for existing properties are more stable. The market value increase does continue to drive up the average value home. The key budget initiatives were discussed in length.

# Ten-year Vehicle and Equipment Plan

The council reviewed the presentation relating to the ten-year vehicle and equipment plan drafted for their review. The Process involves completing and identifying vehicle and equipment needs; consultation and coordination to develop plan; and present draft plan to refine and adjust. The following step would be to present financial impacts to the equipment plan, as well as all plan elements with council review and direction on the draft plan components. Finally, the council reviews, considers and adopts the final ten-year Vehicle and Equipment Plan.

The council also reviewed the presentation regarding a ten-year building and facility maintenance drafted plan with many of the same steps as was followed with the vehicle and equipment drafted plan.

# Bluff Ordinance Review

The Community Development Director provided an overview to the council for the purpose of discussing the opportunity to remove verbiage for the intent and function ability of the current Bluff Ordinance.

# Compensation

The City Manager discussed with the council the topic of compensation. An adoption of an ordinance amending the city code regarding council salaries was on the table for discussion, along the resolution authorizing publication.

Compensation for the offices of the mayor and city councilors was discussed. This compensation is set by ordinances and changes to the code only become effective after the next year's general election which this year would be November. The pay levels in peer cities was considered in several future compensation scenarios. The last amended pay schedule occurred in 2017. Pay increase amounts were reviewed, along with the salary amounts in other cities.

### Ironwood Park

The Public Services Director discussed with the council the installation of an irrigation system in Ironwood park. Approval of a proposal for this system to be installed was discussed at the request of the Public Services Department.

Currently, water needs to be transported resulting in staff time and inconsistent irrigation schedule. Originally, irrigation was planned but was removed as a cost saving measure. Installation of system with fund availability will establish a healthy turf growth.

# Council Member Resignation

The City Attorney addressed the issue regarding council vacancy. The steps outlined to be taken to address the resignation of Council member, Joy McKnight's resignation is straightforward with procedures. The council needs to adopt resolution accepting the resignation and declaring the vacancy. The vacancy is not scheduled to expire until the end of 2024. The statute provides that the vacancy "shall be filled by council appointment until an election is held." There is no special election required. An appointed individual can serve until qualification of a successor elected during the 2024 regular election. The next step the council should discuss is the process to follow appointing an individual to fill the vacancy. The only qualification required is that the appointee must be qualified to be elected. Another consideration is that if the council has a candidate in mind, the appoint could be made at any time. However, the council does have the option to seek individuals interested in filling the vacancy. The council formally declared the vacancy. Advertising for the vacancy and collection of applications will be the next step pursued.

# Carver Business Alliance

The Carver Business Alliance is a collaboration of business owners, community leaders, and local officials working together to promote, enhance, and create opportunities for commerce in the City of Carver. Business roundtable discussions are held, and City of Carver updates are provided at each meeting." They usually meet every third Friday at city hall. May's meeting is scheduled for Friday, September 15<sup>th</sup>.

# Sidewalk Signs

Have you seen the sidewalk signs to raise awareness about the Carver's levee project? There is/was an article in the Southwest news Media by Chuck Rupnow. Near the sidewalk of Gazebo Park in



downtown Carver the City of Carver placed a decal-like sign about the city's levee project. You can scan a QR code to take you to the website for more information. The project is an effort to make necessary improvements to the levee that protects downtown properties from the MN River floodwaters. This new signage is an effort and one of the methods that the city officials are utilizing to keep the community informed of the project's status. The City Mayor's statement, "This is going to be a pretty significant construction plan for our downtown area and the signs with the QR code is a way of letting folks know about it — giving them the resources so they can be educated and learn more about it if they are so intent." The website includes documents, history and other information relating to the ongoing project.

### -Carver Fire Department

# Fire Station History

"The fire station, completed in 2005, is located at 801 Jonathan Carver Parkway. The original station was located at 108 Fourth Street East, Old Carver Fire Hall. Built about 1880, it served as the Carver Fire Hall and was used to store fire fighting vehicles and equipment. In the 1880's the Carver Fire Department had regular monthly meetings.

By 1894 the volunteer Carver Fire Department had one horse-drawn hook and ladder wagon and one hose cart. Now the department serves its community with: Three Engines, One Rescue Truck, One Tanker, One Brush Utility, One Command Vehicle, and One Boat."




